### **ACTION REQUESTED:**

Approval by the Board of Education of Resolution No.1213-0044 - Approval of Increased Project Budget Expenditure and Amendment of Lease Back Agreements Pertaining to the Lowell Modernization Project ("Project") #06004 in the amount of \$750,000.00 increasing the Guaranteed Project Cost (GPC), for reasons stated herein, from \$14,297,443.00 to \$15,047,443.00.

### **BACKGROUND:**

The final budget for the Lowell Modernization Project, file I.D. # 12-0632, was approved by the Board of Education on March 14, 2012 in the amount of \$19,188,360.00. The Guaranteed Project Cost ("GPC") for the Project submitted by the Developer, Arntz-Focon, JV, ("Developer") was \$14, 297,443.00. The funds left remaining in the final approved budget for the Project, after allocation of the GPC equal \$4,890.917.00.

Staff is requesting that the Board of Education approve a transfer of funds from the existing budget for the Project to increase the GPC due to unforeseen conditions and design error, outside the Developer's control.

The redistribution of the Project budget will result in the following GPC, contingency and allowance changes:

Under Article 2.1.5 of Exhibit C, District Allowance is for the exclusive use of the District for additional owner generated Project costs including, but not limited to, owner requested changes in scope is listed as \$480,000.00. The transfer will increase the District Allowance to \$1,230,000.00.

Under Article 2.1 of Exhibit C, the GPC is listed as \$14,297,443,000.00 and following the transfer, will increase to \$15,047,443.00.

The total redistribution of existing Project budget funds is \$750,000.00.

**WHEREAS**, the Board of Education approved Resolution No. 1112-0178 (Enactment No. 12-0907) on March 14, 2012, designating \$19,188,360.00 as the approved project budget for the Lowell Modernization Project ("the Project"); and

**WHEREAS**, the Board approved (Resolution No.1011-1092) on April 27, 2011, the Lease Leaseback Method of Construction Delivery for and authorized the execution of Site Lease Agreement, Facilities Lease Agreement and Other Acts Relating to the Construction and Modernization of Lowell Middle School (the Project) with Arntz-Focon, JV ("Developer") for the Guaranteed Project Cost (GPC) of \$14,297,443.00; and

**WHEREAS**, Project unforeseen conditions and design error outside of the Developer's control have occurred resulting in an increase in costs by \$750,000.00.

**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby approves an \$750,000.00 increase in the GPC with Developer from \$ 14,297,443.00 to \$15,047,443.00, with said increase to be taken from (appropriated) said project budget approved March 14, 2012; and

**BE IT FURTHER RESOLVED** that the Board authorizes and approves Amendment of the Site Lease Agreement, Facilities Lease Agreement and Other Acts Relating to the Project to the extent necessary to effectuate the increase in the GPC with Developer.
