SUBJECT **Legislative Principles and 2019 State Legislative Priorities**

ACTION Adoption by the Board of Education of its Legislative Principles and 2019 State Legislative Priorities, in the areas of: School Finance; Human Resources; School Facilities; Charter Schools; Early Education; School Climate; and Accountability.

BACKGROUND The Board on November 26, 2018 held a Study Session on prospective legislative principles and potential District priority areas of state legislative focus in 2019, such as Career Technical Education, Facilities and Charter Schools.

DISCUSSION The attached State legislative platform has been updated to reflect the priorities the Board identified at its November 26, 2018 study session. The platform will serve as a tool for the Board and the District's legislative advocates, staff, and community to promote the District's interests.

School Finance OUSD supports fiscal policies that provide stable, adequate, and equitable funding that align to the costs of giving our students—regardless of their characteristics—what they need to be successful in school and in the community. State and federal fiscal resources should recognize and accommodate regional cost differences and unique costs of student groups who need additional instructional and non-instructional support to attain educational parity. We support increasing the LCFF base grants to ensure that California is among the top ten in the nation in per-student funding.

Human Resources OUSD supports policies that promote the recruitment and development of a talented workforce trained to meet the needs of California’s increasingly diverse student body. Such policies should include investments along the full professional continuum, beginning with high quality teacher preparation programs that provide in-the-classroom experience with master teachers, support for new teachers during the critically important first few years in the classroom, ongoing training and educator support to develop and refine skills in multi-cultural literacy as well as ethnic and language diversity, and tenure policies that promote continuous improvement in teaching practices. OUSD supports policies that alleviate the hardship of high workforce attrition as well as the traditional hard-to-place subject matters of science, mathematics, multi-lingual education, and Special Education.

School Facilities OUSD supports the continuation of a state facilities assistance program, supported by statewide school bonds, that ensures the state is meeting its obligation to provide equitable and fair access to a free public education and maintains the state-local partnership essential to building and renovating school facilities that meet the demands of 21st century learning. We believe in providing safe, healthy, and environmentally sustainable schools. We believe that the state must provide the funding necessary to retrofit existing schools for seismic safety and other environmental hazards, to address California’s oldest schools, to upgrade building systems to meet current requirements, and to ensure that schools can be renovated for effective instruction and learning.

Charter Schools OUSD supports student-focused charter school policies along the full policy continuum that promote a shared responsibility to educate all of Oakland’s youth. We believe that California must take a careful and comprehensive look at charter school policies relating to the broad spectrum of authorization and renewal, governance, accountability, facilities, funding, and student service practices in an effort to retain charter innovations that benefit students while setting expectations regarding transparency and accountability required of all public school agencies. Specifically, OUSD believes that state charter school law should be evaluated to:

- Authorize school districts to suspend, for a specified time, the approval of new charter schools or the renewal of existing charter schools that include enrollment growth when a district has been externally certified (County, State, FCMAT) that it is in fiscal distress.
- Extend the timeline for authorizers to review and act upon new charter school petitions and charter school renewal requests.

Our 2019 Priorities...

- Allow authorizers to renew charter schools for less than five years, and if appropriate, with conditions.
- Redefine the role of the county superintendent and the State Board of Education in the charter petition and renewal appeals process, to prohibit revisions to petitions during an appeal, and to limit appeals to technical errors, abuse of discretion or failure to follow charter authorization or renewal regulations.
- Prohibit the authorization of charter schools outside the boundaries of the authorizer, except in the cases of countywide and statewide benefit charter schools that serve specific student populations or provide unique educational programs that are otherwise not offered by a district in which the charter school will operate.
- Require charter school petitions to include student enrollment, dismissal, discipline, and transfer policies designed to reflect, within legal constraints, that ensure the charter school's student population is within the range of the student demographics of schools in the district in which it is located, including but not limited to the racial/ethnic, socio-economic, gender, and special needs composition of students.
- Require charter schools to share in the costs of the education of Oakland students with IEPs with a range of options tailored to the city, which would include but not be limited to participation in the Special Education Local Plan Area (SELPA) in which it is geographically located.
- Require charter schools to comply with government transparency and conflict of interest requirements that are required of all public local educational agencies.
- Require charter schools to request a material revision for new or expanded facilities prior to the time the charter school requests permitting authority from the city or jurisdiction that must approve land use and zoning.

Early Education OUSD supports policies that aim to achieve a coherent, high quality pre-kindergarten system, with minimal application complexities and stable, meaningful funding. We know that high quality early learning opportunities benefit our community's neediest children. We are committed to addressing the socio-economic challenges of our families that can impair the success of their children.

Career Technical Education We support the continued investment in the Career Technical Education Incentive (CTE) Grant Program that augments our local parcel tax and supports our effort to expand CTE opportunities to all students. Our local initiative shows great promise to increase graduation rates, which is a top priority for our district. We are actively engaged in the startup of the new K-12 Strong Workforce Program to coordinate with other K-14 CTE providers in our region to meet the needs of our students and our community. We support predictable, multi-year grants that allow us to flexibly invest in promising, high-quality local pathways without unnecessary state bureaucracy and requirements that inhibit our ability to expand CTE to all students.





Our 2019 Priorities...

Educator Effectiveness OUSD continues to face the distinct challenge of attracting and retaining highly qualified educators who we know are the most critical element of student learning and achievement. Our community's high living costs make it difficult for promising young educators to afford teaching in the district; a high-cost community like Oakland warrants additional support to make the reward of teaching our students affordable. To this end, we support innovative policies to attract and retain talent in communities like Oakland. Such innovations that we would like to explore would include affordable housing options and ways to substantially reduce the district's \$34 million outstanding loan. Doing so would enable the district to pay educators a more competitive wage and give them the means to live in the city where they teach

School Climate OUSD believes that creating safe and supportive schools is essential to ensuring students' academic and social success. We have created health and wellness goals that support social, emotional and physical health and employ a restorative justice model that works to lower our rate of suspension and expulsion and to foster positive school climates. We support legislation and resources that allow the District to address both the physical and mental health needs of our students and allow the district to respond to student misconduct in a constructive, locally determined manner.

Accountability OUSD supports a multiple-measures accountability system that aligns with our continual improvement model catalyzed by the Local Control and Accountability Plan and School Performance Framework, which we believe will propel us towards our five-year performance targets through a guided focus reliant on a careful evaluation of school and student performance data.
