**Action Requested** Approval by the Board of Education of Resolution No. 2526-0218- Application for Variable Term Program Waiver – CBEST, BCLAD and Program - California Commission on Teacher Credentialing – Named Employee for School Year 2026-2027:

1. Yessenia Gonzalez Hernandez, K-5<sup>th</sup> grade Bilingual Spanish Teacher, International Community Elementary School;
2. Ximena De La Barrera Calderon, K-5<sup>th</sup> grade Bilingual Spanish Teacher, Greenleaf Elementary School; and
3. Brianda Romero, 9<sup>th</sup>-12<sup>th</sup> grade School Counselor, Oakland Tech High School.

**Background** Since July 1994, the Commission on Teacher Credentialing has had the authority to issue waiver documents that have expressly to do with educator preparation and credentialing and with the ability of employers to employ or assign people who are not appropriately credentialed for their assignment. All other waivers are under the legal authority of the State Board of Education or the Superintendent of Public Instruction.

A Waiver is issued or denied based upon the Commission’s established criteria and factors such as an employer’s continuing needs; the support the employer will provide to the applicant; or extenuating, extraordinary and unanticipated circumstances.

When an employment agency reviews its staffing needs and starts recruiting for various positions, all attempts must be made to fill a position with an appropriately credentialed employee. Employing agencies are required to first recruit a candidate who is qualified to participate in and

enrolls in an approved internship program in the region of the employing agency and secondly, a candidate who is scheduled to complete preliminary credential requirements within six months.

If a fully credentialed candidate is not available employing agencies must recruit candidates in this order:

- A candidate who is scheduled to complete his or her preliminary credential requirements within six months
- A candidate who is qualified to participate and to enroll in an internship program
- A candidate who qualifies to use a local assignment option
- A candidate who qualifies for the Provisional Internship Permit (PIP) or the Short-Term Staff Permit (STSP)

If the employer is unable to find an individual who qualifies for one of the staffing options listed above, the Variable Term Waiver may be requested for the most qualified candidate.

## **Discussion**

1. Yessenia Gonzalez Hernandez is requesting a Variable Term BCLAD Waiver. Yessenia graduated from University of California, Davis with a Bachelors in Anthropology. This waiver will allow candidate time to complete CSET Exams required for a Full Bilingual Authorization: Spanish.

2. Ximena De La Barrera Calderon is requesting a Variable Term BCLAD Waiver. Ximena graduated from Pontifical Catholic University of Valparaiso with a Bachelors and Masters in Fisheries Engineering. This waiver will allow candidate time to complete CSET Exams required for a Full Bilingual Authorization: Spanish.

3. Brianda Romero is requesting a Pupil Personnel Services (PPS) School Counselor. She graduated from San Jose State University with a bachelor's in health science. This waiver will allow candidate time to complete credential requirements while teaching in the classroom.
