Principal, Dr. Vennie Byle spoke on:

- Measure N: School-wide strategies Advancement Via Individual Determination (AVID) for all 9th grade students
- SPSA Goal: Reduce unexcused absences by 25%
- Suspension incidents by month Having instructional learning lab
- Measure N: Skyline climate and culture data outcomes
- Skyline's pathway grade 10 GPA data
- Measure N funded position Work Based Learning Liaison
- Vice Chair, Lacy Asbill asked, how does the school deal with equity in pathways? Ms. Gurholt answered by saying, by using the minority to recruit the other classmen
- Nancy Bloom, Executive Principal stated, one thing that was discovered with data testing the students are that many students that are out of class are so far below grade level that they can't function in a 10th grade science class because they don't know how to access the important curriculum
- Member Gary Yee, stated, every pathway should have the same student quality outcome or grade point average (GPA's) and are within a band across all four pathways, teacher quality distributed among all four pathways, so the outcome is equivalent and

equitable

- Executive Director, Preston Thomas stated, from the district point of view, looking at Skyline High School for facilities upgrade
- Chairperson David Kakishiba asked, is there a concentration suspension in a particular grade level? Dr. Byle said yes, mostly 9th and 10th grades.
- Conversation regarding Action Research and diving deeper in the data analysis
- What is the root causes of the success of having more students into pathways?, asked Gary Yee

After the presentation, Ms. Gurholt took the Commissioners and visited different classrooms according to different subjects.
