Adoption by the Board of Education, upon recommendation by the Measures N and H Commission of a 2025-2026 Education Improvement Plan/Budget modification for Fremont High School to reduce \$41,562.50 Teacher Salaries Stipends by \$4,452.72 to \$37,109.78, and establish a new strategic action to increase \$3,240.00 Conference expenses by \$4,452.72 to \$7,692.72, as stated in the justification section of the New or Revised Strategic Action Section of the Budget Modification Form.

Whole School Tab	118	\$41,562.50	Teacher Salaries Stipends: Extended Contracts for the Interdisciplinary Grade-Level Team Leads. Each teacher in these grade-level teacher teams must put in the planning team, team collaboration time, and individual work outside of contract hours to build an interdisciplinary project with aligned skills. The goal is that learning and skill mastery become intentional and aligned so students are more prepared every year. Teacher teams can also meet to discuss intervention strategies for the English Learner population and students with IEP to increase the pass rate in all their classes. This expenditure aligns with the whole school goal of collaboration and adult teaming. Budget Calculation: Interdisciplinary grade-level Team Leads: Up to 20 hours at \$47.50 hourly rate + 25% benefit costs = \$1,187.50 x 35 Teachers = \$41,562.50.	\$4,452.72

Whole School Tab	125	\$3,240.00	Conference Expenses: Conference expenses for 4 Pathway Teachers to attend the California Partnership Academy Linked Learning Alliance Conference 2025. A team of 2 Teachers from each pathway will attend and present about the pathway work at Fremont. The pathway team will then return to campus and share their learnings with the Pathways small learning community to make progress toward Gold Certification. This aligns with the goal of highlighting and sharing achievements in the media pathway. The whole school's goal is to work with OUSD and district initiatives. If teams and the whole school are aligned on the 4 pillars of Linked Learning and Gold certification standards, then that would	\$7,692.72

			bring quality learning experiences to all students at Fremont. This initiative also aligns with the goal of inclusion, which is to support more quality learning experiences for SpED and newcomers. Besides presenting, teachers will also attend sessions to learn from other CTE programs and bring their learning back to their teams through their Small Learning Community collaborations. Budget Calculation: Registrations at \$650 x 4 = \$2,600.00. Budget Modification: Request to increase the budget allocation to pay for 8 staff members to attend the Linked Learning conference. The original funds allotted for 4 teachers to attend did not cover the entire team that we want to send. This new amount covers the costs for 8 participants: 4 CTE teachers, 1 Administrator, 1 Pathway Coach, 1 Administrative Assistant, and 1 College and Career Readiness Specialist.

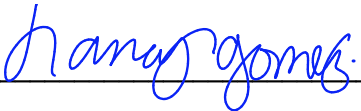
