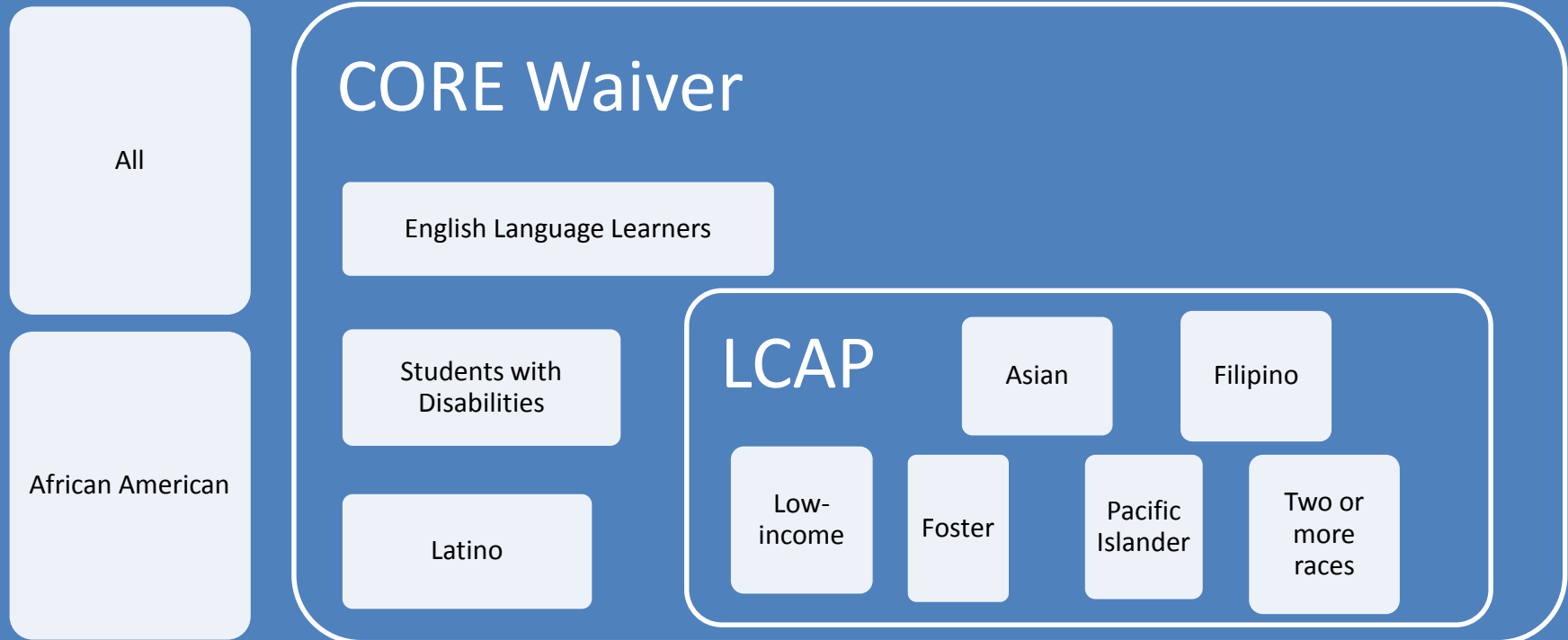
# Local Control Accountability Plan

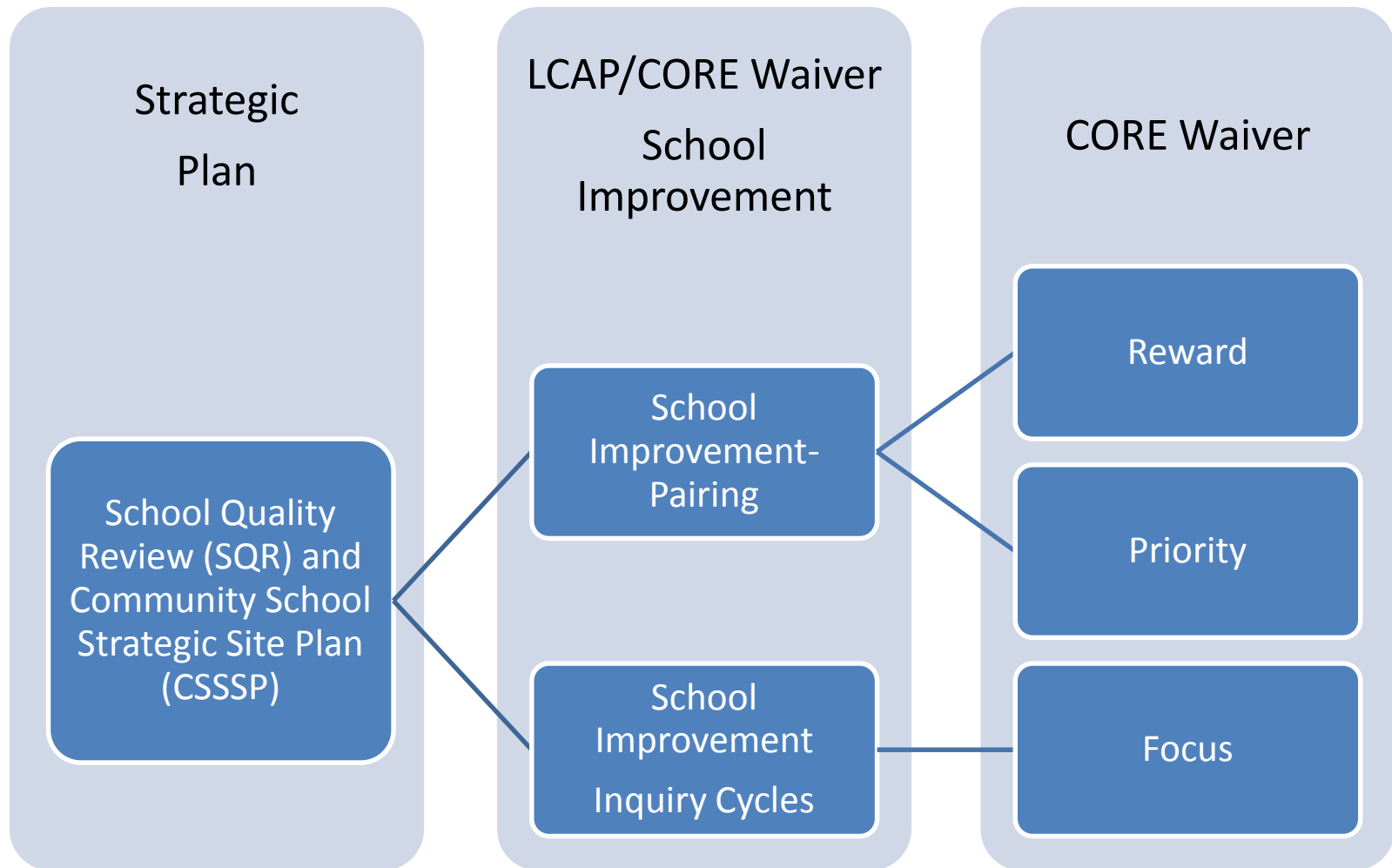
## Engagement

- Course Access – broad course of study (linked learning, electives)

# Purpose

---

1. Engage stakeholders (Spring 2014) in the *development* of the district and site level LCAP stakeholder engagement process.

3. Together, with parent, youth, and community leadership, inform the public about:
  1. Site and district level opportunities for input on the engagement process and the early development of the LCAP
  2. The transition to a Local Control Funding Formula (LCFF)



# Purpose

4. Build community awareness of how LCAP can improve OUSD's ability to prepare students for success in college, career, and life.
5. Gather input on how LCAP can be implemented in a way at site and district level, that best supports on-going stakeholder engagement for continuous improvement.

# Engagement Strategies

- **Existing Structures:** Leverage existing meetings, formal structures, conferences, and professional development spaces to inform and engage all stakeholders on LCAP.
- **English Learner Strategic Planning – Stakeholder Engagement:** Launch a review of district and site practices and engage with teachers, parents, students, grade level focus groups to learn more about EL student/parent experience, and gather input on how to best improve achievement for EL students.
- **Foster Youth, Families, and Agency Engagement:** Reach out to current agencies, youth and parent leaders, and convene planning meeting to design foster youth/family engagement process.

- **Spring Regional LCAP Conferences:** Provide weekend opportunity in each region to gather input and feedback on LCAP engagement, co-hosted by Board Directors.

# Communications Strategies

- **Websites:** Use the main OUSD website ([www.ousd.k12.ca.us](http://www.ousd.k12.ca.us)) and [thrivingstudents.org](http://thrivingstudents.org) to provide information and updates on LCAP/SQIS and to promote stakeholder engagement.
- **Grassroots:** Leverage existing school sites and community meetings and to promote LCAP/SQIS awareness and supplement with subject-specific meetings
- **Social Media:** Use social media to increase understanding and awareness of LCAP and to update the community on the development and implementation of LCAP/SQIS
- **Television Outlets:** Use KDOL TV and YouTube channels to promote understanding of LCAP/SQIS
- **Materials:** Develop and distribute informational handouts to increase understanding of LCAP/SQIS and to promote stakeholder engagement.
- **Electronic Communications:** Use electronic newsletters and emails to update the community on LCAP and promote stakeholder engagement.
- **Advertising:** Use online and radio advertising to publicize LCAP and related events

# Management and Tracking

---

- **LCAP Advisory:** Informs the design and implementation of the LCAP, and is composed of principals, district leaders, parents and community stakeholders.
- **District Stakeholder Engagement Steering Committee:** Oversees and manages the implementation of the LCAP/SQIS engagement plan, and is made up of district department leads and staff.
- **LCAP/SQIS Engagement Work Plan:** This plan will guide and track monthly progress on stakeholder communications and engagement strategies.
- **Feedback Collection & Integration System:** System will guide district staff to collect and synthesize stakeholder feedback, and use this data to make improvements to LCAP.
