- David Ernst's focus will be on teaching Music Entrepreneurship; now for 100% of our 10th grade students. David is our Music Teacher who will teach the Music Entrepreneurship course which will now serve as a pathway aligned course and build on students' understanding of entrepreneurship from 9th grade BUILD. In this course, students will have the chance to combine their passion for music with the opportunities of entrepreneurship. They will explore both how to make music and how to make it in the music industry. They will see how musicians often rely on entrepreneurial skills and mindsets in their careers.

TARGET STUDENT POPULATION:

- 89 10th graders

FREQUENCY OF SERVICES:

- Course held Daily
 - 3 sections of course are taught Mon-Thurs
 - 8:50-9:40, 9:43-10:35, and 1:03-1:55

ANTICIPATED OUTCOMES:

- At least 90% of the students pass Music Entrepreneurship and at least 30% of students continue exploring Entrepreneurship during their Junior year through Entrepreneurship 102.
