SEIU Local 1021 is submitting the following proposals for our Full Contract Renewal for July 1, 2009 to June 30, 2012:

- A) Article 50 The Collective Bargaining Agreement (CBA) between and for the Oakland School Employees Association, Service Employees International Union, Local 1021, (OSEA/SEIU, Local 1021), representing Permanent Paraprofessionals (IAs) and White Collar (WC) Employees and Oakland Unified School District for July 1, 2006 – June 30, 2009, shall be renewed for a three year period ending on June 30, 2012.
 - B. The Collective Bargaining Agreement (CBA) between and for the Oakland School Employees Association representing **"Substitute" Paraprofessionals (IAs) and White Collar (WC) Employees**, Service Employees International Union, Local 1021, and Oakland Unified School District for July 1, 2006 June 30, 2009, shall be renewed for a three year period ending on June 30, 2012.
 - C) Article 25 The Collective Bargaining Agreement (CBA) between and for the Oakland Child Development Paraprofessional Association/Service Employees International Union, Local 1021, (OCDPA/ SEIU Local 1021), **representing permanent employees** and Oakland Unified School District for July 1, 2006 June 30, 2009, shall be renewed for a three year period ending on June 30, 2012.

- D) Article 15 The Collective Bargaining Agreement (CBA) between and for the Oakland Child Development Paraprofessional Association representing "Substitute" Child Development Centers Instructional Assistants /Service Employees International Union, Local 1021, (OCDPA "Substitute"/ SEIU Local 1021) and Oakland Unified School District for July 1, 2006 June 30, 2009, shall be renewed for a three year period ending on June 30, 2012.
- 2. The salary schedule rates in effect as of July 1, 2008, as per Article 3 of the OSEA, Article 10 of the OCDPA, and Article 5 of the OCDPA "Substitute"shall remain unchanged as specified above in Article 50 of the OSEA, Article 25 of the OCDPA, and Article 15 of the OCDPA "Substitute".
- 3. There shall be salary re-opener for all bargaining units for the Fiscal Year 2010-2011 and Fiscal Year 2011-2012

The union is submitting these proposals and reserves the right to amend, withdraw, or add proposals.

Please contact my office to schedule an initial bargaining meeting once the proposals have been "sunshined" before the Board of Education.
