#### **Proposed Process and Timeline**

Goal:

To expand the number of high school students who complete an Employer-Evaluated Internship and strengthen the conditions for vulnerable students to graduate high school and enter postsecondary education, the Measure N & H Commission will develop a proposal to prepare, place, support, and evaluate 1,000 12<sup>th</sup> graders in internships that employ them for 240 hours.
