SUBJECT: Resolution Number 1213-0182 for Non-Public School and Non-Public Agency Contracts for the 2013-2014 School Year

ACTION REQUESTED

Approval of Resolution Number 1213-0182 to allow the District to enter into and execute revised, amended, or new master contracts for Non-Public Schools and Non-Public Agencies for Special Education Programs for Fiscal Year 2013-2014 and to enter into and execute revised, amended or New Individual Service Agreements for Special Education students for Fiscal Year 2013-2014 in an amount not to exceed \$14,600,000.00.

BACKGROUND/DISCUSSION

Federal Law and California Education Code require a Special Education Local Plan Area (SELPA) to provide a full continuum of program options, including Non-Public Schools (NPS). When a school district or SELPA does not have an appropriate public education program and or services for a student, a non-public school and/or the services of a non-public agency shall be made available. The District places students in a NPS for services such as: Day Treatment, Residential Treatment, Extreme Behaviors and Severely Disabled students. The District utilizes non-public agency services to supplement in-house staff services such as speech and language therapy.

This Resolution Number 1213-0182 is necessary to meet the educational needs of students needing specialized care as deemed through their Individual Education Plan.

FISCAL IMPACT

The total cost for the Master Agreements and Individual Service Agreements for services to Special Education students utilizing Non-Public Schools and Non-Public Agencies, funded by Programs for Exceptional Children for Fiscal Year 2013-2014, is projected to not exceed \$14,600,000.00.

RECOMMENDATION

Approval of Resolution Number 1213-0182 to allow the District to enter into and execute Master Contracts and Individual Service Agreements for 2013-2014 Fiscal Year, in an amount not to exceed \$14,600,000.00.
