Action Adoption by the Board of Education of Resolution 2324-0076, Re-Unifying MetWest High School On One Campus at 314 E. 10th Street Effective The 2024-2025 School Year.

Background MetWest High School’s Dolores Huerta (“Huerta”) campus, located at 314 E. 10th Street, is the original and permanent home to MetWest. In 2019 MetWest expanded to occupy a second site, the MetWest Ericka Huggins (“Huggins”) campus, co-located with Westlake Middle School at 2629 Harrison Street. Staff proposes the reunification of MetWest High School on one campus, known to the MetWest community as the Huerta campus, at 314 E. 10th Street effective the 2024-2025 school year.

Re-unifying MetWest High School on one campus at 314 E. 10th Street effective the 2024-2025 school year

WHEREAS, MetWest High School’s Dolores Huerta (“Huerta”) campus, located at 314 E. 10th Street, is the original and permanent home to MetWest;

WHEREAS, in 2019 MetWest expanded to occupy a second site, the MetWest Ericka Huggins (“Huggins”) campus, co-located with Westlake Middle School at 2629 Harrison St;

WHEREAS, the intent of the expansion was to grow the school from two cohorts per grade to four cohorts per grade;

WHEREAS, the projected 2024-25 enrollment can be accommodated at the original MetWest “Huerta” campus;

WHEREAS, operating MetWest across two campuses has created inefficiencies resulting in challenges with coherence, alignment, school culture and climate, and family engagement;

WHEREAS, the proposed reunification on one campus has been communicated through staff discussion, student engagement during their Advisory classes, and Parent Square notifications to families, and input was solicited from all groups;

WHEREAS, responses to a community survey indicated broad support for reunifying the school on one campus, with a majority of respondents indicating that reunification on the Huerta campus would help to improve school culture and climate, family engagement, access to teachers and administrators, and cross-grade student mentoring relationships;

NOW, THEREFORE, BE IT RESOLVED, the Board of Education hereby reunifies MetWest High School on one campus, known to the MetWest community as the Huerta campus, at 314 E. 10th Street effective the 2024-2025 school year.
