**Ask of the Board** **Adoption by the Board of Education of Resolution No. 2324-0170 - Career Technical Education (CTE) Advisory Committee - Naming Members (In Part) To Vacancies/Term Thereof**

**Background** The Board, by Legislative File No. 21-0736, Enactment No. 21-0568, on April 14, 2021, revised the Career Technical Education Advisory Committee (herein after "CTE") required for District's receipt of federal Carl D. Perkins Career and Technical Education Act funds. The Board staggered the initial membership term of members as either one- or two-years commencing April 16, 2021, and expiring April 15, at end of initial fixed term (one or two years). The Board also set the CTE membership, as recommended by staff, at twenty-one (21).

**Discussion** The Board by Legislative File No. 22-2285, Enactment No. 22-1701, adopted on September 28, 2022, upon the recommendation of the Superintendent, requested by the High School Linked Learning Office, extended and changed the commencement of a CTE Membership term to July 1.

Currently, there are 15 vacancies on the Committee: 10 due to term expiration on June 30, 2023 and 5 vacancies on the Committee by resignation for term ending June 30, 2024. Consequently, recommendation is made herein to fill 11 of the 15 existing vacancies as stated in the attached Resolution. Recruitment efforts to fill the remaining 4 vacancies are ongoing.

The CTE Advisory Committee, minimally, meet annually.

**WHEREAS**, the Governing Board of the Oakland Unified School District on April 14, 2021, adopted Resolution No. 2021-0211- Career Technical Education Advisory Committee [CTE] – Number of Members and Naming Said Members/Term Thereof [Legislative File 22-2285, Enactment No. 21-0568], as required of the District as an eligible recipient of federal funding under the Carl D. Perkins Career and Technical Education Act; and

**WHEREAS**, in initiating staggered terms for the 21 membership positions of the CTE, the Board assigned the initial fixed term of membership as either one or two years, effective April 16, 2021, and each expiring at the end of said fixed term (one or two years), as applicable to each appointee; and

**WHEREAS**, the Board, by Resolution No. 2223-0154 [Legislative File No. 22-2285, Enactment No. 22-1701], adopted September 28, 2022, extended existing CTE Membership terms expiring April 30<sup>th</sup> to June 30<sup>th</sup> and redefined the term of Membership as 2 years, commencing July 1,

**WHEREAS**, currently, there are 15 vacancies on the Committee of 21: 10 due to term expiration on June 30, 2023; and 5 vacancies by resignation on the Committee for term ending June 30, 2024,

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that the following person [10 total], upon recommendation of the Superintendent of Schools, via the High School Linked Learning staff, is retroactively appointed to an existing Vacancy on the CTE for a fixed term commencing July 1, 2023, and expiring June 30, 2025:
