ON-LINE SPEAKER CARD REGISTRATION

Public Comment, at the meeting, will be taken individually on Agenda Items indicated by .

You may register to speak in advance on the Agenda Item whether attending the meeting by teleconference, e.g., Zoom, or in person.

Recommendations may include, but are not limited to,
charter school authorization and renewal decisions, with
guidance and review from the Superintendent or her
designee, potential advice to Oakland’s state legislative
delegation regarding state policies regarding charter
schools, land use decisions involving charter schools, the
process for authorizing, renewing, or evaluating
OUSD-authorized charter schools, and material revisions to
existing charters. The committee shall also receive
presentations from the Office of Charter Schools related to
effective charter oversight and authorization.*
