Dear President Kakishiba and Superintendent Mayor:

California *Education Code* Section 1240 requires that the Williams team from the Alameda County Office of Education visits schools identified in your school district as 2006 Decile 1-3 schools, review information in the areas noted below, and report to you the results of the team's visits and reviews. I am pleased to provide, for submission to your governing board at a regularly scheduled meeting, the annual report for 2007-2008 as required by *Education Code* section 1240(c)(2)(G) pursuant to the *Williams Settlement*. This report presents the results of the team's visits and reviews at schools within Oakland Unified School District as of December 31, 2008.

The purpose of the ACOE William's Team visits as specified in *California Education Code 1240* was to:

1. Determine if students have "sufficient" standards-aligned instructional materials in four core subject areas (English language arts, mathematics, history/social science and science), including science laboratory equipment in grades 9-12, and, as appropriate, in foreign languages, and health;
2. Determine if there is any facility condition that "poses an emergency or urgent threat to the health or safety of pupils or staff;" and
3. Determine if the school has provided accurate data on the annual school accountability report card related to the sufficiency of instructional materials and the safety, cleanliness, and adequacy of school facilities, including "good repair."

The law further requires that the county superintendent:

1. Annually monitor and review teacher misassignments and teacher vacancies in schools ranked in deciles 1-3 (2006 Base API); and

2. Receive quarterly reports on complaints filed within the school district concerning insufficient instructional materials, teacher vacancies and misassignments, and emergency or urgent facilities issues under the Uniform Complaint Procedure.

While the Uniform Complaint data are not mandated to be a part of this report to you, they are being included so that you and the citizens of your community will have a complete understanding of the environment in which the schools identified as Decile 1-3 are functioning within the Oakland Unified School District.

Before proceeding with the report, let me define some basic terms as defined in California Education Code:

- “Sufficient textbooks or an instructional material” means each pupil, including English language learners, has a standards-aligned textbook, or instructional materials, or both, to use in class and to take home.
- A school facility condition that poses an “emergency or urgent threat” is a “condition that poses a threat to the health or safety of pupils or staff while at school.”
- “Good Repair” means the school facilities are clean, safe and functional as determined pursuant to the school facility inspection and evaluation instrument developed by the Office of Public School Construction or a local evaluation instrument that meets the same criteria. Each school district that receives state funding for facilities maintenance is required to establish a facilities inspection system to ensure that each of its schools is maintained in “good repair.”

In conclusion, let me assure you that our administration is available to support the actions that need to be taken to address the needs identified in the team’s report. The ACOE Williams’ Team findings can be found in the tables below this letter.
