Lead by Learning focuses on analyzing curriculum, activities, learning targets and figuring out best practices to present material to students. Teachers will go through "learning cycles", which focus on strategies, delivery, analysis and reflection of student progression. This is necessary as we continue to expand and build out our CS pathway with more classes and new(er) teachers at CCPA. This process is crucial to the development or the curriculum being used in the pathway, student outcomes, and preparation for students to head into a career in CS as technology is constantly changing. We have shifted from block based coding to more line coding, as well as shifted more to industry standard platforms.
