**SUBJECT:** Agreement with Mills College, School of Education for the On-Loan Services of Stanley Pesick

**ACTION REQUESTED**

Approval by the Board of Education of an agreement with Mills College, School of Education for the teacher on-loan services of Stanley Pesick for the period of October 1, 2011 through June 30, 2012.

**DISCUSSION**

Mr. Stanley Pesick will work fifty percent (50%) of his time as co-director and representative of Oakland Unified School District (OUSD), with Mills College, School of Education on the Teacher Quality California Postsecondary Education Commission (CPEC) grant awarded to Mills College, OUSD, and the Alameda County Office of Education (ACOE). Through this grant and in partnership with Mills College and ACOE, Mr. Pesick will provide professional development activities to assist OUSD's secondary English Language Arts (ELA) and history teachers learn to implement the Common Core State Standards by teaching conceptual understanding by incorporating an integrated model of literacy throughout reading, writing, speaking, and listening. Through this ELA/history collaboration project, teachers will develop and investigate a set of mutually supportive instructional practices designed to implement the Common Core State Standards.

Mr. Pesick will be responsible for the day-to-day implementation of the grant activities and other aspects necessary to achieve the goals of the project.

**FISCAL IMPACT**

Mills College, School of Education will reimburse the District for fifty percent (50%) of salary and driven benefits for Mr. Stanley Pesick.

**RECOMMENDATION**

Approval by the Board of Education of an agreement with Mills College, School of Education for the teacher on-loan services of Stanley Pesick for the period of October 1, 2011 through June 30, 2012.

**RELEASE AGREEMENT**

**between**

**MILLS COLLEGE**

**and**

**OAKLAND UNIFIED SCHOOL DISTRICT**

THE AGREEMENT is entered by and between MILLS COLLEGE and the OAKLAND UNIFIED SCHOOL DISTRICT ("District").

1. District hereby agrees to release Stanley Pesick to work for the School of Education, Mills College on a fifty percent basis for the period of October 1, 2011 – June 30, 2012. The work is described in the attachment #1.
2. Stanley Pesick will continue to have his full salary and benefits disbursed by the District, but Mills College will reimburse District fifty percent of such salary and benefits as paid to Stanley Pesick for services performed for Mills College on a fifty percent basis from October 1, 2011 through June 30, 2012.
3. District may submit numbered invoices to Mills College at the end of each quarter for Stanley Pesick's services during that period. Mills College shall make payment to District promptly upon receipt of each invoice. Invoices shall be mailed to the following address:


4. Any duties assigned and/or expected of Stanley Pesick beyond those which constitute his contract time with District shall be time outside of assigned District working hours and shall not constitute any cost to District.
5. This Agreement may be terminated by Mills College if, for any reason, Stanley Pesick should become unable to serve on Mills College's projects or if sufficient funds are not available to continue the projects on which Stanley Pesick is employed. In the event of such termination, Mills College shall reimburse the District for the share of Stanley Pesick's salary and benefits earned by him through the date of termination.

6. District represents that it has appropriate policies and procedures or agreements with Stanley Pesick sufficient to enable it to comply with all of the terms of this agreement.




