TRIAL ON-LINE SPEAKER CARD REGISTRATION

The Board of Education, in its desire to take more targeted Public Comment on Agenda Items, on a trial basis, within the current times allotted for Public Comment, is returning to it past practice of taking individual Public Comment on most items on the Agenda (except Consent). As a result, a separate Speaker Card (Sign In To Speak) is required to be filed by the commenter on each Agenda Item eligible for Public Comment.

On line Speaker Card Registration (Sign In To Speak) opens at minimum 72 hours in advance for a Regular Meeting or at minimum 24 hours in advance for a Special Meeting. Use the eComment Link to Sign In (Register) to Speak up to one hour before the beginning of the meeting. Manual (Paper) Speaker Cards also will be available at the meeting for completion.

Sign In to Speak, on an eligible Agenda Item, as a matter of equity, is first registered, first called, in order of Registration whether participation is in person or virtually, e.g. Zoom, or by audio, e.g., telephone.

For advanced pre-meeting Registration, You must establish a one time OUSD eComment - Sign In (Register) To Speak Account providing your First Name and Last Name and your email address. Your First Name and Last Name, as Registered, must also show as the Participant or Profile Name on a teleconference system (i.e., Zoom, webex, other). You will be requested to Register the first time you use eComment - Sign In To Speak.

The Sign In To Speak System, after the one time registration, will remember you by first name and last name associated with your email address (profile), making it easier for you to electronically Register or Sign In to Speak on an Agenda Item at a future OUSD legislative meeting, e.g., Board, committee, commission.

Early pre-meeting Sign In To Speak (Registration) is urged for all - whether you plan to attend meeting in person or view meeting via teleconference or listen to the meeting by telephone. Names will be called in Sign In To Speak order received.

On line Request to Speak (Registration) automatically closes one-hour before commence of the legislative meeting. (No way to manually reopen.)

Thereafter, a Request To Speak on an eligible Agenda Item is taken in person at the legislative meeting only via Manual Speaker Card. (If you registered pre-meeting on line to speak on an eligible Agenda Item, please do not re-register if you then attend the meeting in-person.) The Manual Speaker Card, for equity, will be placed in the que behind pre-meeting registered speakers If you registered to Speak on an eligible Agenda item, premeeting, if attending meeting in person, when your name is called, please walk to the Speaker's Podium and comment on the eligible Agenda item.

If you registered to Speak on an eligible Agenda Item, premeeting, if attending meeting on line, when your name is called, please raise your hand. Board of Education staff will match your pre-registration name with on line profile, unmute you to speak and remute you upon conclusion.

If you wish to speak by telephone only please pre-register and enter as your First Name (area code) and Last Name (last four digits of your telephone number.). If you pre-registered to Speak on an Agenda item, when your profile (area code and last four telephone digits) is called for comment on the Agenda item, please press "9". Board of Education staff will match your pre-registration name with on line profile, unmute you to speak and remute you upon conclusion.

Total Public Comment time on an eligible Agenda Item is established and announced by the Presiding Officer prior to first speaker on the eligible item for Public Comment.

General

- 2. Every Board Member will exhibit behavior that is honorable, honest, and dedicated to the success of the students and staff of the district.
- 3. Each Board Member is to be treated with dignity and respect.
- 4. Board Member Commitment will include:
- Participate fully in the discussion of issues
- Listen respectfully to all views and opinions
- Respect each individual's opinion
- Accept the majority action of the Board

Board Members

- 5. An individual Board Member will not use the media as a personal forum, unless it is clearly indicated that the opinion is personal and not representative of the Board majority position.
- 6. Each Board Member will make every effort to attend all Board meetings in person; and to start and end on time.
- 7. Board Members will ensure opportunities for each to comment.

Superintendent

- 8. Staff is the responsibility of the Superintendent who will bring recommendations to the Board for action.
- 9. Questions regarding Board agenda items are to be communicated to the Superintendent prior to the Board meeting and the Superintendent will respond in a timely manner.
- 10. The Superintendent is to communicate all significant administrative actions to the Board.
- 11. Legal and personnel matters will be confidential.

H. President's Address – 5 Minutes

President Benjamin "Sam" Davis' Address:

Thank you everybody. I was really moved to have so much support from my colleagues, honoring this responsibility. I was originally urge to run for Board President in 2022, and at the time, I told my colleagues at that time that I didn't feel ready because I have not been to that many in-person meetings of the Board as a Board Member. I have in the audience but not on this side of the Dias, and with the Pandemic ending I was a little bit flummoxed by the idea of trying to Chair a Board Meeting in-person. And at the time I talked to a former Board President, one of my mentors, and something he said stuck with me he said, "Usually if you want to be President you have a goal you want to do with that role." Now at my fourth year on the Board I do feel ready and I also do have a few goals that I want to achieve and I'm going to echo some of the things that have been said.

I think the most important goal, I said this before, I think for us as a District is to leave State Receivership and one of the main steps we can take as a Board to achieve that goal is to have a higher standard of how we approach this role. Both in terms of our individual responsibility, taking this role seriously, doing our research on the issue that confront us, bringing policy proposals to this body that focus on strengthening our District, and helping our students achieve their goals and their family's goals for them. And it also means a higher standard for how we work together, how we show respect to each other, to our Superintendent and her staff, and how we collaborate so that we can achieve things that advance not our own personal or political agendas, but to move the whole District forward and to always put our Students first.

And this is not directed to any one individual on this Board because I think each of us can grow in a way where we are elevating the collective standards of our Board governance, but each of us have our own growth areas. When I announced I was going to run for reelection this year, a lot of people said to me, "Are you okay? Are you sure you want to do that?" The Oakland School Board people would say to me it doesn't seem like a healthy environment to be in, and that's sad to me because it's an honor to sit on this side of the Dias. It's an honor to advocate for better outcomes for our Students and for a stronger and more stable District. There's a lot of prejudice against Oakland Unified out there in the world, and when you look at which Districts across the State were placed under Receivership, Districts like Richmond, Oakland, Vallejo, Inglewood, you can see clearly that it's a form of racism and classism that blames the victim for the social economic challenges that our students face because of the circumstances of which they were born.

When we look at Oakland Unified today we see a College and Career for All program initiative that is renowned across the State of California thanks to Measure N and Measure H. We see early literacy efforts that are getting a lot of recognition and celebration. We have a Superintendent who has been here for six and a half years. That is a tenure much longer than most urban Superintendents. She has chosen to stay here even though she can definitely write her ticket to anywhere she wants to go. And school after

school I go to I see amazing teachers, classified staff, excellent school leaders, there's so much to celebrate here in Oakland yet people don't have that same respect or regard for our Board. Wouldn't it be great if people said about our School Board, "Those Board Members have a high standard in how they treat each other, how they treat staff the seriousness of which they are engaging with the issue in the community, instead of, I know we all face that question with dread when people say, "Hey what is the latest controversy of the School Board?"

One way I, as Board President, can move us in that direction is by increasing our opportunities to collaborate with each other as well as to learn more from Senior Staff about the issues that confront us by having monthly study sessions on the whole variety of topics that we need to learn more about, our facilities, to our budget, to Charter Schools. I would also like to see us, to Director Brouhard's point, have more one to one conversations, something I think has been too rare in the past couple of years. A former Senior Staff Member said to me once that this Board talks to each other much less than any other Board he has known. One of the things I love about our new colleague, Director Lerma, is he's a talker, he likes to talk to folks, which is a great thing. I have a feeling he's going to be calling each of us more than we are used to and that's great, and I promise to reach out to each of you in the coming days as well.

I want to end with an appreciation. I am consistently impressed by how hardworking this Board is. I know how much time I put in to this role every week, and I can tell each of you puts in a lot of time as well. We have definitely earn the extra \$40.00 a month we are about to vote on. So thank you to each of you for all you do for our District and our Students and thank you to everybody here as well from staff and from the public who care so much about our children and our beloved town of Oakland, California.
