Charter School Renewal Overview

Timeline

Background

Every 5 years (typically), a Charter School must submit a renewal petition to their authorizer in order to continue operating. The authorizer, the OUSD Board of Education, must evaluate the renewal petition based on criteria outlined in California Education Code and the school's Renewal Tier placement. The Board must vote within 90 days of submission to approve or deny the petition.

COVID-19 Impact on Charter Renewal

Due to the lack of Dashboard data after COVID, the State legislature extended all charters' terms by a total of **three years**. Therefore, all OUSD-authorized charter schools that are up for renewal this fall are currently in **year 8** of their charter term.

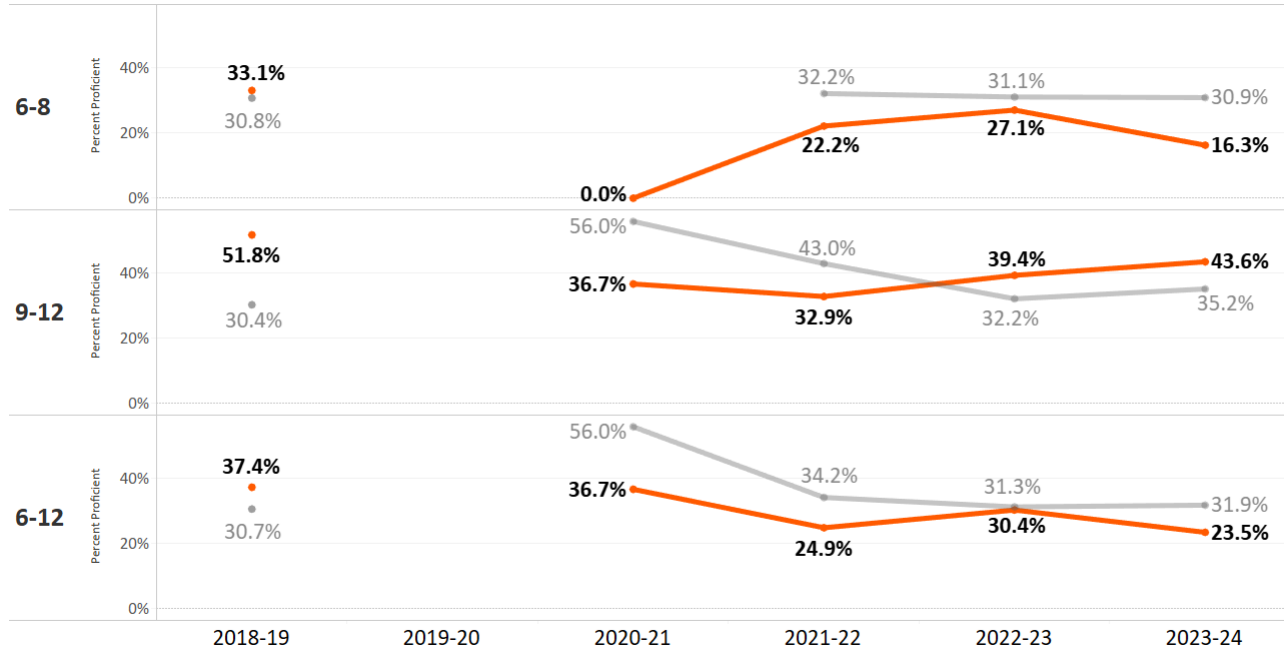

Academic Performance - English Language Arts

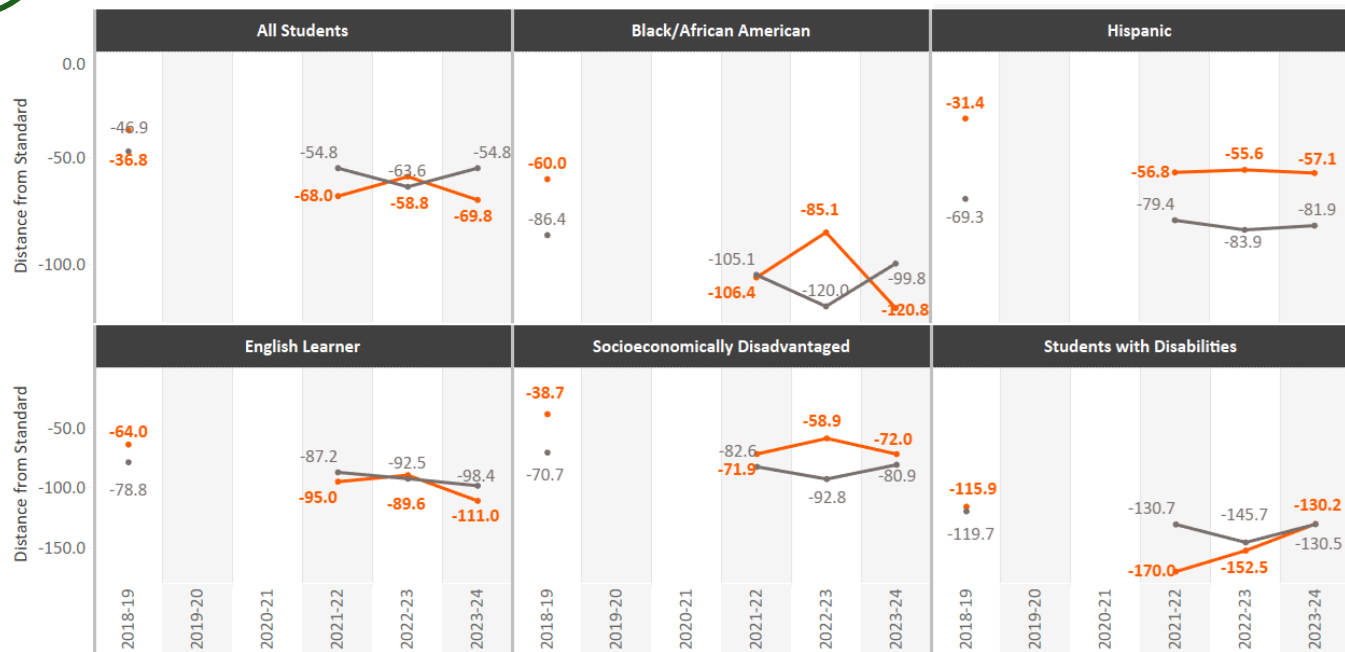


Average ELA proficiency has been consistently lower than the OUSD average at the middle school level, but has been higher at the high school level.

Academic Performance - English Language Arts

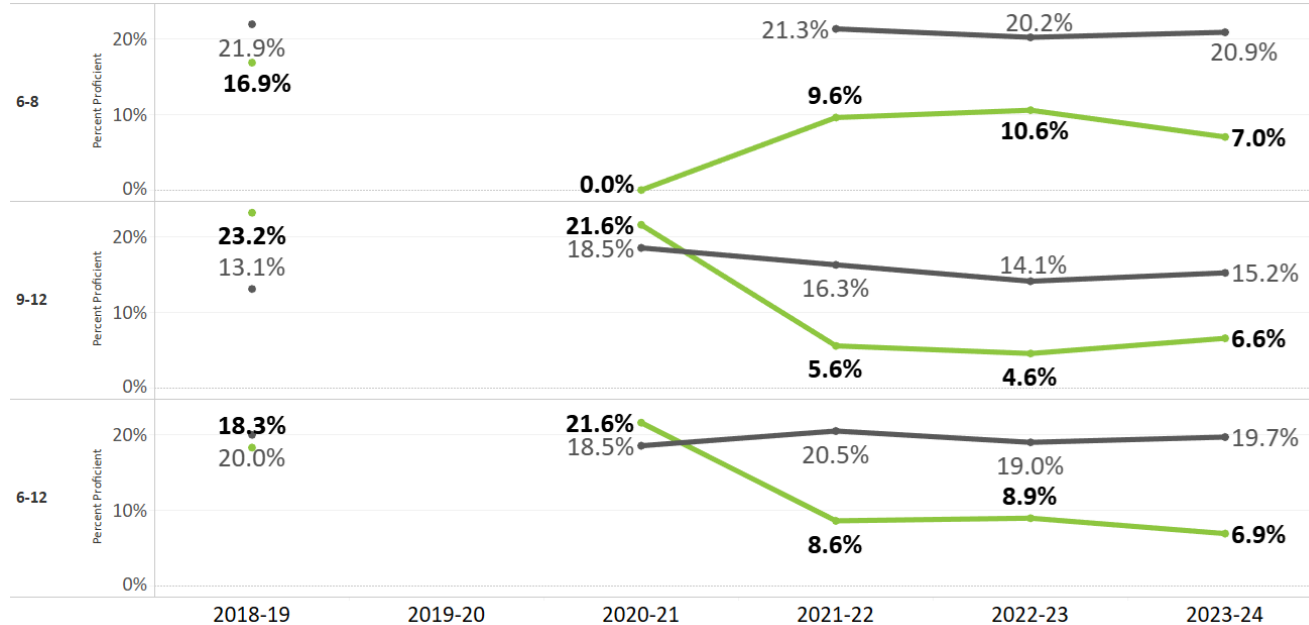


In 2023-24, average DFS for the Hispanic, Socioeconomically Disadvantaged, and Students with Disabilities student groups was above the District average.

Academic Performance - Math

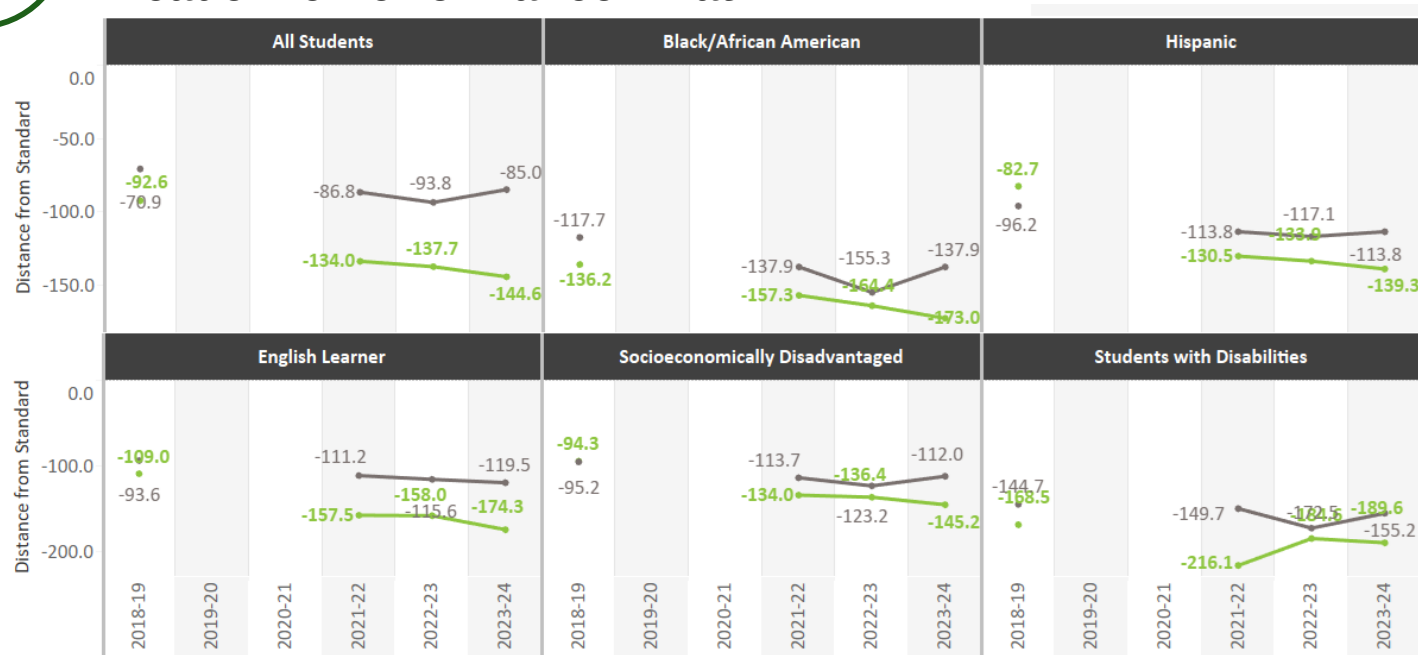


Post-pandemic, Math proficiency has remained below the District average in each grade span

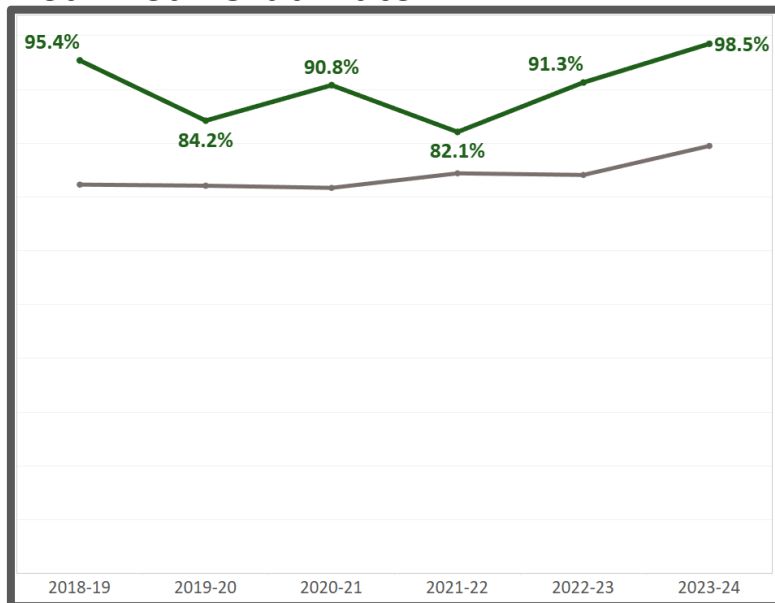
Average Math DFS decreased schoolwide and for all student groups between 2021-22 and 2023-24.



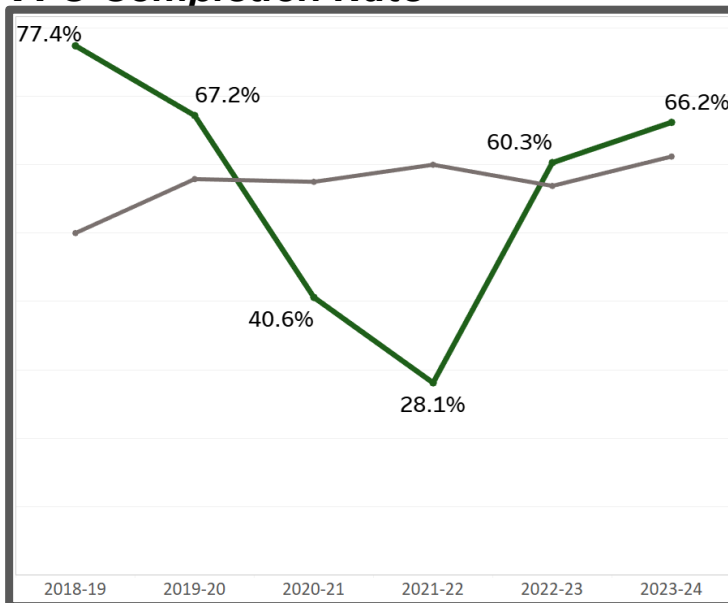

A-G Completion Rate

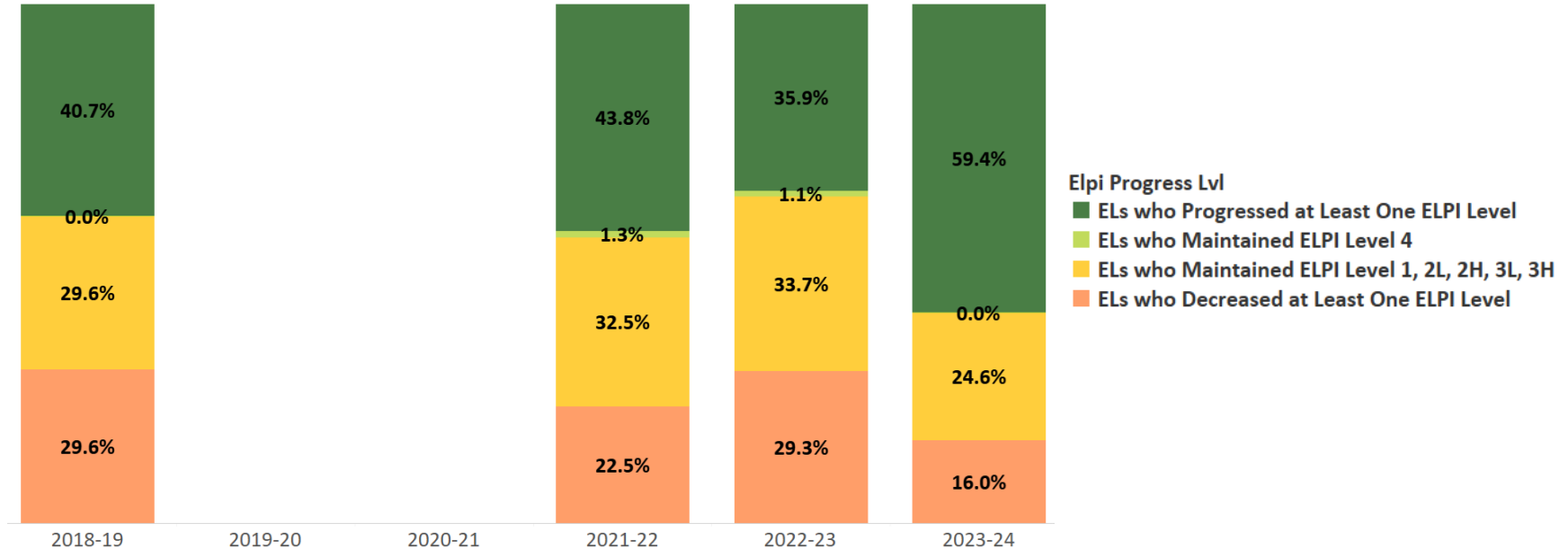


Although A-G rate decreased significantly post-pandemic, both the A-G Rate and the Grad Rate were higher than the District in the most recent two years.

English Learner Progress

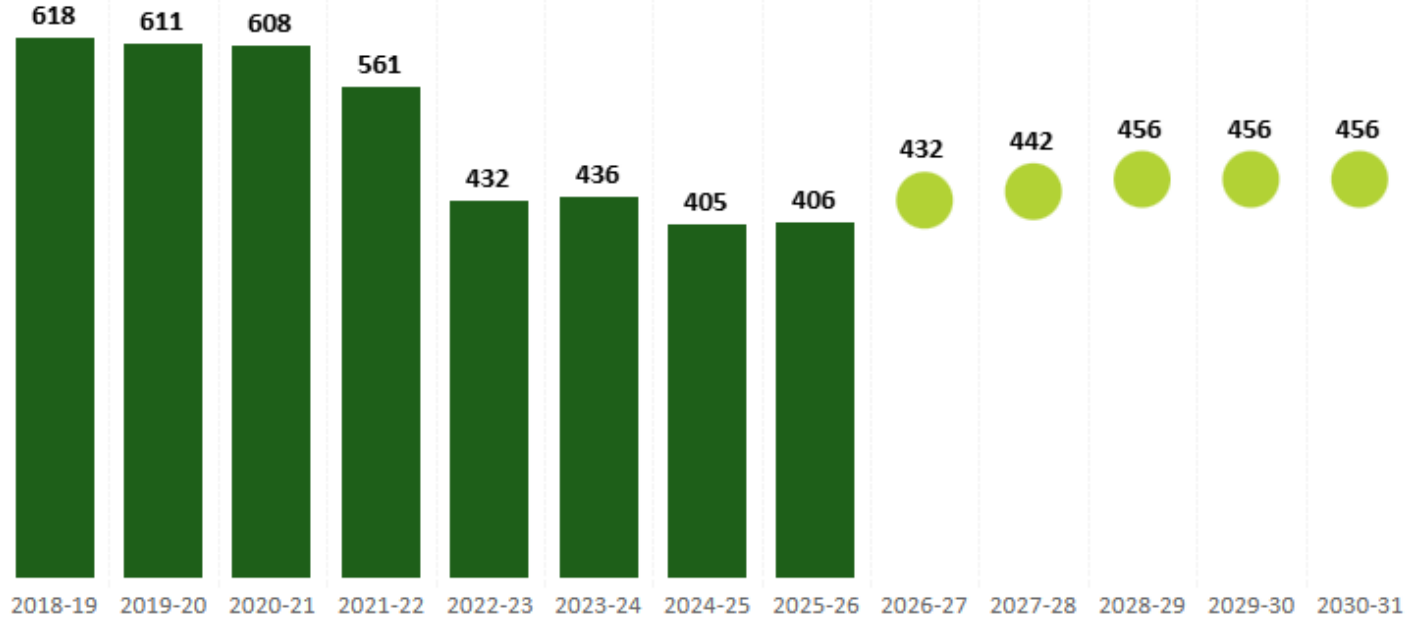


The percentage of students progressing at least one ELPI Level increased significantly in 2023-24 with the percentage of students decreasing at only 16%.

Aspire GSP's total enrollment decreased significantly post-pandemic, with the school projecting increases over the next 5 years.

Renewal Criterion 3

Renewal Petition Review

The charter petition included a reasonably comprehensive description, per State standards, of the 15 required elements outlined in California Education Code.



Renewal Criterion 4

CDE Enrollment Data and Complaints

There were no substantiated complaints related to noncompliance with suspension, expulsion, or involuntary disenrollment procedures and no evidence in the State-provided enrollment data which suggests the Charter School is not serving all students who wish to attend.

Staff Recommendation

The OUSD Office of Charter Schools recommends APPROVAL

with a Fiscal Benchmark to track audit finding clearance and a Performance Benchmark to track Math progress.

Strengths

- Very high percentage of ELs making progress in most recent year, with Blue EPLI indicator.
- Post-pandemic increase in high school ELA proficiency.
- Significant increases for Students with Disabilities in Math and ELA DFS in most recent year.
- High graduation rate with upward trajectory.
- Despite declining enrollment, remains a sustainable size with a healthy fund balance.

Challenges

- Decline in Math proficiency and DFS over the term, with current proficiency at 6.9% with a Red Dashboard indicator.
- Schoolwide ELA proficiency and DFS remain below the District average.
- A-G rates declined significantly during charter term, although have shown recent improvement.
- Most recent audit identified two material weaknesses.
