Subject 2024-25 Prop 39 Applicant Update

Ask of the Board Review and discuss the applicants for the 2024-25 cycle of Proposition 39.

Background Proposition 39 ("Prop 39") is a state law which requires school district facilities to

be shared fairly among all public-school students who reside in the district, including those in charter schools. Each year, as part of this process, OUSD is legally required to offer facility space to all charter schools who apply for space through

the Prop 39 process.

The deadline for charter schools to apply for Prop 39 for the 2024-25 cycle was November 1, 2023. OUSD received applications from 12 charter schools,

representing approximately 3,019 in-District ADA.

Proposition 39 - Overview

Proposition 39 is a state law which requires school district facilities to be shared fairly among all public school students who reside in the district, including those in charter schools.

School districts must make facilities available to charter schools to serve their **in-district students** in conditions **reasonably equivalent** to those in which they would be served if they were attending other public schools in the district.

Prop 39 - OUSD Obligations

OUSD is required by law to fulfill the following obligations:

Must offer enough space to accommodate the charter school's in-district students.

Facilities offered
must be <u>reasonably</u>
<u>equivalent</u> to the
facilities the charter
school's students
would attend if they
were at District
schools

Facilities offered must be <u>contiguous</u>, furnished, and equipped (Can be offered at more than one site if certain findings are made)

District must make reasonable efforts to provide the charter school facilities near to where they wish to locate

Prop 39 FAQs

How much space are we required to offer Prop 39 applicants?

A charter school is entitled to classroom space based on the charter school's in-District ADA
and space provided to students at a set of District-operated Comparison Schools. The
charter school's classroom entitlement is based on the average ratio of classrooms to
ADA at their comparison district schools.

Example: A charter school projects 200 ADA. The three District comparison schools have an average 20 ADA per classroom. The charter school is entitled to 200/20 = 10 classrooms.

Which sites are offered as part of Prop 39?

- OUSD has discretion to choose which sites to offer, but <u>must make legally compliant offers</u>.
- OUSD takes into account a variety of factors in determining sites to offer, but the most important is *underutilized space*.

Prop 39 - Using Utilization to Make Offers

Offers are given at sites that have **underutilized space**, as determined by the Utilization Formula:

Gen Ed Instructional Classroom Usage

Based on Master Schedule Data

Flex Classroom Usage

All District schools entitled to 2 "flex" classrooms



Special Education Classroom Usage

Includes space for SDC classes as well as additional SPED service providers

Other Classroom Usage

Includes Adult Ed, Central Office, ECE, Charters, external orgs, etc.

In-Lieu of Prop 39 Leases

In an effort to increase facility stabilization and minimize Prop 39 offers, OCS engages in negotiations with some schools to pursue "In-Lieu of Prop 39" leases. Benefits of this process include:

- Additional classrooms and years beyond Prop 39 baseline are charged at a premium
- Charter is responsible for additional facilities responsibilities
- Potential for longer lease terms (up to 4 years, aligned to end of charter term), which decreases disruption at school sites
- Negotiated earlier in the year, reducing uncertainty for both District and charter schools
