**ASSIGNING THE MONITORING AND REPORTING OF EXPENDITURES OF FACILITIES BOND MEASURES "A", "B" AND "J" TO THE MEASURE "B" INDEPENDENT CITIZENS' SCHOOL FACILITIES BOND OVERSIGHT COMMITTEE AND RENAMING SAID COMMITTEE THE INDEPENDENT CITIZENS' SCHOOL FACILITIES BONDS OVERSIGHT COMMITTEE**

**WHEREAS**, on June 6, 2006 the voters of the City of Oakland approved School Facilities Bond Measure "B" to provide financing to repair and modernize elementary, middle and high schools, including renovating classrooms, restrooms and other facilities to meet current safety standards, and to repair electrical, plumbing and other building systems, and to build libraries, classrooms, and science and computer labs, in accordance with the then District's Facilities Master Plan; and,

**WHEREAS**, in accordance with the language of Measure "B" and the requirements of Education Code Sections 15278 and 15282, the Governing Board (State Administrator) established the Measure "B" Citizens' School Facilities Bond Oversight Committee ("Committee"), pursuant to Resolution No. 0607-0031, adopted August 30, 2006, for the purpose of monitoring and informing the public concerning the expenditure of said school facilities Bond revenues; and,

**WHEREAS**, by Resolution No. 1112-0198, adopted April 4, 2012, the Governing Board, although not required, authorized the Measure "B" Committee to monitor and inform the public and Board concerning the expenditure of remaining Measure "A" Bond revenues, as specified in said Resolution; and,

**WHEREAS**, on November 6, 2012 the voters of the City of Oakland approved Measure "J" to improve the quality of Oakland schools and school facilities to better prepare students for college and jobs, to upgrade science labs, classrooms, computers and technology, improve student safety and security, repair bathrooms, electrical systems, plumbing and sewer lines, improve energy efficiency and earthquake safety, in accordance with the current District's Facilities Master Plan; and,

**WHEREAS**, in accordance with the language of Measure "J" and the requirements of Education Code Sections 15278 and 15282, the Governing Board is required to established a Citizens' School Facilities Bond Oversight Committee ("Committee"), for the purpose of monitoring and informing the public concerning the expenditure of Measure "J" school facilities Bond revenues,

**NOW, THEREFORE, BE IT RESOLVED**, the Governing Board hereby assigns the responsibility of monitoring and informing the public concerning the expenditure of Measure "J" school facilities Bond revenues to the established Measure "B" Committee; and
