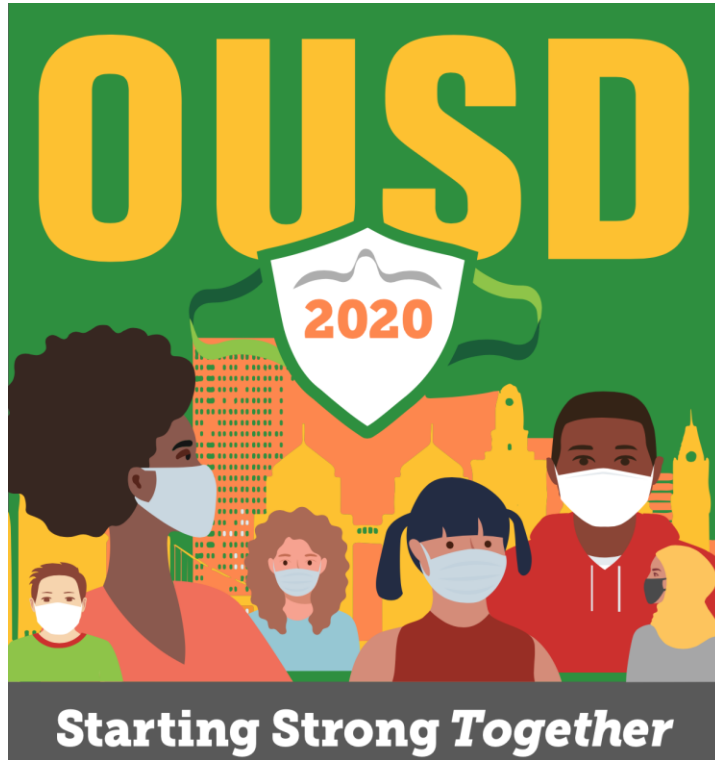

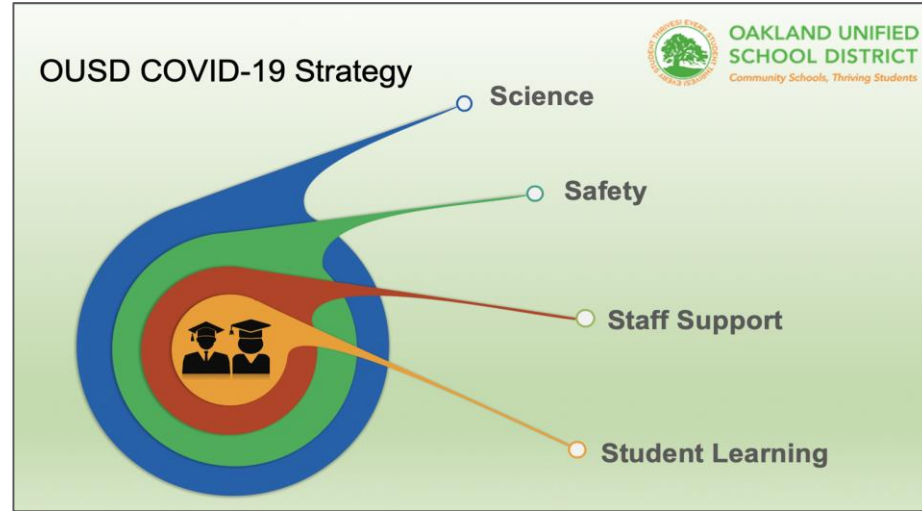

Partnership with Oakland Ed Fund. Volunteers matched with teachers (classroom Zoom Assistants) and with individual students (tutoring). 60 volunteers matched with nearly 240 more in process.

Special Education Services and Testing

Support Pods

We are providing in-person services beyond the virtual instructional day to a group of students identified by their teachers as being impacted by significant skill regression. Pods will launch in November at multiple OUSD campuses, each with 2-3 pods on site. These pods are being supported by Non Public Agency Staff and paraeducators from AFSCME.

In-Home Service

We have partnered with two nonpublic agencies to provide in-home behavioral technician support and in-home tutoring for our students who have experienced the most significant skill regression. Additionally, we launched a cadre of engagement liaisons to support the reengagement of a small group of students with IEPs who are not attending online courses.

Assessment

We have several assessment teams working on unfinished evaluations from the Spring of 2020, and we are expanding our capacity through the expansion of contracted assessors and OUSD volunteers.

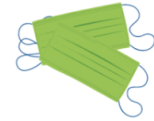

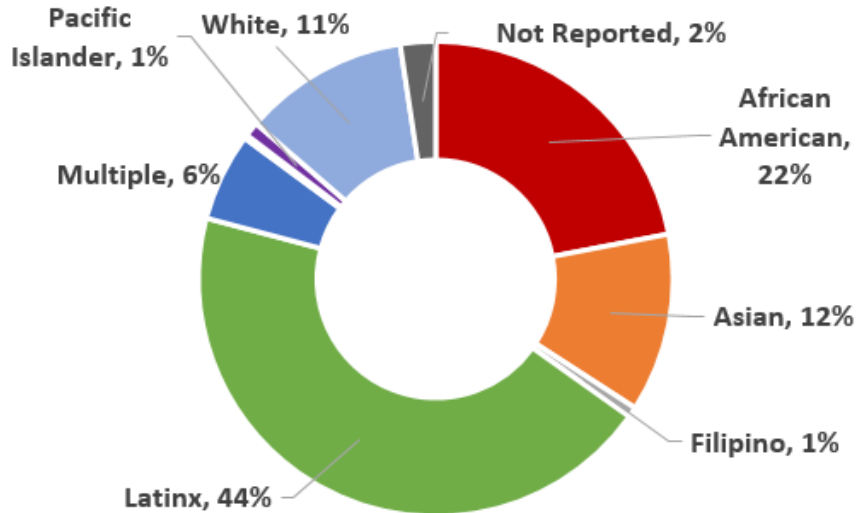

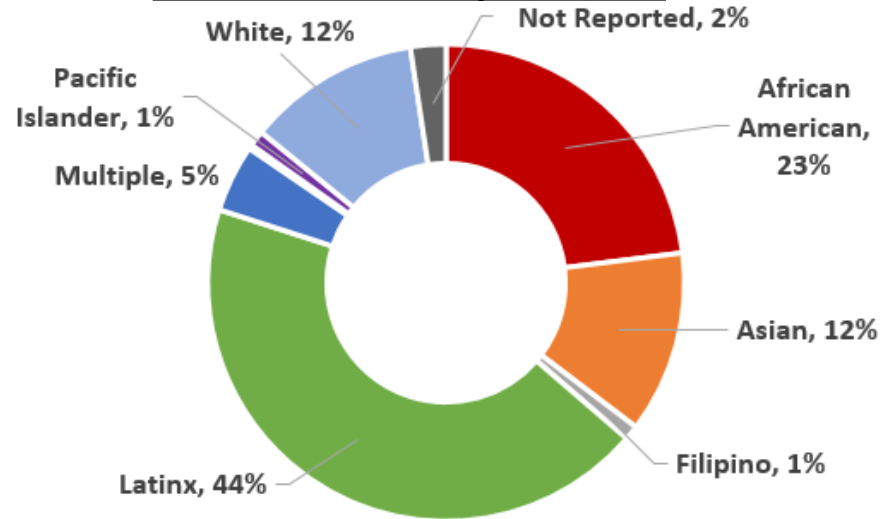
Demographic Comparison



Student Technology Access Dashboard

Developed dashboard that tracks individually how we can confirm that every student has access to the appropriate technology by using 4 types of data: Tech Check survey that is validated with login, computers and hotspots checked out to students by OUSD (OUSD Loaners) and OU Devices, and device tracking that is collected every time a student logs into Clever or Google.

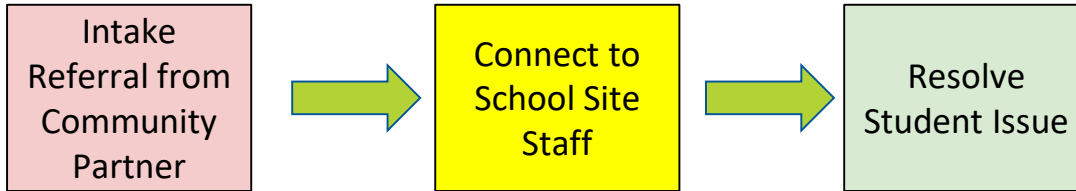

Disaggregated Data to Connect Students

Where is OUSD focusing our outreach to ensure that all students have a quality connection to distance learning?

- Out of the 35,241 students enrolled in the district, **only 142 were accessing their online learning through a phone**. We are currently going student by student to ensure they have a device.
- **67/82 schools have 100% of the Unhoused students** confirmed to have both internet access and a computer to access distance learning
 - There are 749 Unhoused/Homeless Students currently identified in OUSD
 - 44 students may need both internet access or a computer
 - 29 students may need internet access
 - 16 students may need a computer
- **69/82 schools have 100% of the Foster Youth** confirmed to have both internet access and a computer to access distance learning.
 - There are 197 Unhoused/Homeless Students currently identified in OUSD
 - 25 students may need both internet access or a computer
 - 5 students may need internet access
 - 3 students need a computer

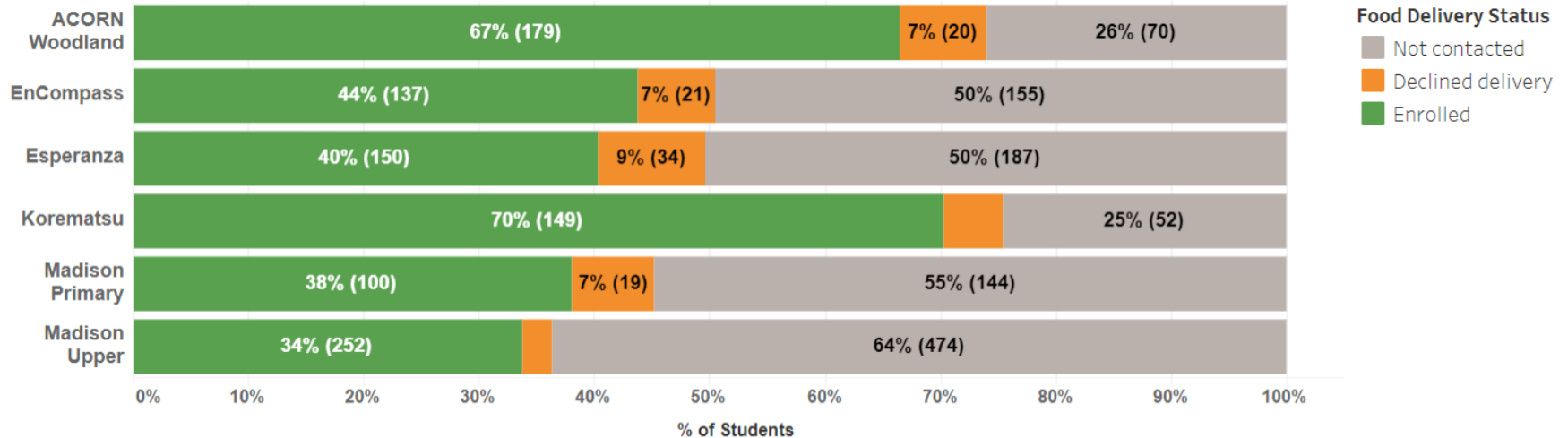

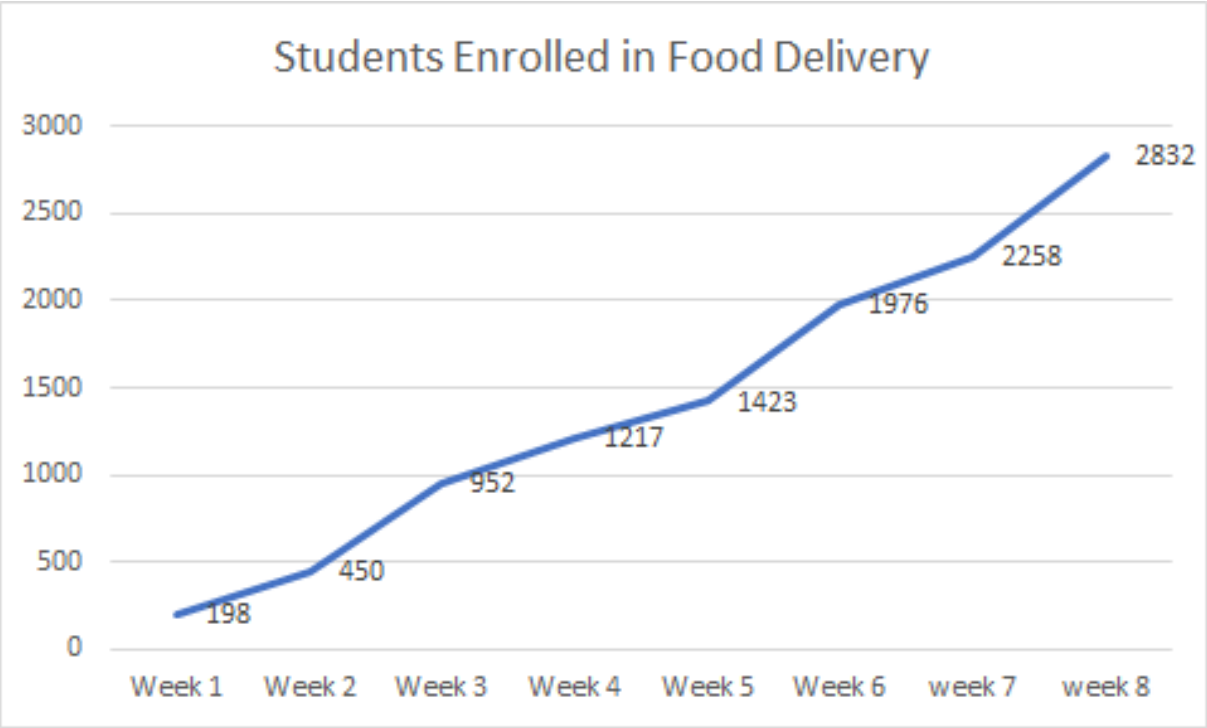
Home Delivery-Pilot Schools

During the week of October 19th, OUSD delivered 53,808 meals to the homes of 2,832 children

“Growing Together” Driver-Mario Mendoza



Mario Mendoza is a part of the team of parents who provide home delivery service of food to families, and he also does administration and customer service.

“My sons have lived in Oakland since they were born. One of them attended both Harriet Tubman Pre-School and **Hoover Elementary School**. He's now on his last year of high school and is college bound. In name of all our community, we thank you for all the help you've provided through these unprecedented times. I can go on and on to tell the impact in our lives. I can only say **THANK YOU**”

To date, “Growing Together” has contracted with over **25 out of work OUSD parents to deliver produce boxes and school meals to OUSD families during distance learning.**

To date, this has directly supported OUSD families by using philanthropic dollars to pay the drivers **nearly \$120,000 that goes directly to our families.**

During the summer, the average of \$750 per week per driver

If you want home delivery....

Who is eligible to sign up for home delivery?

An OUSD student and any of their siblings (18 years old and younger) who live in the same household are eligible for meal delivery (even if the sibling attends a charter school or is too young for school). **To sign up, you will need the OUSD ID number of at least one child in the household.**
