BACKGROUND/DISCUSSION

As you may know, the California School Boards Association (CSBA) is a collaborative group of virtually all of the state's more than 1,000 school district and county offices of education which advocates for and promotes the interest of K-12 children through a variety of organized means.

The Association's governance structure, in part, provides for a Delegate Assembly, elected, in part, by member school boards divided into Subregion. The Oakland Board is a member of the Association and is geographically located in Subregion 7-B (Alameda County).

Presently there are four delegates to be elected to the Delegate Assembly from Subregion 7-B of the Association for a two year term commencing April 1, 2015. The Assembly will meet at least twice a year to conduct business and may also meet with other Delegates and Director of the Region and otherwise act in the interests of the Association.

Four school board member candidates within CSBA Subregion 7-B have qualified to seek the office. I believe that each candidate will personally serve the interests of the Oakland Board and well represent the Subregion as a whole if elected to the Delegate Assembly.



CSBA's Delegate Assembly sets the general education policy direction for the Association. As a member of the Delegate Assembly, please describe what your top three educational priorities would be, and why they are important to the Association.

My top three educational priorities are; supporting parent/community engagement in the LCAP, equity in education and addressing the needs of English Language Learners. A key factor in the success of the LCAP is the inclusion, involvement and partnership of parents and community in the LCAP process. Their involvement is critical in evaluating what is having the most impact in reaching all of our students. Ongoing issues of racism and discrimination in our communities is a reminder that Equity in Education must be upfront and a topic of discussion, reflection and evaluation of how it plays out in our schools, curriculum, community, administration and systems. Without the lens of equity we are missing the opportunity of providing our students, teachers, parents and community the tools to be pro-active in the inequities that are happening in real-time for our students. English Language Learners, curriculum, instruction and best practices require our ongoing attention and advocacy this 1st year of the LCAP and Common Core curriculum/adoption and implementation.

Another responsibility of Delegates is to communicate the interests of local boards to CSBA's Board of Directors, Executive Committee and staff. Please describe your activities/involvement or interests in your local district, county and/or CSBA committees, etc.

For the past three years I have served on the SARB Board in my district, attending sessions with students, staff, community, parents, teachers, safety officers, nurses and hearing directly as a school board member the barriers our students and families face in attending school. I have also attended the State SARB Board hearing and was able to address on a state level the issues that districts face in helping students and families referred to SARB. I was proactive in my district in supporting improved practices in attendance monitoring and bringing forth truancy resolutions and supporting legislation that address students needs. In Alameda County, I have participated actively for over 20 years in the Child Care Planning Council wherein I sit with other Program Directors of Child Development programs in our county (non profit and school districts). Together we address on many levels (legislative, advocacy, action and collaborations) how to collaborate, sustain and expand county wide quality care and education to working families from infancy to school age in the school/college districts and in community based programming.

My educational priorities are:

- 1) Student Health and Wellness. We must have a learning environment that permits us to be attentive to our students' physical and mental health.
- 2) Lack of Career Technical Courses. Funds need to be invested in this area so our students have options outside the traditional college path.
- 3) Ensuring adequate support for our at-risk and focal students (socio-economic disadvantaged students, English-Language learners, and designated sub-groups) in order for them to achieve success.

These are important priorities as we must be proactive in supporting our students for success.

I have been active as a school and community volunteer. I have served as a member of the School Site Council (SSC) for Bay Farm School (K-8), Lincoln Middle School (Chairperson), Alameda High School (Chairperson), and Encinal High School. Also, I have been room parent, PTA Financial Secretary, and an after school math enrichment lecturer for interested students looking to advance their understanding of math. At the community level, I serve as a board member for the Community of Harbor Bay Isle (HOA) representing the largest village consisting of five associations where I regularly meet with the board of directors of each association throughout the year so that I am always informed about their concerns and input. CSBA's Delegate Assembly sets the general education policy direction for the Association. As a member of the Delegate Assembly, please describe what your top three educational priorities would be, and why they are important to the Association.

Originally, I ran for the Delegate Assembly because our District had replaced 6 out of the 7 Board members, and we (the new Board) were seriously in need of knowledge and information. I found the Delegates' meetings and the MIG trainings very helpful. After the election this week, I will be the senior member of the Board, as all other seats have changed again. My priorities involve increasing training opportunities for individual Boards (e.g. Common Core info, Brown Act, financial insight would be helpful.) I would like to also see more involvement of the Delegate Assembly in lobbying activities. Third, I would like to see the group develop materials and participants in a "traveling road show" that could be invited to various Districts, when we are seeking candidates to run for office. Frequently our seats are uncontested, or the candidates are either people with an axe to grind or folks without a clue as to the purpose of School Boards. If we could develop low-cost training for prospective Board candidates, perhaps by volunteer members in nearby districts, it might benefit every district in the state.

Another responsibility of Delegates is to communicate the interests of local boards to CSBA's Board of Directors, Executive Committee and staff. Please describe your activities/involvement or interests in your local district or county office.

I was Board president a year ago when we hired a new Superintendent. I had taken the Superintendent Evaluation workshop, so that was helpful. I also connected with several local Delegates to "pick their brains" about the issues. In addition, I have served on the Finance Committee and the Curriculum Committee in San Leandro. I have been the chair of the Facilities and Technology Committee for 4 years. During that time we have completed a \$150 million set of bond projects, passed a \$50 million bond for athletic facilities, solar and seismic projects, converted the entire District to a technology-based program that is connected to the city's fiber-optic loop and provides computers in all classes 4th - 12th grade (we're still working on the primary access.) I have also worked with our County Association (ACSBA), although it isn't totally functional at this point. And I have worked on a few projects with our current county Superintendent. CSBA's Delegate Assembly sets the general education policy direction for the Association. As a member of the Delegate Assembly, please describe what your top three educational priorities would be, and why they are important to the Association.

My top three education priorities are (1) Amping up District family involvement efforts; (2) Appropriately funding federally mandated special education, and (3) Improving delegate representation. First, Revving up family involvement champions cooperative efforts of students, staff, and families, decreases the achievement gap, and increases positive student outcomes. Decisions regarding evaluation, grading and funding issues, made together, promote student success. Secondly, the Special Education encroachment on District funds, to make up for the federal contribution of the anticipated 60% , fundamentally disrupts equity in providing quality pupil services. You do count and your views need to be heard as a priority need which the iCount census completely demonstrates. In summary, I stand for increasing family involvement, fully funding SPED, and better representing constituent views on policy and CSBA positions.
