This educational experience will give students the opportunity to expand music production skills as many aspects of creating music tracks include samples, scratching and mixing. Students will also have an opportunity to explore career opportunities such as DJ-ing at live events, radio broadcasting, and performing live music. Approximately 60 students will be served by this class. This expenditure aligns with our goal of building out the college and career exposure of our pathways.  These funds will supplement an already approved Strategic Action in our 2021-22 Carryover Plan.	\$5,000.00




