The Committee shall have the option to tour sites where Bond funds are being expended, with support from the Superintendent.

Michael Ezeh, Account Manager, gave a presentation on Measures B and J Budget to Actual Expenditures and Cash Flow Projections for Year Ending June 30, 2025, and as of September 30, 2025. Michael Ezeh and David Colbert, Director, Facilities Planning and Management responded to comments and questions from the Committee.

Discussion - Member Dawson, Nelsen, Clark, Chairperson Butler

Historical Expenditures Detailed by Site. Michael Ezeh reviewed the document, taking the committee through the spreadsheet which details by measure, by site and project number as well as the original board approved budget, its current budget, and budget to actual balances and whether such project is in design, construction or completion (or rescinded) stages. In addition, a Project Budget Reconciliation one pager was prepared for all current major project listed by Project Number. This provided a snapshot of current vendors and status of construction and financing for each project.

Measure B and Measure J Bonds have no un-issued bonds remaining and currently are sitting at respective balances of \$5.2 million and \$25.4 Million.

Measure Y Bonds were initially approved to raise \$735,000,000. As of October 1, 2025: Measure Y Issued funds available are \$183,248,354.00. There remains another \$365 million of un-issued bonds.

Total available funds for Measures B, J, and Y are approximately \$213,810,092.00.

Questions asked from the Committee:

- How is the sale of bonds impacted by school's ability to manage its funding

or how dependent is bond rating on OUSD balancing of its books?

- When are bonds going to be issued next?
- Has staff and OUSD made a decision when the school district expects to go back to ask the public for additional support?

Several committee members voiced concerns that it might be important to go solicit support from the Community sooner than later given the climate regarding parcel taxes and uncertainty in the economy.
