Action Requested

Approval by Board of Education of Resolution 1314-0037 authorizing the District to file an Application for Exemption for Fiscal Year 2010-11 from the Education Code requirement (Education Code Section 60119(a)) that the sufficiency of textbooks and materials public hearing be held on or before the end of the eighth week of school and authorization to submit same to the Alameda County Superintendent of Schools

Background and Discussion

Education Code Section 60119(a)(1) stipulates that the governing board shall hold a public hearing or hearings at which the governing board shall encourage participation by parents, teachers, members of the community interested in the affairs of the school district, and bargaining unit leaders, and shall make a determination through a resolution, as to whether each pupil in each school in the district has, or will have prior to the end of the fiscal year, sufficient textbooks or instructional materials, or both, in each subject that are consistent with the content and cycles of the curriculum framework adopted by the state board.

Education Code Section 60119 further stipulates that the governing board hold the public hearing on or before the end of the eighth week of school. Although the District met the substantive requirements of sufficiency of materials and textbooks for the 2010-11 school year, the Board of Education held the public hearing 3 days after the timeframe provided in Education Code Section 60119. This was an oversight that did not recur for 2011-12 or 2012-13. As a result of the not complying with the requirement to hold the public hearing before the end of the eighth week from the first day pupils attended school, the State Controller's Office (SCO) recommended disallowance of Instructional Materials Funding Realignment Program funds received in the amount of \$2,217,698 for fiscal year 2010-11.

The Education Code also authorizes the County Superintendent to waive noncompliance with Education Code Section 60119. The waiver request is pursuant to Section 60119 of the Education Code. If the County Superintendent approves the waiver, the SCO disallowance will be negated and the District will not be required to appeal this finding to the Education Audit Appeals Panel.

No budget adjustments are required for either the current or prior year.

Recommendation

Approval by Board of Education of Application for Exemption for Fiscal Year 2010-11 from Education Code Section 60119(a) that the sufficiency of textbooks and materials public hearing be held on or before the end of the eighth week of school and authorization to submit same to the Alameda County Superintendent of Schools

ACTION REQUESTED:

Conduct Public Hearing and, following close of hearing, adopt resolution and report on the sufficiency of textbooks and instructional materials for all schools sites as required by Education Code Section 60119 (Williams Case).

BACKGROUND:

In May 2000, the ACLU and other public interest advocates representing students across the state filed a lawsuit against the State of California, the Superintendent of Public Instruction, the State Board of Education and the California Department of Education. The basis of the lawsuit was that the agencies failed to provide public school students with equal access to instructional materials, safe and decent school facilities, and qualified teachers.

The Instructional Materials ordering process for the 2011-12 school year is as follows.

1. All instructional materials were ordered based upon 2011-12 enrollment projections, designated schools' responses to our inquiries, and in alignment with the completed instructional materials survey results. The schedule for the ordering and delivery of instructional materials:

Materials ordered by:	Program	Shipped to sites
February 15	OCR consumables	May 15
February 15	Foro consumables	May 15
March 15	All subject-area consumables	May 15
June 30	adjustments per conf w/principals	August

- 2. An excel file is maintained for each school site that indicates materials and quantities ordered. Each file is updated after orders are placed. Individual school textbook order files are available upon request and are sent by e-mail. In addition, for the purpose of accountability and maintaining an accurate and current warehouse inventory, there is a separate file for each school of materials distributed from the warehouse. This includes a form signed by principals or their designees each time they pick up materials from the warehouse.
- 3. Williams-mandated Textbook Surveys for all schools were available on-line April 4th, 2011. In addition, all schools received a packet of written directions and helpful organizational tools during the week of March 21st April 1st. Completed school surveys were due on May 26th, 2011 Research, Assessment and Data provided ongoing support to schools as well as a "drop-in clinic" May 9th 13th at the Cole Annex.
- 4. Leadership, Curriculum & Instruction textbook management and staff convened one-to-one meetings with all of the Williams schools principals June 20th 30th. Non-Williams school principals were invited and encouraged to meet as well. The purpose of these meetings was to:
 - Review of site-specific Williams Survey
 - Review of site-specific data about what has been ordered to date
 - Review of updated Projected Enrollment Data
 - Discussion: additional needs
 - Review of what the site is responsible to order in regards to lost textbooks
 - Review of OUSD 11-12 Instructional Materials Purchasing Policy

Based upon meetings with the principals and updated enrollment data, additional materials from the warehouse were distributed to designated schools and/or adjustments were made to orders. This process was completed by July 22nd.

- 5. Beginning August 16th it was incumbent upon principals to inform Leadership, Curriculum and Instruction staff of additional textbook needs based upon additional enrollment.
- 6. A training was conducted on August 17th, 2011 for the principals of Williams schools on how to successfully prepare for the upcoming ACOE Williams Textbook Audit.
- 7. All schools are required to complete the September Update Report by September 16th, 2011. The purpose of this report is to once again verify the current quantity of textbooks that each school currently has and determine any additional textbooks that are needed for the 2011-12 school year.

DISCUSSION:

The results of the survey showed that all schools have a sufficiency of textbooks and/or instructional materials as required by SB 550.

FISCAL IMPACT:

As of September 13th, 2011 expenditures on textbooks/instructional materials are as follows:

WHEREAS, the Governing Board of the Oakland Unified School District, in order to comply with the requirements of Education Code 60119, held a public hearing on October 12th, 2011, at 7:00 o'clock, which is on or before the eighth week of school (between the first day that students attend school and the eighth week from that day) and which did not take place during or immediately following school hours; and

WHEREAS, the Board provided at least ten (10) days notice of the public hearing by posting it in at least three public places within the district that stated the time, place and purpose of the hearing; and

WHEREAS, the Board encouraged participation by parents/guardians, teachers, members of the community, and bargaining unit leaders in the public hearing; and

WHEREAS, information provided at the public hearing detailed the extent to which textbooks and instructional materials were provided to all students, including English learners, in the Oakland Unified School District; and

WHEREAS, the definition of "sufficient textbooks or instructional materials" means that each student, including English learners, has a textbook or instructional materials, or both, to use in class and to take home; and

WHEREAS between the 2008-09 through the 2012-13 fiscal years, the definition of "sufficient textbooks or instructional materials" also means that all students who are enrolled in the same course within the Oakland Unified School District, have standards-aligned textbooks or instructional materials from the same adoption cycle, and; WHEREAS, sufficient textbooks and instructional materials were provided to each student, including English learners that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in the following subjects:

The basis of the lawsuit was that the agencies failed to provide public school students with equal access to instructional materials, safe and decent school facilities, and qualified teachers.

In addition, for the purpose of accountability and maintaining an accurate and current warehouse inventory, there is a separate file for each school of materials distributed from the warehouse. This includes a form signed by principals or their designees each time they pick up materials from the warehouse.
- 3. Williams-mandated Textbook Surveys for all schools were available on-line April 2. In addition, all schools received a packet of written directions and helpful organizational tools during the week of March 19–23. Completed school surveys were due on May 24. Research, Assessment and Data provided ongoing support to schools as well as a "drop-in clinics" on May 7–11 at the Cole Annex.
- 4. Leadership, Curriculum and Instruction textbook management and staff convened one-to-one meetings with all of the Williams schools principals June 18–29. Non-Williams school principals were invited and encouraged to meet as well. The purpose of these meetings was to:
 - Review of site-specific Williams Survey
 - Review of site-specific data about what has been ordered to date
 - Review of updated Projected Enrollment Data
 - Discussion: additional needs

Based upon meetings with the principals and updated enrollment data, additional materials from the warehouse were distributed to designated schools and/or adjustments were made to orders. This process was completed by August 13, 2012.

- 5. Beginning August 20, it was incumbent upon principals to inform Leadership, Curriculum and Instruction staff of additional textbook needs based upon additional enrollment.
- 6. A training was conducted on August 15 for the principals of Williams schools on how to successfully prepare for the upcoming ACOE Williams Textbook Audit.
- 7. All schools are required to complete the September Update Report by September 21, 2012. The purpose of this report is to once again verify the current quantity of textbooks that each school currently has and determine any additional textbooks that are needed for the 2012-13 school year.



DISCUSSION:

The results of the survey showed that all schools have a sufficiency of textbooks and/or instructional materials as required by SB 550.

WHEREAS, the Governing Board of the Oakland Unified School District, in order to comply with the requirements of Education Code 60119, held a public hearing on October 10, 2012, at 7:00pm, which is on or before the eighth week of school (between the first day that students attend school and the eighth week from that day) and which did not take place during or immediately following school hours; and

WHEREAS, the Board provided at least ten (10) days notice of the public hearing by posting it in at least three public places within the district that stated the time, place and purpose of the hearing; and

WHEREAS, the Board encouraged participation by parents/guardians, teachers, members of the community, and bargaining unit leaders in the public hearing; and

WHEREAS, information provided at the public hearing detailed the extent to which textbooks and instructional materials were provided to all students, including English learners, in the Oakland Unified School District; and

WHEREAS, the definition of "sufficient textbooks or instructional materials" means that each student, including English learners, has a textbook or instructional materials, or both, to use in class and to take home; and

WHEREAS between the 2008-09 through the 2012-13 fiscal years, the definition of "sufficient textbooks or instructional materials" also means that all students who are enrolled in the same course within the Oakland Unified School District, have standards-aligned textbooks or instructional materials from the same adoption cycle, and; WHEREAS, sufficient textbooks and instructional materials were provided to each student, including English learners that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in the following subjects:

TO ALL INTERESTED PARTIES, PLEASE TAKE NOTICE that on October 10, 2012, at a Regular Meeting of the Governing Board of the Oakland Unified School District, the Board will hold a public hearing on the District's Sufficiency of Textbooks and Instructional Materials - FY 2012-2013.

The public hearing will be held, October 10, 2012 at approximately 6:00 p.m. or as soon thereafter as the matter may be heard in the Board Room, Paul Robeson Building, $1025 \, 2^{nd}$ Ave, Oakland, CA, 94606.

California Education Code Section 60119 requires that the Oakland Unified School District Board of Education ("Board") hold a public hearing to determine the sufficiency of textbooks and instructional materials in order to be eligible to receive funds for that purpose.

Finding 11-39

FINDING 11-39— Deficiencies in compliance with instructional materials program requirements (30000) (40000) (70000) The Standards and Procedures for Audits of California K-12 Local Education Agencies (section 19828.4(a)(1)), require that the auditor determine whether the District's Governing Board held the public hearing required by the provisions of Education Code section 60119 on or before the end of the eighth week from the first day pupils attended school for that year.

During our review of the instructional materials program, we noted that the District's Governing Board failed to hold a public hearing to certify that there were sufficient textbooks or other basic instructional materials by the end of the eighth week after the first day pupils attended classes. The Governing Board held the public hearing on October 27, 2010, which was during the ninth week of the school year.

As a result of not complying with the requirement to hold the public hearing before the end of the eighth week from the first day pupils attended school, the Instructional Materials Funding Realignment Program funds received in the amount of \$2,147,698 is unallowable.

Education Code section 60119(a)(1)(A) and (B) states:

- (a) In order to be eligible to receive funds available for the purposes of this article, the governing board of a school district shall take the following actions:
 - (1)(A) The governing board shall hold a public hearing or hearings at which the governing board shall encourage participation by parents, teachers, members of the community interested in the affairs of the school district, and bargaining unit leaders, and shall make a determination, through a resolution, as to whether each pupil in each school in the district has sufficient textbooks or instructional materials, or both, that are aligned to the content standards adopted pursuant to Section 60605 in each of the following subjects, as appropriate, that are consistent with the content and cycles of the curriculum framework adopted by the state board:
 - (i) Mathematics.
 - (ii) Science.
 - (iii) History-social science.
 - (iv) English/language arts, including the English language development component of an adopted program.
 - (B) The public hearing shall take place on or before the end of the eighth week from the first day pupils attend school for that year. A school district that operates schools on a multitrack, year-round calendar shall hold the hearing on or before the end of the eighth week from the first day pupils attend school for that year on any tracks that begin a school year in August or September. For purposes of the 2004-05 fiscal year only, the governing board of a school district shall make a diligent effort to hold a public hearing pursuant to this section on or before December 1, 2004.

Good internal controls require that the District's Governing Board implement controls to ensure it complies in future years with the requirement to hold the public hearing in a timely manner as required by Education Code section 60119.

This is a repeat of prior year Finding 06-45. Note that FY 2008-09 and FY 2009-10 were not audited.

Recommendation

The District should:

- Implement procedures to ensure that the District's Governing Board complies with the provisions of Education Code section 60119 and holds the required public hearing on or before the end of the eighth week from the first day that pupils attended school;
- Repay the State the amount of \$2,147,698 for the Instructional Materials Funding Realignment Program funds received.

District's Response

The District met all requirements with the exception that the District was three days late in holding the public hearing due to an oversight.

The District will request a waiver from Alameda County Office of Education, as is allowed by EC 41344.4. The District has verified that the public hearing was held within the required period for the 2011-12 fiscal year.

SCO Comment

As stated in the finding, the District did not hold the required public hearing within eight weeks of the first day of classes as required by Education Code section 60119. Because the District did not comply with Education Code requirements, whether through an oversight or other cause, the K-12 audit guide stipulates that the District was not eligible to receive instructional materials program funding.

Our finding remains unchanged.
