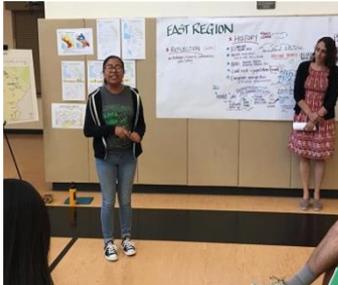
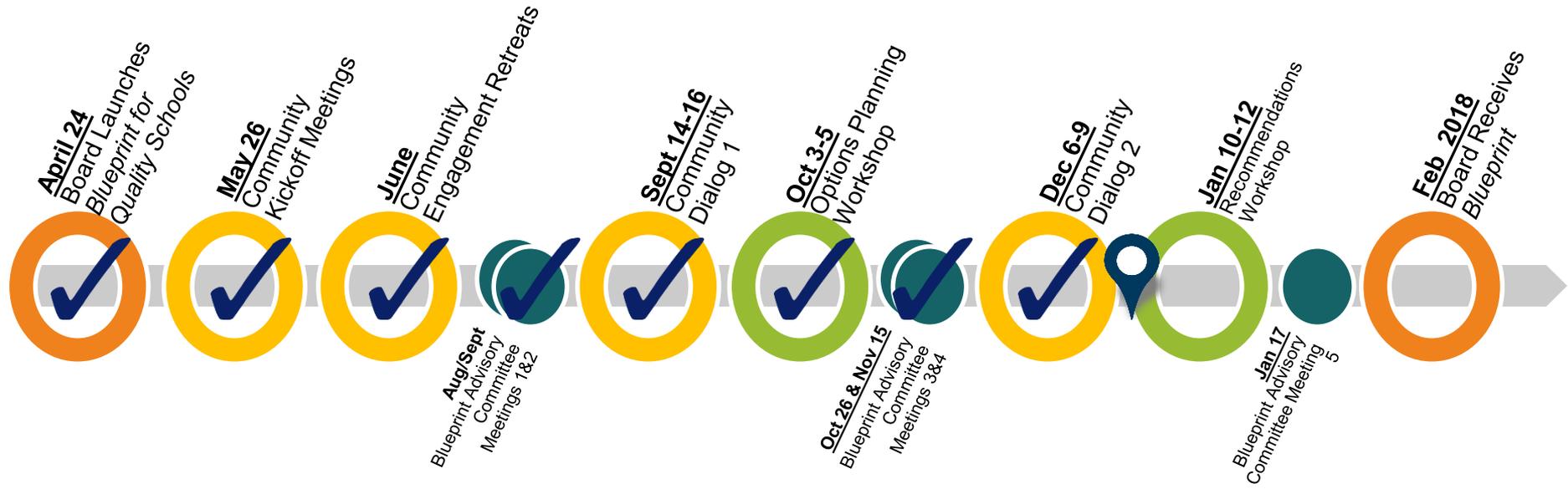
- **Prioritizing upgrades to buildings and programs**

Keeping in Mind **Our Constraints:**

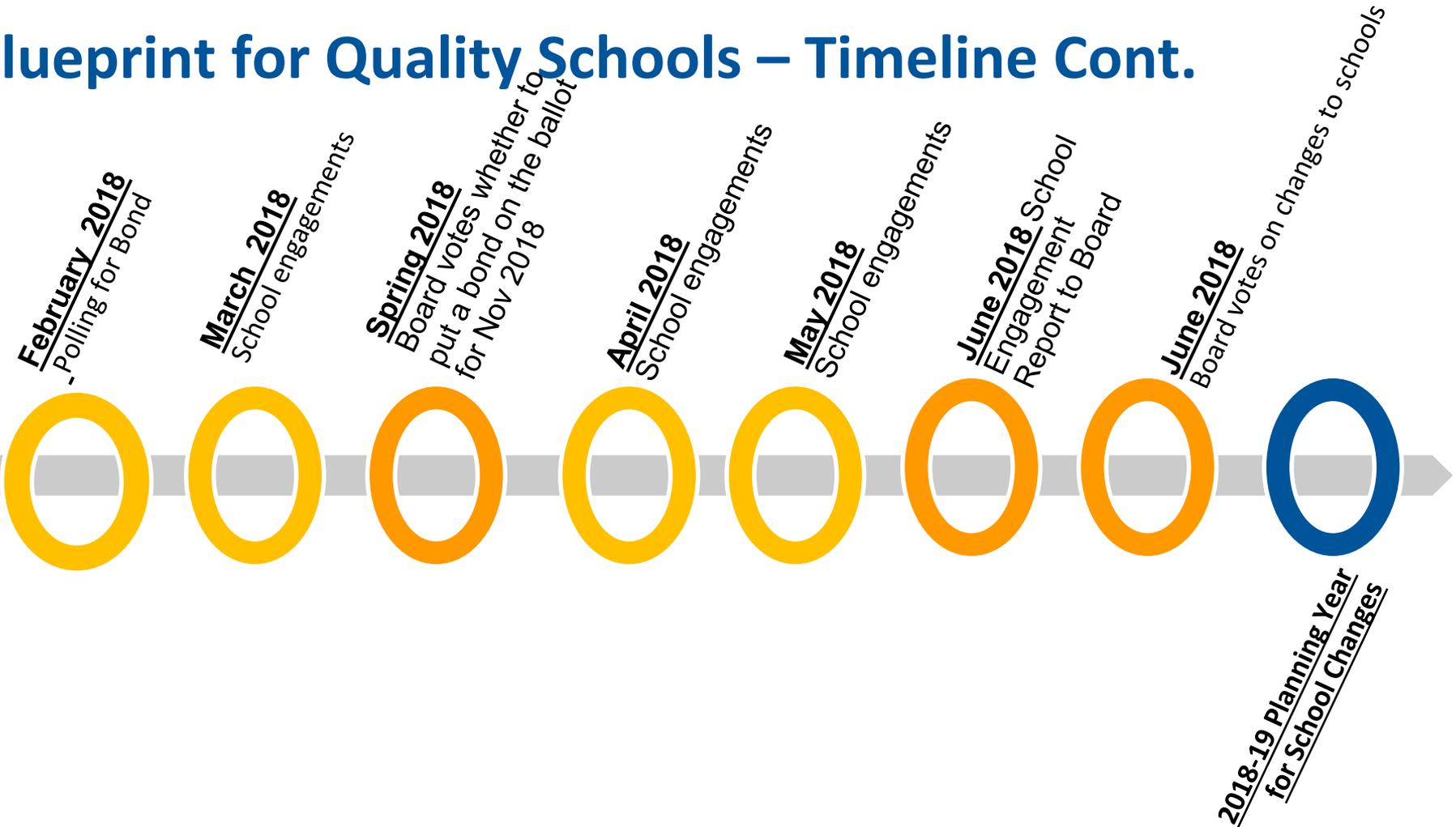
- California is 47th in per pupil funding in the nation

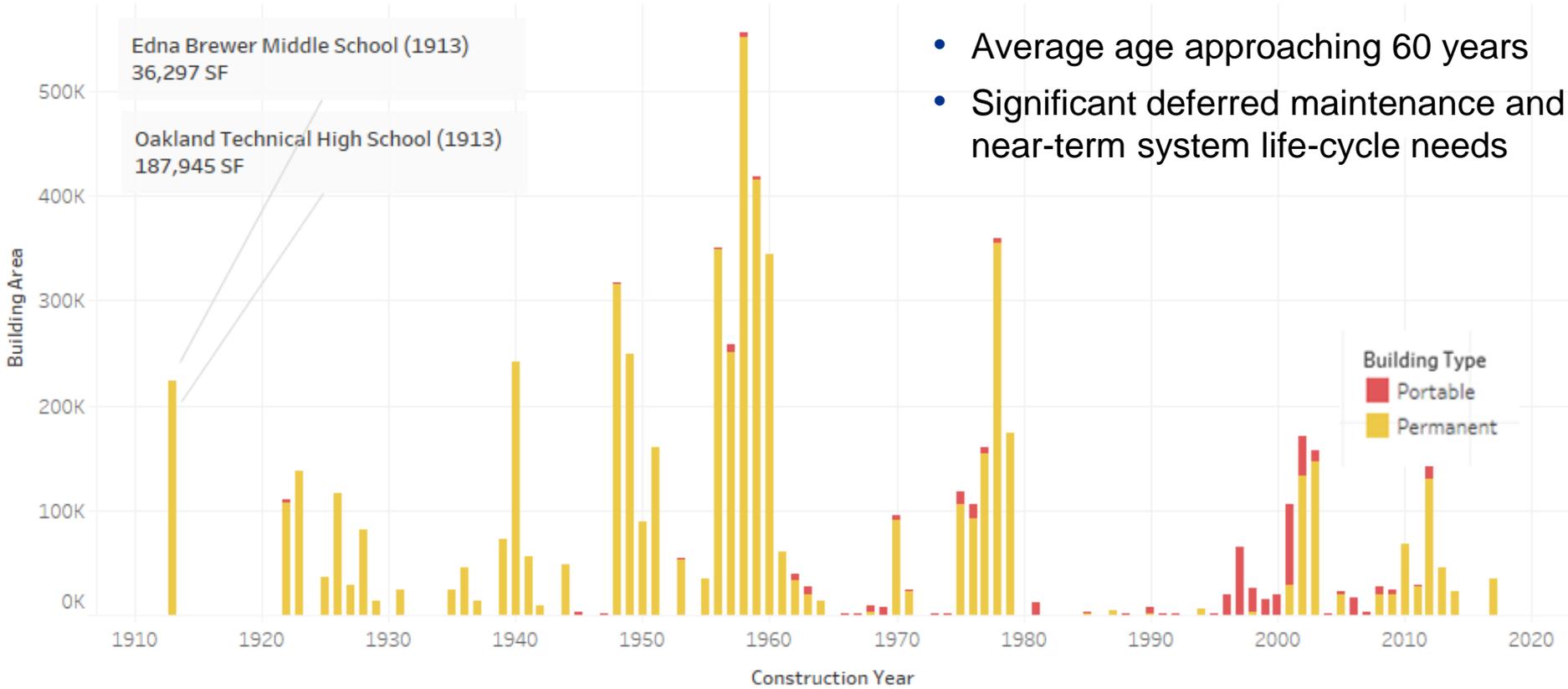

- Campus (site) vs School (organization)
- Average age 58 years
- 131 of the 515 portables are older than 30 years old, ~50 on underutilized campuses
- **Note:** While not included in assessment, the facility master plan considers unoccupied facilities and pre-K centers as assets for facility options.

Building Original Construction, Permanent and Portable

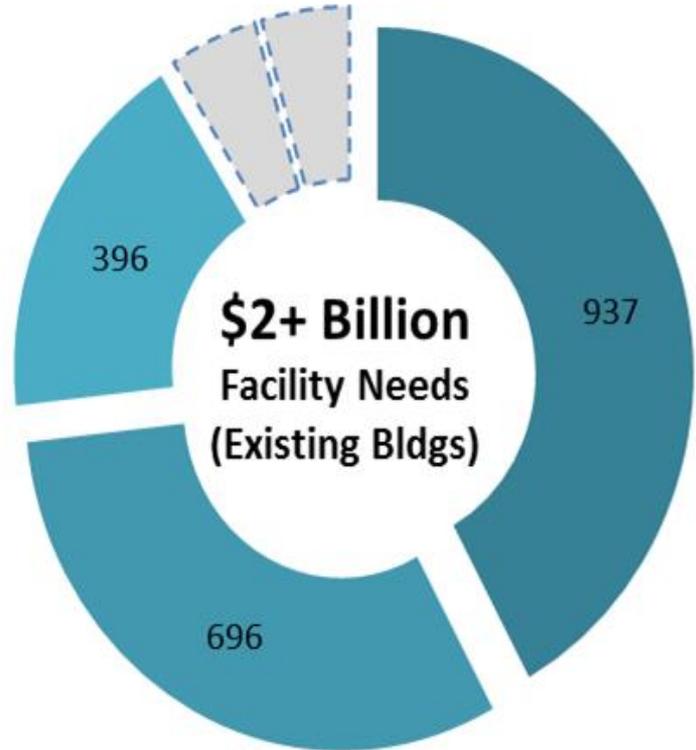


- Average age approaching 60 years
- Significant deferred maintenance and near-term system life-cycle needs

OUSD Facility Needs

- Facility Need Categories:
 - **5-Year Repairs** (what's broken)
 - **Seismic** (what are structural retrofits)
 - **Educational Adequacy** (what's missing)
 - **ADA** (accessibility deficiencies, pending)
 - **Program/Technology** (program enhancements defined during planning and engagement, pending)

• \$2+ Billion in Facility Needs
• Urgent need for capital bond in near term.
Committed bond funds insufficient to keep up with capital needs.

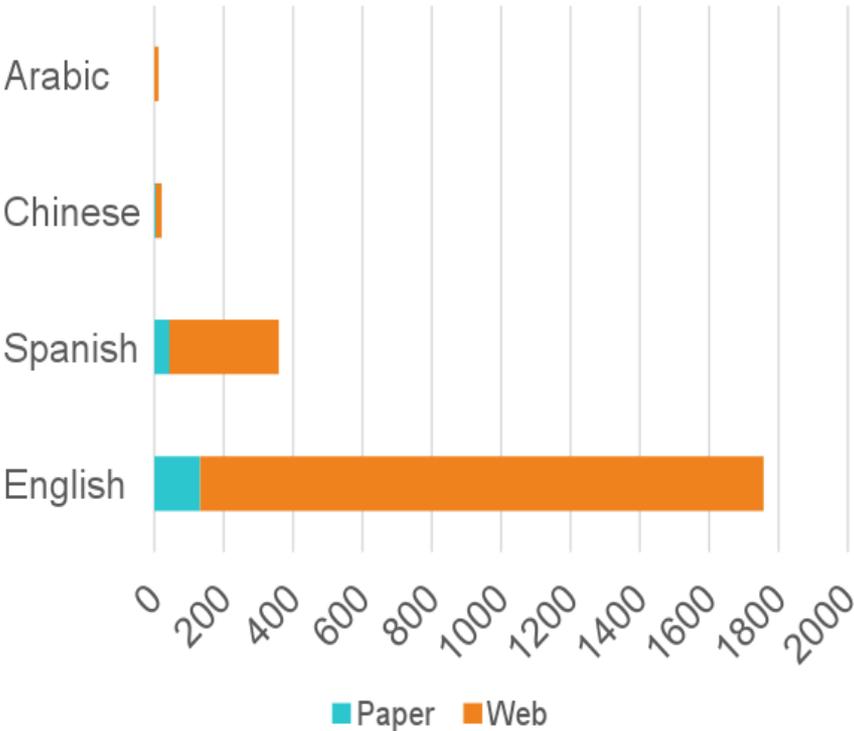

- Over 2,000 total responses

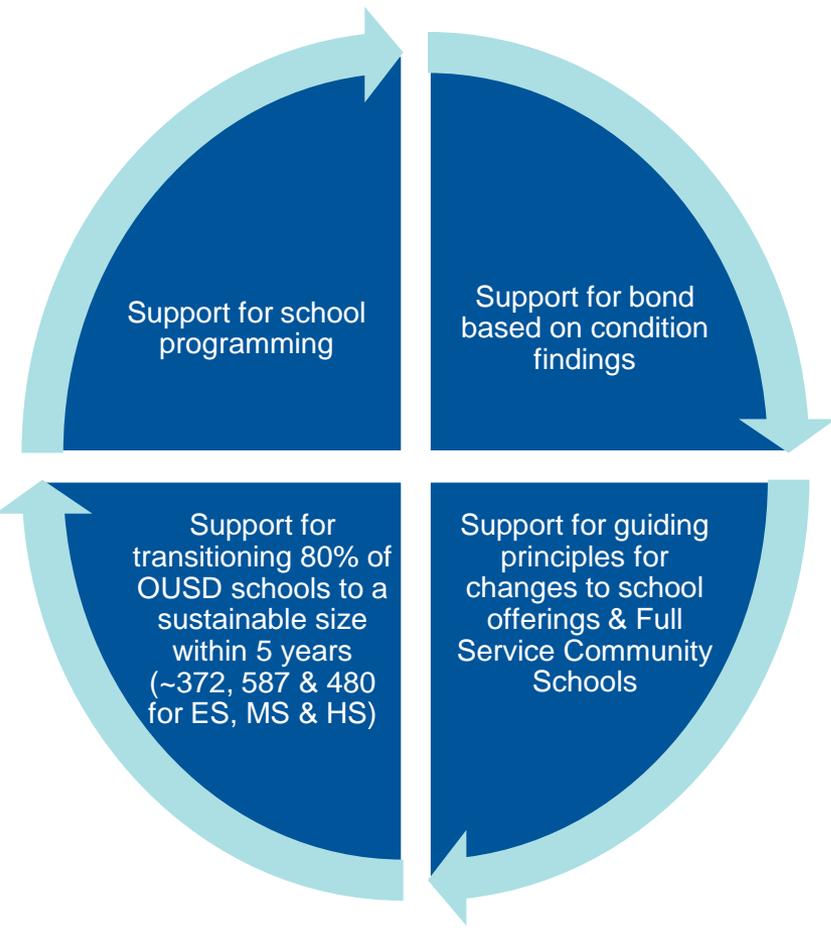


Key themes

- Equity (focused mainly on funding for and quality of staff)

December Community Dialogue Themes

Survey themes



- Develop child-centered, experiential educational models (e.g. Montessori, expeditionary learning, etc.)
- Develop “magnet” programs (e.g. Fine Arts, STEAM, Computer Science, International Baccalaureate etc.) with programmatic feeders between middle schools and high schools
- Develop dual- immersion language academies, including Spanish, Cantonese, Mandarin, French, Arabic, etc.
- Develop High School CTE (Career Technical Education) Centers
- Develop TK-8th and 6th-12th programs
- Increase number of school offerings in District
- Increase size of physically small schools to increase capacity
- Decrease size of physically large campuses to reduce enrollment and create more region-focused feeder
- Replicate successful programs that are in high demand from families

Prioritization of Seismic, Safety and Critical Repairs across Regions and Schools / Facilities

INTRODUCTION:

A condition assessment identified \$105 million worth of top priority repairs to safety and critical structural systems in OUSD facilities. When adding seismic code compliance to this figure, the total need over the next five years exceeds \$558 million. It is proposed that the following categories of safety-focused and critical repairs are implemented across District facilities to ensure the health and safety of students, staff, and community members:

-Seismic upgrades

-Priority 1 Facility Repairs / Upgrades: (Deficiencies or conditions that may directly affect the school's ability to remain open or deliver the educational curriculum. These deficiencies typically relate to building safety, code compliance, severely damaged or failing building components, and other items that require near-term correction. An example of a priority 1 deficiency is a fire alarm system replacement).

-NOTE: "Get the Lead Out": The developing abatement issue of lead-containing water fixtures and pipes is an example of a Priority 1 deficiency that was NOT accounted for in the original general facility survey but WILL be addressed through this process.

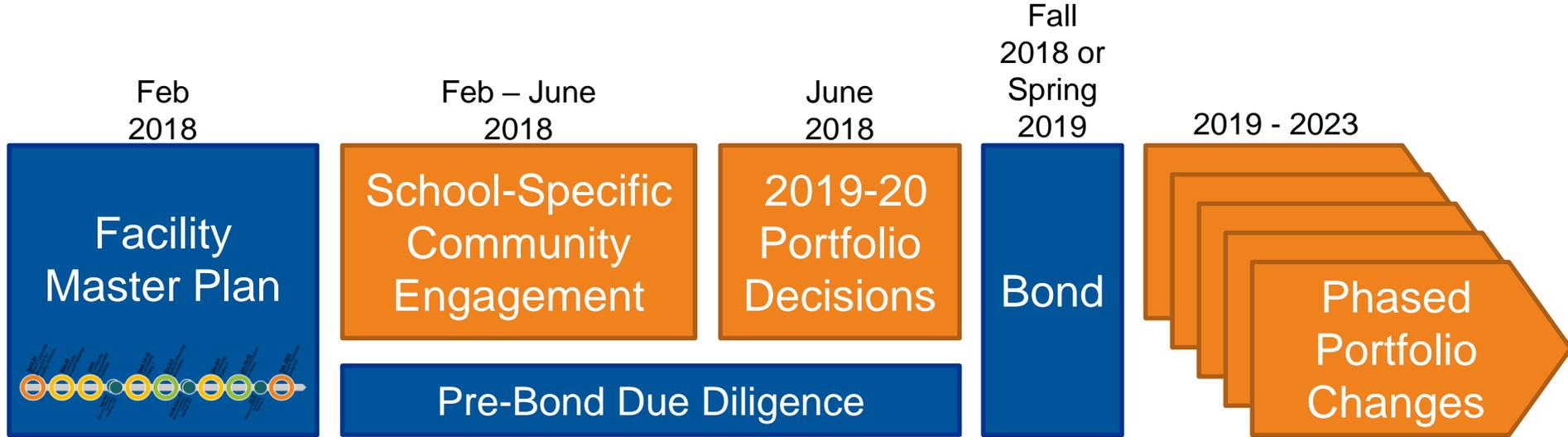
-Priority 2 Facility Repairs / Upgrades: (Items that may progress to a Priority 1 item if not addressed in the near-term. Examples of Priority 2 deficiencies include inadequate roofing that could cause deterioration of integral building systems, and conditions affecting building envelopes, such as roof and window replacement).
