**Ask of the Board** Approval of Resolution No. 2425-0129, declaring its intention to convey easement rights to

Pacific Gas and Electric Company for the purpose of installing electric vehicle charging stations at East Oakland Pride Elementary School, 8000 Birch Street, Oakland, California,

94621 (APN 40-3370-1-4).

**Background** This easement is necessary to permit PG&E to install and maintain electric vehicle charging

stations.

**Discussion** The East Oakland Pride Elementary School ("Site") was selected to participate in PG&E's

program to provide electric vehicle charging infrastructure at school facilities, which will allow the District to install three electric charging stations at the Site. The easement would allow PG&E access to the Site for maintenance and installation of the charging stations. The Board previously approved granting an easement for this purpose but it was subsequently determined that the location of the easement needed to change. The new easement

proposed would effectively replace the previously approved easement.

# DECLARING ITS INTENT TO GRANT AN EASEMENT TO PACIFIC GAS AND ELECTRIC TO ALLOW ACCESS FOR INSTALLATION AND MAINTENANCE OF ELECTRIC VEHICLE CHARGING STATIONS

WHEREAS, the Oakland Unified School District ("District") owns East Oakland Pride Elementary School property located at 8000 Birch Street, Oakland, California, 94621, and more particularly described as APN 40-3370-1-4 ("District Property"). Pacific Gas and Electric Company ("PG&E") has requested an easement on the District Property (the "Easement") for public utilities purposes, as described in the attached Exhibit 1;

**WHEREAS**, the District Property was selected by PG&E to join PG&E's Electric Vehicle Charge Schools and Parks Program ("Program");

WHEREAS, the purpose of the Program is to provide electrical vehicle charging infrastructure at school facilities and education institutions;

**WHEREAS**, as part of the District's participation in the Program, PG&E will design, construct, own, and maintain some components for the electric vehicle chargers, i.e., the Electric Vehicle Service Connection and the Electric Vehicle Supply Infrastructure, at no cost to the District;

**WHEREAS**, Education Code section 17556 *et seq.* authorizes the District to convey property to a public or private corporation engaged in the public utility business after declaring its intention to do so, and holding a properly noticed public hearing to allow for comment; and

**WHEREAS**, the Easement will replace and terminate the prior easement approved by the Board of Education of the Oakland Unified School District ("Board") on June 21, 2023, Resolution No. 2223-0218A.

#### **NOW, THEREFORE BE IT RESOLVED** by the Board as follows:

- 1. The above recitals are true and correct.
- 2. The Board expresses its intention to convey the Easement to PG&E.
- 3. The Board directs that a public hearing ("Public Hearing") to receive comments regarding the conveyance of the Easement to PG&E shall be held on May 14, 2025, beginning at 4:00 p.m., or as soon thereafter as the matter may be heard at the Great Room, La Escuelita Elementary School, located at 1060 2nd Avenue, Oakland, CA.
- 4. District staff are authorized and directed to give notice of the Public Hearing according to applicable legal requirements.
- 5. The President of the Board and the Secretary of the Board are authorized to take such actions as may be reasonably necessary to effectuate the purpose and intent of this Resolution, including execution of and recording of any related documents.

**BE IT FINALLY RESOLVED,** that the advisory committee shall present its recommendations to the Board of Education for final consideration and approval within a reasonable timeframe.

OAKLAND UNIFIED SCHOOL DISTRICT, a public body of the State of California, who acquired title as Oakland School District of Alameda County, a public school district,

hereinafter called Grantor, hereby grants to PACIFIC GAS AND ELECTRIC COMPANY, a California corporation, hereinafter called Grantee, the right from time to time to construct, reconstruct, install, inspect, maintain, replace, remove, and use facilities of the type hereinafter specified, together with a right of way therefor, within the easement area as hereinafter set forth, and also ingress thereto and egress therefrom, over and across the lands of Grantor situate in the City of Oakland, County of Alameda, State of California, described as follows:

(APN 40-3370-1-4)

The parcel of land described in the deed from Francisco Costa and Carolina Costa to Grantor dated August 17, 1920 and recorded in Book 2952 of Official Records at page 352, Alameda County Records.

The parcel of land described in the deed from S. D. Wilcox to Grantor dated August 5, 1920 and recorded in Book 2944 of Official Records at page 303, Alameda County Records.

Said facilities and easement area are described as follows:

Such underground conduits, pipes, manholes, service boxes, wires, cables, and electrical conductors; aboveground marker posts, risers, and service pedestals; underground and aboveground switches, fuses, terminals, and transformers with associated concrete pads; electric vehicle charging supply equipment, bollards and/or curbs or other associated safety equipment, associated signage; and fixtures and appurtenances necessary to any and all thereof, as Grantee deems necessary for the distribution of electric energy and communication purposes located within the strip of land of the uniform width of 10 feet, lying 5 feet on each side of the alignment of the facilities as initially installed hereunder; and the parcel of land of the width of 14 feet and length of 25 feet centered on the facilities as initially

installed hereunder. The approximate location of said facilities are shown upon Grantee's Drawing Number 31600716 attached hereto and made a part hereof.

Grantee agrees that on receiving a request in writing, it will at Grantor's expense, survey, prepare and record a "Notice of Final Description" referring to this instrument and setting forth a description of said strips of land.

Grantor further grants to Grantee the right, from time to time, to trim or to cut down any and all trees and brush now or hereafter within said easement area, and shall have the further right, from time to time, to trim and cut down trees and brush along each side of said easement area which now or hereafter in the opinion of Grantee may interfere with or be a hazard to the facilities installed hereunder, or as Grantee deems necessary to comply with applicable state or federal regulations.

Grantor shall not erect or construct any building or other structure or drill or operate any well within said easement area.

Grantor further grants to Grantee the right to assign to another public utility as defined in Section 216 of the California Public Utilities Code the right to install, inspect, maintain, replace, remove and use communications facilities within said easement area (including ingress thereto and egress therefrom).

In the event upon termination of the electric vehicle charging station contract as set forth in the terms and conditions, Grantee shall upon written demand therefor execute and deliver to Grantor a good and sufficient quitclaim of said easement and right of way or such portion thereof conveyed in this document, at Grantor's expense.

The legal description herein, or the map attached hereto, defining the location of this utility distribution easement, was prepared by Grantee pursuant to Section 8730 (c) of the Business and Professions Code.

The provisions hereof shall inure to the benefit of and bind the successors and assigns of the respective parties hereto.

In exercising its easement rights hereunder, Grantee shall not unreasonably interfere with, disrupt, or materially adversely affect Grantor's business operations or access rights at the property owned by Grantor.


