Mr. White said he was asked to look into ways to expand the goals of the agreement. The existing agreement had a \$400,000 carve-out for the \$435 million dollar bond. He said through negotiations the District is at approximately a \$20 million dollar carve-out. He said Special Facilities Council, Cate Boskoff, will talk about the negotiations

Cate Boskoff said today the District has about \$240 million left in Measure "A" and Measure "B" Bond proceeds. She said the Side Letter will not stop the negotiations but it is a way to start using the carve-out in a program geared towards local businesses and local resident hires. She said one concern is if we exempt projects from the PLA contractors from outside jurisdictions coming in trying to do the work at a more competitive price. Ms. Boskoff said the District is making the carve-out money exclusively available to local business or local hires. Another component is the reduction in the number of core employees that would be allowed. She said currently an outside contractor can use up to 10 of their own employees before they default to having to use 100% hires out of the local union hall. This would reduce the number down to five.

Chairperson Gallo clarified that the District is going from \$400 hundred thousand to \$20 million dollars in carve-outs for local residents. He asked for the timeline for acceptance from the unions and the Labor Council.

Ms. Boskoff said everyone is in agreement.

Jacqueline Minor, General Counsel, said the agreement before final Board approval will be signed by the union.

Public Comments

Darrel Carey, East Bay Small Business Council, said \$22 million is not enough. He said the whole remaining \$240 million should be put back into the local economy. Mr. Carey suggested the District implement a mentoring program so these businesses (about five) can absorb as much of the \$22 million as they can with the obligation that they will create a 100% sub utilization on these projects.

Committee Discussion

Chairperson Gallo asked when does the current PLA expire?

Ms. Boskoff said the PLA is a rolling PLA meaning as each bond measure passes the PLA rolls into the new bond. She said the PLA is always open for renegotiation.

Jacqueline Minor said the current PLA continues to roll. She said it is a negotiation with the trade unions because there is a binding enforceable contract. She said the changes being made are beneficial to our constituents and the community of Oakland. She said with direction from the Committee or the Board making clear District's expectations and needs, it supports the ability to get the changes you wanted in the PLA.

Director Spearman wanted to know if the District can implement the mentoring program and sheltering program Mr. Carey talked about?

Mr. White said currently the Local Vendor Policy is performing in excess of 40%. He said the anticipation is that the carve-out would be exclusive to Local Vendors.

Tim White said this is a proposal to the existing Joint Use Agreement between the District and the City of Oakland Parks & Recreation Department for shared use of District facilities and the use of City of Oakland facilities. The proposal made by Jane Brunner and the Life Enrichment Committee requested the District open up the majority of its facilities for public use during after school hours and on weekends. He said the Life Enrichment Committee was disappointed that the District did not accept their proposal when he reported back to them two weeks ago. The approach recommended by the committee was that each City Councilmember contact their counterpart on the Board directly and have discussions about what schools within their districts could they open. Mr. White said they discussed the issues associated with liability and custodial costs. The City thought the District could find some creative ways to absorb the liability and in terms of the cost associated with custodial services, the committee felt the District could shift custodial hours and cut back on custodial services during the day when students are in class. He said Councilmember Jean Quan said she did understand and supported meeting with the District as a legislative body and wanted to look into funding from various grants to help meet the District half way in covering the additional costs.
