Subject Verification of Closure of Early Learning and Childcare Programs on a Local Education Agency Campus

Action Authorize Board President to sign Verification of Closure of Early Learning and Childcare Programs on a Local Education Agency Campus form on behalf of LEA Governing Authority

Background & Discussion The early learning and care (“ELC”) program in the District has been closed for in-person instruction since March 16, 2020. Senate Bill No. 820 (“SB 820”) amended Education Code section 8209 to require that the Board of Education discusses in a public hearing, at some point, the ELC program closure and to prepare a plan for safely reopening the ELC program no later than when the District campuses reopens for in-person instruction.

Additionally, to continue to be reimbursed by the State even though the District’s ELC program is closed, the District must, among other things, complete and submit the Verification of Closure of Early Learning and Childcare Programs on a Local Education Agency Campus form, which requires a signature by the “LEA Governing Authority.
