Adoption by the Board Education of Resolution No. 1718-0091, Amendment No. 1, to the Grant contract No. CCTR-7009-General Child Care and Development Program from the California Department of Education for Early Childhood Education Department, increasing contract maximum reimbursement amount (MRA) from \$2,114,624.00 to \$2,368,501.00, with no change of 240 minimum days of operation, but maximum rate per child of enrollment change from \$43.31 to \$48.51, pursuant to terms and conditions thereof, if any.
