ACTION REQUESTED

Approval by the Board of Education of Resolution No. 1920-2019, Temporary Hiring Freeze – Classified Central Office Positions.

DISCUSSION

The District is currently determining appropriate classified staffing levels at school sites and central office departments for the 2020-2021 school year. Due to staffing level changes and projected restructuring of some departments, it is anticipated that reassignment and/or layoff of some classified represented positions may be required. This will necessitate a hiring freeze to facilitate the placement of employees in current vacancies who may be impacted by bumping, position reductions and/or layoffs. The freeze is limited to Central Office positions in recognition that we must ensure adequate and appropriate staffing at school sites at all times.
