This draft Plan is not just about buildings. It is about supporting students, strengthening communities, and ensuring every learning environment reflects OUSD's educational vision.

Interconnected challenges

The FMP responds to a set of interconnected challenges facing the District. Conditions including the ones illustrated below underscore the need for a more intentional, long-range approach to facilities planning.

of all OUSD facilities are rated **POOR** or **DEFICIENT**



82% of campuses were built between the 1920s & 1970s

of all OUSD facilities are rated **GOOD** on Education Adequacy

39% of all schools are **LESS THAN HALF** full

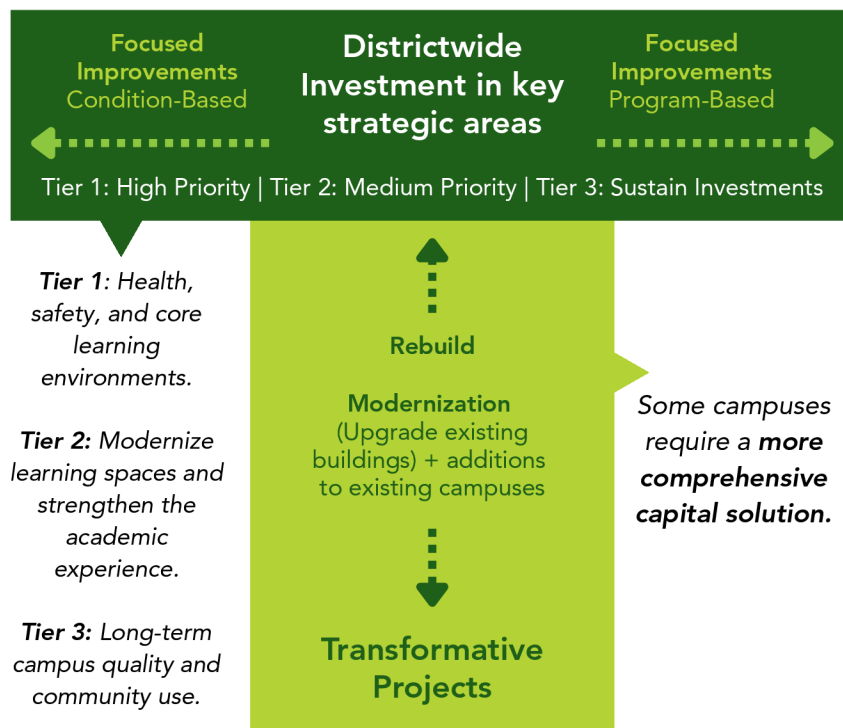

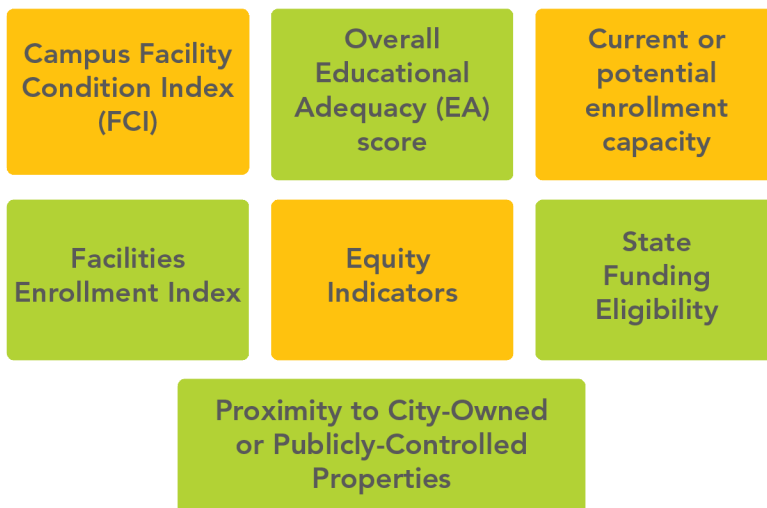
