### DISCUSSION

The Board of Education on April 25, 2012, as requested, approved Resolution No. 1112-0204, imposing a temporary hiring freeze for all classified represented positions for central office and school site services.

The District has completed the reduction and/or elimination of classified represented positions for the 2012-2013 school year due to closing schools and restructuring of some school sites and departments. Therefore, it has been determined the hiring freeze of all classified represented positions now be rescinded.
