It is recommended that the Board of Education adopt Resolution No. 1718-0163 directing the Secretary of the Board, on behalf of the Board, to cast a ballot for Subregion 7-B Regional CSBA Delegate Assembly candidates as listed in said Resolution, which is incorporated herein by reference as a though fully set forth.

BACKGROUND/DISCUSSION

As you may know, the California School Boards Association (CSBA) is a collaborative group of virtually all of the state's more than 1,000 school district and county offices of education, which advocates for and promotes the interest of K-12 children through a variety of organized means.

The Association's governance structure, in part, provides for a Delegate Assembly, elected, in part, by member school boards divided into Subregion. The Oakland Board is a member of the Association and is geographically located in Subregion 7-B (Alameda County).

Presently there are four delegates to be elected to the Delegate Assembly from Subregion 7-B of the Association for a two-year term commencing April 1, 2018. The Assembly will meet at least twice a year to conduct business and may also meet with other Delegates and Director of the Region and otherwise act in the interests of the Association.

Seven school board member candidates within CSBA Subregion 7-B have qualified to seek the office. Upon conferring with our Board's Assembly delegates – Jody London and Roseann Torres – they recommend that the Board support the following four candidates: **Amy Miller, Dublin Unified**

WHEREAS, the CALIFORNIA SCHOOL BOARDS ASSOCIATION (CSBA) is a collaborative group of virtually all of the state's more than 1,000 school districts and county offices of education which advocates for and promotes the interests of K-12 children through a variety of organized means; and

WHEREAS, the Association's governance structure, in part, provides for a Delegate Assembly, elected in part by member school boards divided into sub regions; and

WHEREAS, the Oakland Unified School District Board is a member of the Association and is geographically located in Subregion 7-B (Alameda County); and



Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly.

As a School Board member for 9 years and a Delegate for 6 years, I have a deep understanding of the issues in education. I want to continue to be involved in the advocacy work that is essential in our organization. The duties of a Delegate; which includes policy leadership, support for governance teams, and educating communities on the issues, is important. However, I am responsive to changing environments and I strive for improvement. I want to look for new and improved ways to strengthen School Boards and I will always advocate for ways in which we can provide the best education for our kids. I have attended all CSBA conferences since elected in 2008 and I have attended nearly all of the Delegate Assemblies in the last 6 years. I also completed CSBA's Masters in Governance in 2012.

Please describe your activities and involvement on your local board, community, and/or CSBA.

I have been Board President in 2011 and 2015 and Vice President in 2013 and 2017. I've been on multiple committees and task forces including the Strategic Planning committees, Youth Master Plan, Economic Vitality committee, and the Hacienda Housing Development Task Force. I have also been on the Special Education LPA Board for the past 4 years and our Liaison committee with the City of Pleasanton. I have been on the Tri-Valley Education Collaborative for the past 5 years. I have had a wealth of community involvement including being on the Pleasanton Library Commission for 8 years, the Tri-Valley YMCA Board of Managers for 3 years, and a Girl Scout summer camp leader for 5 years. My education includes a B.S. degree in Health Science (Cal State Northridge) and a M.B.A. degree (Cal Lutheran University). I completed the CSBA Masters in Governance in 2012.

What do you see as the biggest challenge facing governing boards and how can CSBA help address it?

The biggest challenge facing school districts in California is the lack of adequate funding. CSBA should continue advocating for increased funding for our students. We, as School Board members, cannot provide the high quality education our students deserve without addressing the serious shortfalls we continue to have. I also believe that LCFF should address our special education costs. Included in this challenge is the increase in pension costs that all districts will be facing. CSBA can be involved in addressing this issue at the state level and advocating that this financial burden is unreasonable for school districts. Another challenge is the Prop 51 state facilities bond. The dollars need to be released in a timely manner so that districts can receive the funds necessary to build and/or modernize their facilities. In addition, advocating for additional future state bonds is also important. Another challenge is the work of School Boards themselves and how CSBA can be a part of improving and strengthening School Boards. In order to govern effectively, CSBA can assist in providing tools and resources that will enable Boards to better serve their students.
