RESOLUTION NO. 1718-0064

**REGARDING THE ALLOCATION OF MEASURE G1 PARCEL TAX REVENUE TO COUNTY
AUTHORIZED CHARTER SCHOOLS**

WHEREAS, the Oakland Unified School District (“District”) Board of Education on January 25, 2017, adopted Resolution No. 1617-0119 (Legislative File No. 17-0127, Enactment No. 17-0155) creating the Measure G1 – Districtwide Teacher Retention and Middle School Improvement Act Oversight Commission (“G1 Commission”); and,

WHEREAS, in the process of allocating Measure G1 parcel tax dollars, the G1 Commission has requested further clarification on whether or not county-authorized charter schools are included in the parcel tax revenue allocation methodology,

NOW, THEREFORE, BE IT RESOLVED that:

1) Measure G1 funds shall be allocated to:

(a) any district school or charter school within the District serving grades 6, 7, or 8, regardless of whether the school serves grades in addition to those grades, and

b) to all county-authorized charter schools formed prior to the date of the passage of the Teacher Retention and Middle School Act or Measure G1 on November 4, 2016.

2) All schools receiving G1 funds will be subject to the same application, oversight and audit requirements.

3) The Board of Education will convene a stakeholder group during school year 2017/2018 to collaborate with appropriate district and charter school stakeholders as well as the Alameda County Board of Education to discuss charter school governance, charter school authorization, student enrollment, and **eligibility of future county-authorized charter schools**. This group will bring back findings and recommendations no later than June 30, 2018.
