

Overview of Special Education – What is Special Education?


There are 13 eligibility categories

- Autism
- Deaf / Blind
- Deafness
- Emotional Disturbance
- Hearing Impairment
- Mental Retardation changed to "Intellectual Disabilities"

- Multiple Disabilities
- Orthopedic Impairment
- Other Health Impairment
- Specific Learning Disability
- Speech or Language Impairment
- Traumatic Brain Injury
- Visual Impairment including blindness

Overview of Special Education – Percentage of students by disability type

Students with Disabilities enrollment by disability type as of May 2012*



Specific Learning Disability – 41% Speech Impairment – 23% Mental Disability – 10% Autism – 9% Emotional Disturbance – 6% Other – 11%


*Grades K-12 enrollment & OUSD K-12 schools only.

This pie chart represents the five largest categories of disability for OUSD students.

- Autism affects 9% of all students with disabilities, and is the fastest growing group.
- "Other" (including the remaining 8 disability categories combined) makes up 11% of all Students with Disabilities

Overview of Special Education – Students in Non-Public Schools (NPS)


Approximately 250 Students in Non-Public Schools

2010-11 Cohort Graduation Rate & Dropout Rate



Key Data: Students Receiving Special Education

African American Males

16% of overall OUSD K-12 population (2011-12)

32% of students identified with disabilities

Latino Males

20% of overall OUSD K-12 population (2011-12)

23% of students identified with disabilities

Asian Males

8% of overall OUSD K-12 population (2011-12)

7% of students identified with disabilities

White Males

5% of overall OUSD K-12 population (2011-12)

2% of students identified with disabilities

Overview of Special Education – Current Structural and Process Improvements

Assessment Planning Team

 Enables school site teams to consider general education options and to look closely at the profile of each student before testing for special education eligibility

Child Find Brochure

 Enables compliance with law and provides information to anyone who believes a child may qualify for special education services

Independent Educational Evaluation Policy

 Updated old policy to align with current law and built in cost-containment measures


Alternative Dispute Resolution Program

 Allows parties to use a non-adversarial free service to resolve issues and complaints before filing for due process

• Improved Personnel Management for Special Education

Enable sites to have more control and ownership of their program




- Ensure that all eligible students who receive special education services graduate college and career ready or ready for financial independence




