BACKGROUND/DISCUSSION:

As you may know, the California School Boards Association (CSBA) is a collaborative group of virtually all of the state's more than 1,000 school district and county offices of education which advocates for and promotes the interest of K-12 children through a variety of organized means.

The Association's governance structure, in part, provides for a Delegate Assembly, elected, in part by member school boards divided into sub regions. The Oakland Board is a member of the Association and is geographically located in Subregion 7-B (Alameda County).

Presently there are four delegates to be elected to the Delegate Assembly from Subregion 7-B of the Association for a two year term commencing April 1, 2012. The Assembly will meet at least twice a year to conduct business and may also meet with other Delegates and Director with the Region and otherwise act in the interests of the Association.

Four school board member candidates within CSBA Subregion 7-B have qualified to seek the office. Each candidate is personally known to me. I believe that each candidate will personally serve the interests of the Oakland Board and well represent the subregion as a whole if elected to the Delegate Assembly.





Enclosed is the ballot material for election of a representative to the CSBA Delegate Assembly from your region or subregion. The material consists of the ballot (on red paper), required candidate biographical sketch form, and if submitted, résumé for each candidate. In addition, we are including a “copy” of the ballot on white paper so that it may be included in board agenda packets, if you choose to do so. **Only the ballot on red paper is to be completed and returned.**

The board as a whole may vote for up to the number of vacancies in the region or subregion as indicated on the ballot. For example, if there are three vacancies in the region or subregion, the board may vote for up to three individuals. Regardless of the number of vacancies, each board may cast no more than one vote for any one candidate. (The ballot also contains a provision for write-in candidates; their name and district must be clearly printed in the space provided.)

The ballot must be signed by the Superintendent or board clerk and returned in the enclosed envelope; if the envelope is misplaced, you may use your district’s stationery; please write **DELEGATE ELECTION** prominently on the envelope with the region or subregion number on the bottom left corner. **Ballots must be postmarked by the U.S. Post Office on or before Thursday, March 15. No exceptions are allowed.**

Election results will be available no later than Monday, April 2. If there is a tie vote, a run-off election will be held. All re-elected and newly elected Delegates will serve two-year terms beginning April 1, 2012 – March 31, 2014. The next meeting of the Delegate Assembly is on Saturday, May 19 – Sunday, May 20 at the Hyatt Regency in Sacramento.

1. Adequate funding for education. CSBA must continue to lead/push the conversation about the importance of public education, the resources needed to move California into a leadership position in education, and the value to be gained by our entire state through well educated students prepared for future leadership.
2. Change to 55% for approval of parcel taxes. It is undemocratic for a minority of voters to block the majority.
3. CSBA should continue to advocate nationally against one size fits all. We must have reasonable flexibility within our state. We also need federal programs to be flexible enough to work not only among different states but differing populations and geographic realities.



CSBA's Delegate Assembly sets the general education policy direction for the Association. As a member of the Delegate Assembly, please describe what your top three educational priorities would be, and why they are important to the Association.

FUNDING - Rather than merely restore funding with a goal of adequacy, CSBA should not rest until California students are funded among the top five states in the country.

TEACHER QUALITY - We must assure that graduates of CA credential programs are able to meet the needs of our diverse student population in this world of 21st century technology. State laws surrounding both granting "tenure" and releasing permanent teachers must be revised to suit the needs of our students. CSBA should lead efforts to update components of teacher evaluation to include measures of student achievement and professional leadership.

CHARTER SCHOOLS - Few educators would avoid competition with charter schools IF the playing field were level. Charters should be required to state their goals and be held accountable for meeting them. As leaders of state agencies, charter officers should be held accountable for following conflict of interest statutes as well as the Brown Act. Business practices of charter schools should be exemplary and their boards held accountable.

Another responsibility of Delegates is to communicate the interests of local boards to CSBA's Board of Directors, Executive Committee and staff. Please describe your activities/involvement or interests in your local district or county office.

I am an active member of the Livermore Chamber of Commerce and attend the Economic Development - Government Affairs Committee as well as the Hispanic Committee. Frequently I have been appointed to the Livermore Inter-Agency Committee including two members each from the City Council, the Park District Board and the School Board and the chief administrator from each agency. Topics of common interest run the gamut from the State Budget impacts to returning the Livermore Fourth of July celebration and placement of trees at our schools. For several years, I have been appointed to our Tri-Valley TEC group. TEC, our 20 year old career-ed consortium, includes three K-12 districts and Las Positas Community College, as well as business members, representatives from the Lawrence Laboratory and California State University East Bay. For many years I have attended planning meetings at Marilyn Avenue School, formerly a PI school, which continues to improve. Through these connections I am knowledgeable about many of the topics which confront CSBA and can bring a local perspective to problems which will come before the Delegate Assembly.

Why are you interested in becoming a Delegate and what contribution do you feel you would make as a member of the Delegate Assembly?

A strength of CSBA is having the capacity to thoughtfully reinvent itself while continuing to carry out its traditional responsibilities in an every-improving way. My experience as a member of 15 governance teams has shown me that boards come in many varieties. I will be useful as CSBA evaluates our board training to serve members of the many different styles of boards. As a 12 year observer and participant in Delegate Assembly I have seen problems arise. Many of the fixes have worked well, like the computer generated clock to time speakers. Some are works in progress. Jill has spoken about overhauling the Policy Platform process. As a member of the Nominating Committee and as chairman in 2005, the Committee and I became aware of several problems with the process.
