Dear Site and District Administrator:

It is time for the posting, as required by state law, of the Annual Notice of the Board of Education's Public Hearing on the Sufficiency of Textbooks and Instructional Materials for pupils of the District.

The Board of Education at its Regular Meeting on October 12, 2011, at approximately 7:00 P.M., being held this year in the Auditorium, Castlemont High School, 8601 MacArthur Boulevard, Oakland, CA 94605, will hold the District's annual hearing to take testimony from pupils, parents, and staff as to whether the District has sufficiently provided required textbooks and/or instructional materials to pupils at your site and each and every site in the District as of the end of the eight week of school. If "Yes", the Board will be able to so certify. If "No" then the Board must determine said shortages and how the shortages are going to be immediately made up.

Appropriate Instructional and Support staff, with your assistance, has completed the current school year's sufficiency of textbooks and instructional materials survey at your site, produced a proposed District-wide report, determination and finding for consideration by the Board at the October 12, 2011 Meeting. For ten calendar days - beginning Sunday, October 2, 2011 - prior to the Board Meeting of October 12, 2011, the District is required to give Notice of the Public Hearing on the adequacy of textbooks and instructional materials, of the availability of the preliminary report that the Board will consider at the hearing, by posting a Notice of the Hearing at your school site in the major language or languages of your pupil, parent population; in the Oakland Tribune and on the web. (The Notice, preliminary or proposed report will be on the web by Saturday mid-night at <http://publicportal.ousd.k12.ca.us/19941081819255553/site/default.asp>.) The Notice is required to remain posted through October 12, 2011.

I am asking your help, as chief administrator of your site, in assisting the District to meet the legal obligation of Notice by requesting that you post the attached Notice in as many languages as may be spoken, written by your site student population and/or parents, guardians or custodians of pupils or employees, so that each may become aware of the hearing and participate therein, if desired, which will help the Board make the appropriate decision. (You are not required to reproduce the document to send home by pupils but only to post the notice at the site in an accessible, visible location so that visitors, pupils and staff may read it.)

The benefit to the District, among others, is twofold: one, by Noticing this hearing as required by law, it will help the Board determine if additional textbooks and instructional materials are needed for pupils, notwithstanding the extraordinary efforts made by you and other staff to have sufficient textbooks and materials on hand, at your site and every school site, school day one; and secondly, by carrying out

the legal, procedural requirements, such as compliance with this posting of Notice request, the District acts prudently to insure that the textbook and instructional materials monies currently available from the state for our students is not withheld because the District did not post the Notice, hold the hearing and make the findings as prescribed by state law, i.e., Education Code Section 60619, on or before the eighth week of school.

I know that this posting request is one more administrative task that you are being asked to do but it is a requirement for the benefit of those we serve - our pupils. Would you please post - today - and by return e-mail, i.e., reply, confirm that you have posted the Notice? Your response will serve as part of the evidence that the District has complied with legal requirements by taking appropriate steps to remedy any late discovery of shortages of pupil textbooks or instructional materials and that the District is entitled to its appropriated state textbook and instructional materials funds to educate our pupils (and not have to return such funds because District did not take necessary steps, including noticing and conducting this hearing, to insure it students have said textbooks and materials).

We had a great response, which was very much appreciated, from you last year confirming the posting. The Board, Superintendent Smith, his deputies and I thank you in advance for your prompt, positive honoring of this request to post the required Notice and give return notice thereof.

Đối với những ai quan tâm, xin lưu ý rằng vào ngày 12 tháng 10, 2011, học khu Thống nhất Oakland, ở một buổi họp thường kỳ của Hội đồng Giáo dục, sẽ tổ chức một buổi điều trần công khai về việc thấy có đủ Sách giáo khoa hay Tài liệu giảng dạy cho năm học 2011-2012.

Buổi điều trần công khai sẽ được tổ chức ngày 12 tháng 10, 2011 lúc 7:00 p.m., hay sớm nhất ngay sau đó, trong Hội trường của Castlemont High School, 8601 MacArthur Boulevard, Oakland, CA 94605. Mục đích của buổi điều trần là để Hội đồng quyết định bằng văn bản coi xem mỗi học sinh ở mỗi trường trong Học khu có đủ sách giáo khoa hay tài liệu giảng dạy hay cả hai thứ, ăn khớp với tiêu chuẩn nội dung áp dụng theo Đạo luật Giáo dục Đoạn 60605 trong mỗi môn thích hợp sau đây, vốn phù hợp với nội dung và chu kỳ khung học trình mà Hội đồng Giáo dục Tiểu bang áp dụng.

Toán; Khoa học; Lịch sử-Khoa học xã hội; và Anh ngữ-Ngữ văn, bao gồm phần phát triển Anh ngữ của chương trình được áp dụng.

Ở buổi họp Hội đồng sẽ quyết định bằng văn bản coi xem mỗi học sinh ghi danh môn ngoại ngữ hay khóa học y tế, nếu được, có đủ sách giáo khoa hay tài liệu giảng dạy phù hợp với nội dung và chu kỳ của khung học trình mà Hội đồng Giáo dục tiểu bang áp dụng cho những môn đó. Ở buổi họp, Hội đồng sẽ còn quyết định bằng văn bản cung cấp thiết bị phòng thí nghiệm khoa học cho các lớp học thí nghiệm khoa học, từ lớp 9 tới lớp 12.
