Honoring Marcus Board, Painter, Department of Buildings and Grounds, as 2014 State of California Classified Employee of the Year In Maintenance, Operations and Facilities

WHEREAS, the goal of the State of California Classified School Employee of the Year (CSEY) Program is to highlight contributions of classified school employees who support the education of California's public school students in preschool through grade twelve, and

WHEREAS, the overall purpose of the CSEY Program is to pay tribute to the tireless efforts of our state's outstanding classified school employees as vital staff members who play key roles in creating a school environment that promotes student achievement, safety, and health, and

WHEREAS, the CSEY selection process identifies only six 2014 Classified School Employee of the Year awardees statewide, one each from the categories of: Child Nutrition, Maintenance, Operations, & Facilities, Office and Technical, Para-Educator & Instructional Assistance, Support Services & Security, and Transportation, and,

WHEREAS, Marcus Board was nominated to the County of Alameda for advancement to State candidacy for recognition in the category of Maintenance, Operations & Facilities by leaders of his department, and,

WHEREAS, Marcus Board is described by his department leaders as: "[possessing] a passion for his job. He is well-known throughout the Building and Grounds Department for his compassion and his energy. A highly skilled craftsman, his high ethical standards and vast experience enable him to be an excellent mentor to his colleagues and to the students who intern during the summer," and,

WHEREAS, his nomination further states: "Last year, Mr. Board was called upon to temporarily step in as shop manager and provided a comfortable and open environment for his coworkers. He worked hard, often coming in early and staying late to ensure the work was properly completed and on time. He possesses wisdom beyond his years and knows how to motivate people. He exudes warmth, humility, and compassion and always expresses appreciation to others for their efforts," and,

WHEREAS, Mr. Board was duly advanced by the County of Alameda to candidacy for State-level recognition, was selected, and was celebrated and honored as the 2014 State of California Classified Employee of the Year In Maintenance, Operations and Facilities by State Superintendent of Schools Tom Torlakson and the State Department of Education during Classified School Employees week, May 19-23, 2014,

NOW, THEREFORE, BE IT RESOLVED that the Board of Education and the Superintendent of the Oakland Unified School District salute Marcus Board for stellar service to the students and City of Oakland and for bringing statewide recognition to the excellence of the District's classified workforce.
