Subject Resolution - SELPA Local Plan Update - Transition and Agency Agreements - Special Education Department

Action Requested Approval by the Board of Education of Resolution No. 1920-0233 Adopting a Policy Regarding Interagency Coordination to Ensure Students with Disabilities Have Access to Transition and Related Services.

Background and Discussion This resolution is required as a provision of the SELPA Local Plan for Oakland Unified School District SELPA. The OUSD SELPA, pursuant to section 56195 of the California Education Code, has the responsibility to adopt a plan (in accordance with California Education Code 56200) to assure that special education and services for all eligible individuals with disabilities residing in the geographic area served by OUSD SELPA are delivered. Specific resolutions are called for as a part of that plan that do not currently exist within OUSD Board Policy. SELPA policy requires that the body governing OUSD SELPA is the Oakland Unified Board of Education, which must adopt SELPA policies when additions or adaptations become necessary.

The District engages with other agencies to ensure students with disabilities have access to appropriate transition and related services, that interagency agreements or other mechanisms for interagency coordination are in effect to ensure services required for free appropriate public education are provided, including the continuation of services during an interagency dispute resolution process. The Special Education/SELPA Director will serve as the liaison to the Regional Center, California Children's Services and other private and public agencies to coordinate services for students with disabilities.

Adopting and Complying With Requirements for Specific Resolutions that are Necessary for the Special Education Local Plan Area’s (“SELPA”) Policy Regarding Interagency Coordination to Ensure Students with Disabilities Have Access to Transition and Related Services

WHEREAS, Education Code section 56195.5 prescribes that the district governing board shall have authority over the programs it directly maintains, consistent with the local plan submitted pursuant to 56195.1; and

WHEREAS, Oakland Unified School District (“OUSD”) is a single-district Special Education Local Plan Area (“SELPA”); and

WHEREAS, Oakland Unified School District’s Governing Board has authority over the programs provided through the OUSD SELPA; and

WHEREAS, pursuant to Education Code section 56195, the OUSD SELPA has the responsibility to adopt a plan in accordance with Education Code section 56200 to assure that special education and services for all individuals residing in the geographical area served by the OUSD SELPA are delivered; and

WHEREAS, policies governing OUSD SELPA shall be adopted by the OUSD Board of Education (“Board”); and

WHEREAS, pursuant to Education Code section 56122 and 56205(a), OUSD SELPA Local Plan must ensure conformity with Title 20 United States Code (USC) and Title 34 Code of Federal Regulations Section 300.201 and identify whether or not for each of 23 areas the SELPA has a specific written policy or a specific board adopted resolution where the policy can be found,

NOW, THEREFORE, BE IT RESOLVED, that the Board acknowledges that the OUSD SELPA must have a written policy confirming that the SELPA engages with other agencies to ensure students with disabilities have access to appropriate transition and related services;

BE IT FURTHER RESOLVED, the Board delegates the SELPA Director to serve as the liaison between OUSD SELPA and other agencies to develop mechanisms and processes for interagency coordination;

BE IT FURTHER RESOLVED, that the Board hereby adopts the following SELPA policy: “Interagency agreements or other mechanisms for interagency coordination are in effect to ensure services required


