Discussion:

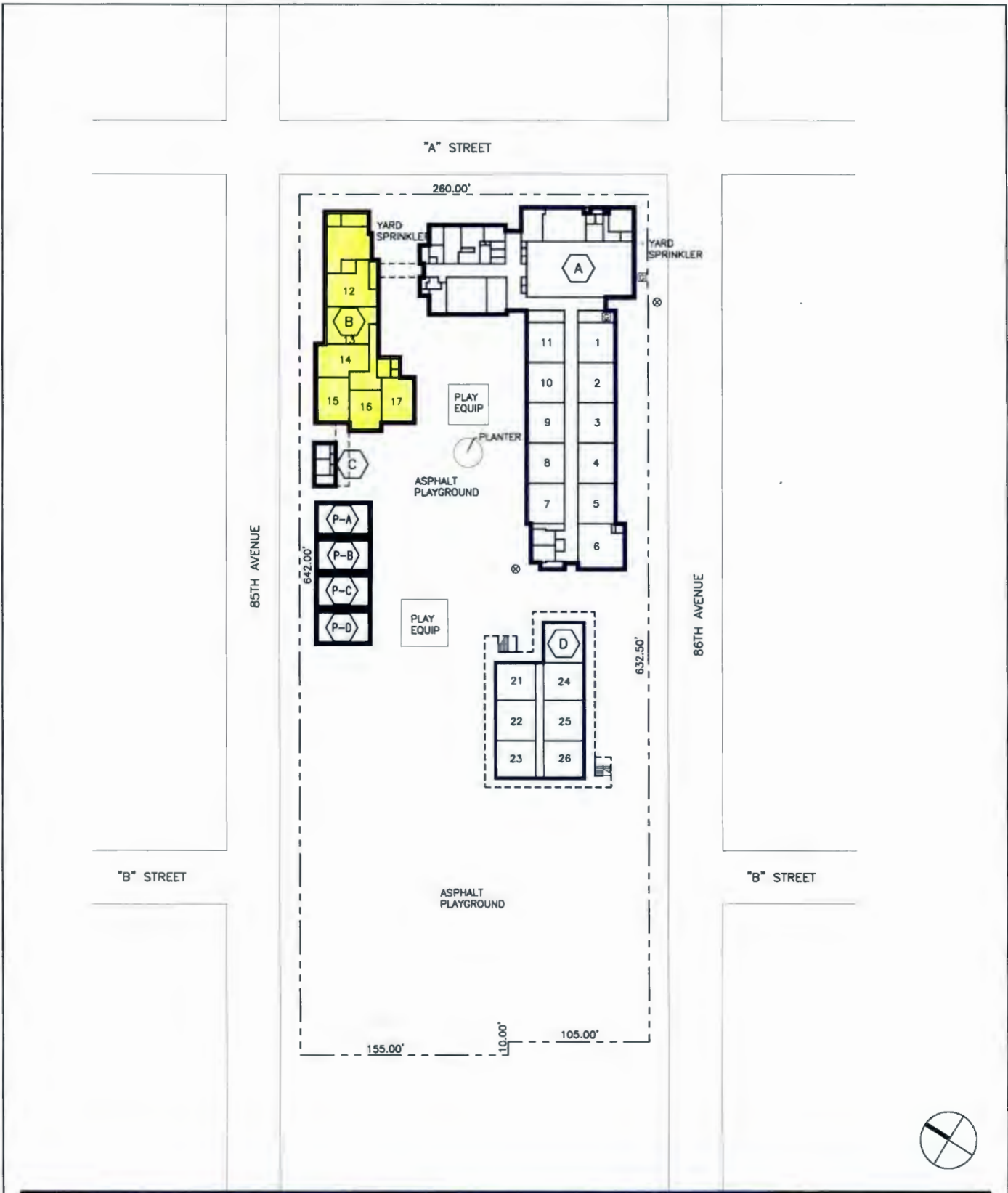
