Ask of the Board Adoption by the Board of Education of Resolution No. 2021-0128A - Extending Date to Present Analysis of Cohorts 1 and 2

Background The Board of Education (“Board”) approved Resolution No. 2021-0128 - Advancing District’s Citywide Plan Work on or about December 9, 2020. This resolution states, in relevant part, that the Superintendent shall “[b]y April 2021, present the Board with an analysis of the impact—to school quality and to District finances—of the school expansions, redesigns, mergers, and closure from Cohorts 1 and 2.”

Discussion In order to provide District staff with additional time to conduct the analysis and in order to provide additional opportunities for District staff to meet separately with Board members, Resolution No. 2021-0128A – Extending Date to Present Analysis of Cohorts 1 and 2 would modify Resolution No. 2021-0128 to extend the date by which the analysis of Cohorts 1 and 2 would be presented from “April 2021” to “no later than May 15, 2021.”
