The following conditions apply:

- The grant award will be processed upon receipt of the signed Grant Award Notification (AO-400). This AO-400 must be signed by the superintendent or an authorized official and returned within 10 working days.
- 2. All approved program funds must be expended within the dates designated and for the maximum amount indicated on the AO-400. Encumbrances may be made at any time after the beginning date of the grant stated on the AO-400. Expenditures must be completed by **June 1, 2027**. **No extensions of this grant will be allowed**.
- 3. The grantee is required to use these funds to plan for, start, or expand a Middle College High School, Early College High School, or approved program as described in the grant application along with any required or requested changes. Prior written approval is required for any program or budget changes. Line item transfers in excess of 25 percent of each original line item budget amount may not be made without written approval from the High School Innovations and Initiatives Office (HSIIO). These funds may not supplant current fixed costs. Expenditures shall comply with all applicable provisions for federal, state, and local rules, regulations, and policies relating to the administration and accounting for public school funds.
- 4. The grantee must limit administrative indirect costs to the rate approved by the California Department of Education (CDE) for the applicable fiscal year in which the funds are spent.
- 5. Upon receipt of the required certifications, scheduled payments of grant funds will be as follows:
 - Ninety percent of the funds will be released upon completion and return of the AO-400. Please allow approximately four weeks for processing.
 - The final 10 percent of the funds will be released after the End-of-Project (EOP) Expenditure Report and all reporting and submission requirements have been received.
 - The EOP Expenditure Report is due June 15, 2027, after all funds have been expended. The EOP includes a narrative of expenditures. Failure to submit a final EOP Expenditure Report with a budget narrative within 60 days of the end of the grant period will result in a billing from the CDE for the entire amount of any grant funds paid and possible reduction of any subsequent years' grant(s).
- 6. The Baseline Data Report is a requirement of this grant and is due October 2, 2023. The Mid-Project Report and Mid-Project Expenditure Report are requirements of this grant and are due June 15, 2024. The End-of-Project Report is a requirement of this grant and is due June 15, 2027. Guidelines will be mailed separately.
- 7. The CDE has partnered with the California Coalition for Early and Middle College to provide technical assistance to all grantees through a generous grant received from the College Futures Foundation. The CDE strongly encourages all grantees to participate in technical assistance and capacity building support.
- 8. If the grantee or the CDE terminates the grantee's participation in the program, the grantee shall submit a final expenditure report within 30 days and return the unexpended funds upon receipt of a billing from the CDE. Supplies and equipment purchased with these funds will be redirected to other programs.

Mission and Vision Gateway to College is an innovative alternative high school that serves some of our most vulnerable students who need something different. As a part of our High School and Alternative Education Network, Gateway to College provides a unique opportunity for students to re-engage, get back on track, and pursue their high school diploma by taking college courses at Laney while earning early college credit. Our main goal is to develop Gateway to College students' collegiate identity with the intention of building their confidence and necessary social capital to succeed in the contemporary marketplace and more importantly for their own lives. Structure At Gateway, dual enrollment is not only enrichment for some students, it is at the core of their programming and model. We provide comprehensive holistic and academic support through intensive case management. Gateway to College Resource Specialists/Success Coaches have a cohort of students that they support with acclimating to the Laney College environment through personal guidance and peer mentoring while assisting students to complete their high school diploma and earn early college credit to prepare them for community college certifications, an AA degree, and beyond. Student Population According to our most recent demographic data, our 2022-23 student population (n = 64). - The student body is comprised of: 57.8% male students and 42.2% female students; - The student body is comprised of: 87.5% 12th-grade students, 6.3% 11th-grade students, 3.1% 10th-grade students, and 3.1% 9th-grade students - The student body is comprised of: 40.6% Latino students, 23.4% African American students, 12.5% White students, 10.9% Not Reported, and 4.7% students from Multiple Ethnicities; - 90.6% of students qualify for Free and Reduced Lunch; - 4.6% of students are classified as English Language Learners; - 7.8% of students are in Special Education; - 1.6% of students are classified as Homeless; and - 1.6% of students are classified as in Foster Care.

Collaboration Relationship Between High School and College Embedded into and as part of the Peralta Community College District and Laney College, Gateway to College is close collaboration and supported by the infrastructure of both the Peralta and Laney. Gateway to College students are all eligible for the full host of resources and services that Peralta and Laney have to provide. Moreover, Gateway to College at Laney's high school program is supported by Oakland Unified School District (OUSD) via MOU and is part of OUSD's High School Network and Alternative Education Network. Collaboration Relationship Between High School and Families Our Success Coaches and K-12 Pathway Specialist work closely with families to support student success. We communicate regularly with families via email, text, and phone. Moreover, the K-12 Pathway Specialist also conducts more in-depth, higher-tier

interventions which include home visits. Collaboration Relationship Between Community Gateway continues to partner with community-based organizations. Most notably, we have partnered with Laos Family Community Development Inc. to provide Work-Based Learning experiences (e.g. resume workshops, mock interviews, etc.) to our Gateway to College students. Collaboration Relationship Between Industry Partners Gateway to College's relationship with industry partners is embedded within the Laney College infrastructure. Laney has robust CTE programming, including Machine Technology, Carpentry, Cosmetology, Culinary, and much more. As such, many of our industry partnerships occur through our CTE programs. Furthermore, we are in close collaboration with the OUSD Linked Learning Office. We are currently building out a signature partnership with BayWorks which focuses on Bay Area Water/Wastewater Workforce. With our team from Laney College, OUSD, and Gateway to College, we will build more bridges to industries that our Gateway students are pursuing or wish to pursue.

Gateway to College's guided pathways programming is structured according to the Linked Learning model which includes four pillars: Rigorous Academics, Career Technical Education, Work-Based Learning, and Personalized Student Supports which are continually building and refining. Rigorous Academics and Career Technical Education At Gateway, dual enrollment is not only enrichment for some students, it is at the core of the programming and model. As such, students' academic loads are completely comprised of Laney College courses. Their elective schedule serves as the primary vehicle for CTE program participation. Currently, we are in collaboration with our Vocational Technology Coordinator at Laney and will continue to build deeper and more focused CTE pathways. As such, we have selected Machine Technology, Carpentry, and Cosmetology as our areas of focus for now. We will continue to survey and gauge our ever-changing student population to best meet their needs and postsecondary goals. Work-Based Learning we continually have guest speakers from a variety of industries visit our school-wide assemblies to share their personal and professional stories and work. Lastly, we bring students on a variety of College Exploration Visits to local four-year universities (e.g. UC Santa Cruz, UC Berkeley, etc.) and we plan on conducting Career Exploration Visits locally. We are currently in partnership with partners and CBOs to provide more robust Work-Based Learning experiences. This spring semester we plan on hosting a resume workshop with Laos Family Community Development Inc., an Oakland-based organization that provides high-quality resources and services to Oakland's youth. Personalized Student Supports We provide comprehensive holistic and academic support through intensive case management. Our team of Resource Specialists/Success Coaches) provide case management, and personal guidance, and facilitate peer mentoring, so that students can complete their high school diploma and earn early college credit to prepare them for community college certifications, an AA degree, and beyond -- to identify and pursue their academic and professional goals. Additionally, we support students in resourcing and financing their academic and professional journeys through leveraging Laney College resources and opportunities, national and local scholarships, and Federal Student Aid (FAFSA application process).

At Gateway to College at Laney, dual enrollment is at the core of the programming and model. Student class schedules are comprised entirely of community college courses that count towards their high school diploma and college. By the design of the Gateway to College national model and our network, dual enrollment is the backbone of the program. Most notably, for English and Math which are in high demand, we recruit engaging, committed, and approachable staff and faculty that are more "high-school friendly" to ensure high academic expectations and high-quality instruction and support. Lastly, we provide comprehensive holistic and academic support through intensive case management via our

success coaches and our embedded math and writing tutors. Currently, we also have a 6-12 grade math specialist on our team who supports the students, the math college instructor, and the program overall with engaging curriculum and instruction methodologies. Lastly, we have a deep partnership with Laney's Math and Writing centers which provide learning lab spaces and additional tutoring.

Should the MCES grant be awarded to Gateway to College, the funding will be nested in an already rich ecosystem of support. We plan to leverage our existing partnership with the Peralta Community College District and Laney College, where Gateway to College sits institutionally to build even more robust programming options where more Oakland youth experience college while still in high school. Most recently, Oakland passed a ballot measure to continue funding Linked Learning pathways in Oakland, formerly known as Measure N and now known as Measure H. Gateway will continue to build out our Link Learning pathway and pursue Silver Certification through the Linked Learning Alliance, and apply for additional funding to support our pathway and dual enrollment work--including Measure N/H.
