If the school district has a negative certification pursuant to Section 42131, the county superintendent of schools, in consultation with the Superintendent, shall take at least one of the actions described in paragraphs (1) to (5), inclusive, and all actions that are necessary to ensure that the school district meets its financial obligations and shall make a report to the Superintendent and the president of the state board or the president's designee about the financial condition of the school district and remedial actions proposed by the county superintendent of schools.

Background for the Current Action

Fiscal distress

A Negative Certification means the district will be **UNABLE** to meet financial obligations in the next years.

Without significant intervention, the district is projected to **run out of cash** during the 2025-26 school year.

Deferred decision-making

Many plans have been made, and many lessons have been learned.

Living "paycheck to paycheck" has exhausted resources, families, and staff.

Risk to Local Control

June ends the narrow window for OUSD to complete the 3Rs:
Re-envision, Redesign,
& Restructuring process.

The **best action** is for the **OUSD Board to lead**Re-envisioning decisions for the next generation of Oakland students.

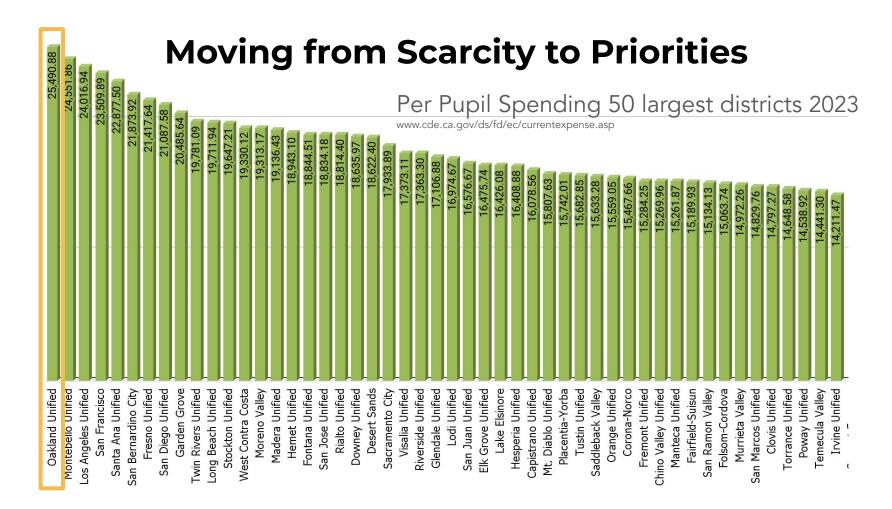

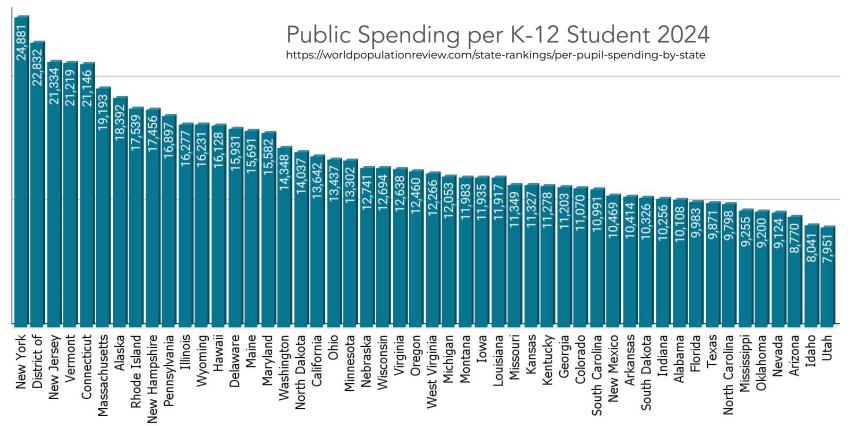

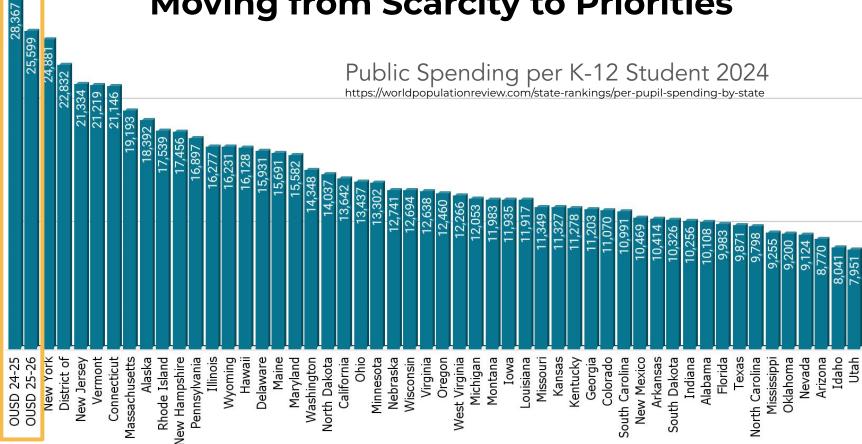

Intervention Plan

Why? Support OUSD's Board to make local decisions about the district's future

What? Provide the Board with staff, structures, and technical support to:

- 1. **Engage with each other and the community to identify and approve actionable priorities** for OUSD schools responsive to AB1912 process. (Feb-Mar)
- 2. Refer approved priorities to staff for the development of footprint and change management plans. (April)
- Lead community engagement to understand the footprint plan and implement change management plans. (May)
- 4. **Approve footprint and change management plans**, as well as adopt multi-year budget and accountability plans incorporating these proposals. (Jun)
- 5. Streamline and focus Board work to complete 3Rs efforts necessary to meet fiscal obligations. (Ongoing)

Advisory Team Role

Why? Support OUSD's Board to connect resources to priorities

What? The responsibilities of the Advisory Team include, but are not limited to:

- Support the Board to finalize a Re-envisioning plan that enables the district to meet its future obligations, both for educational equity and economic viability by the end of 3Rs timeline of June 2025.
- Support the Board to streamline and focus Board time and decision-making in service of the 3Rs process.
- Add capacity, process and expertise for the Board to engage in values-based conversations that identify actionable priorities.
- Add capacity, process and expertise to scale the Board's capacity to engage in values-based governance and community engagement.
