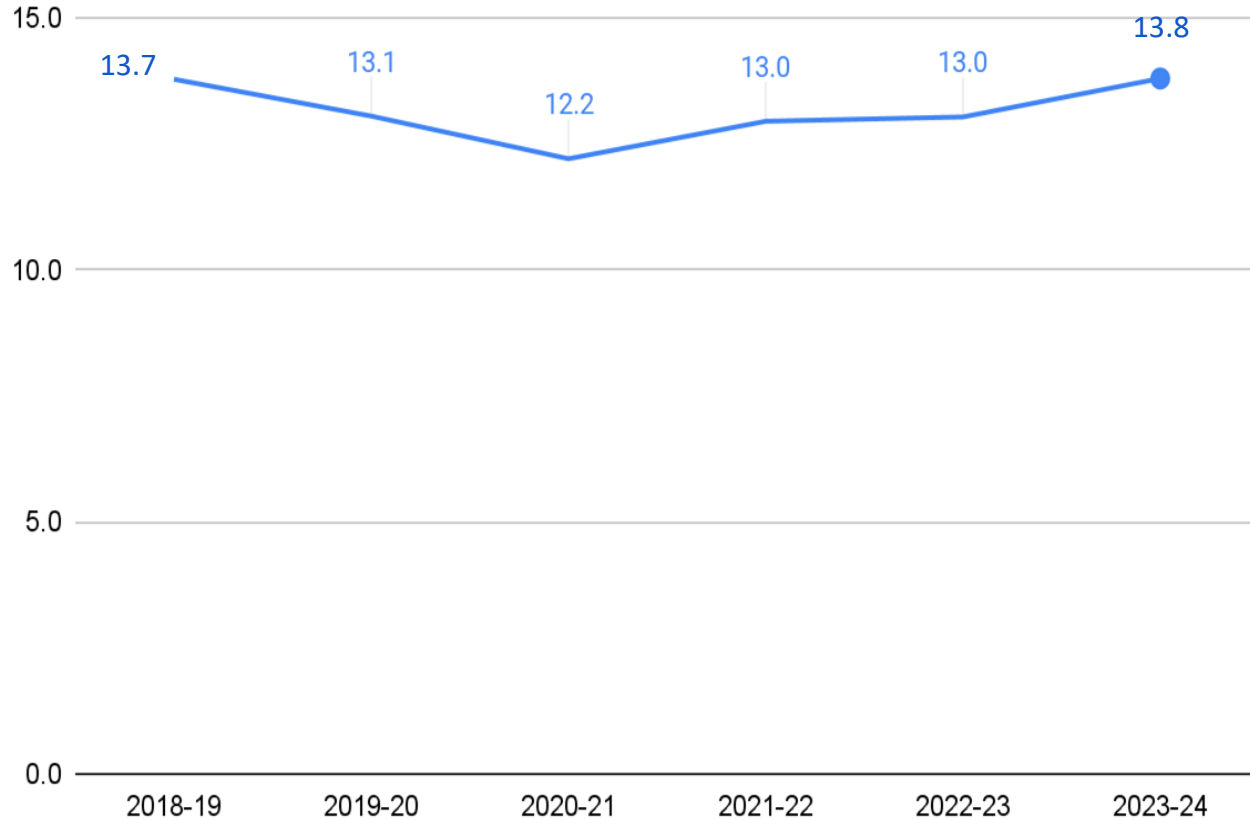

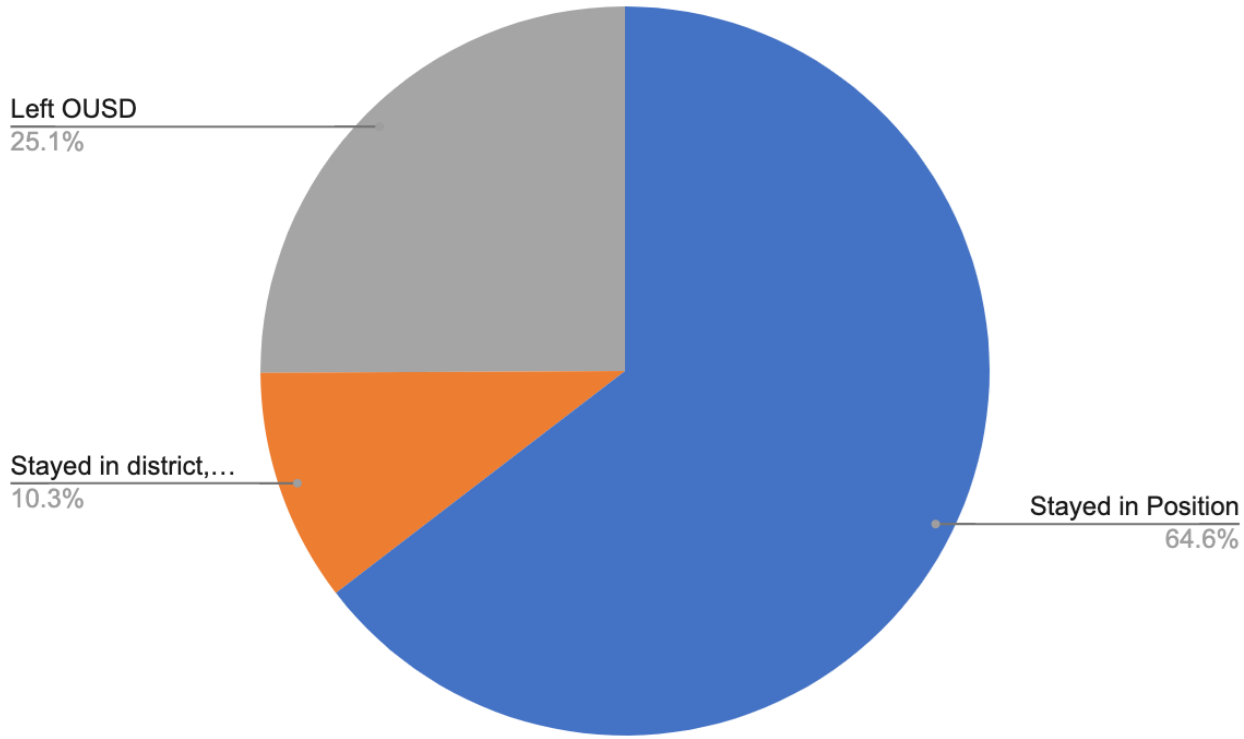

[in the graph: number of students with IEPs per 1 support staff]

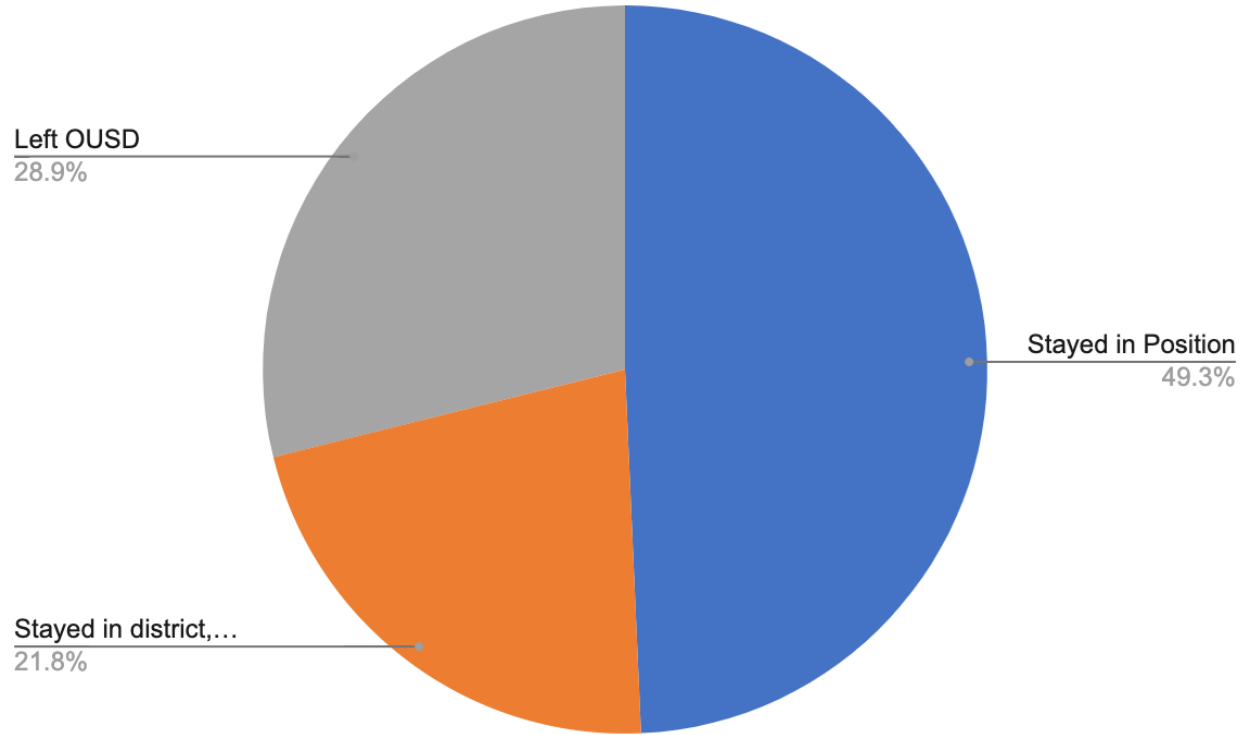


**More students per support staff in 2023-24 than in the previous five years**



## **Paraeducators: How Many Stay After Three Years (Fall 2023 Data)**

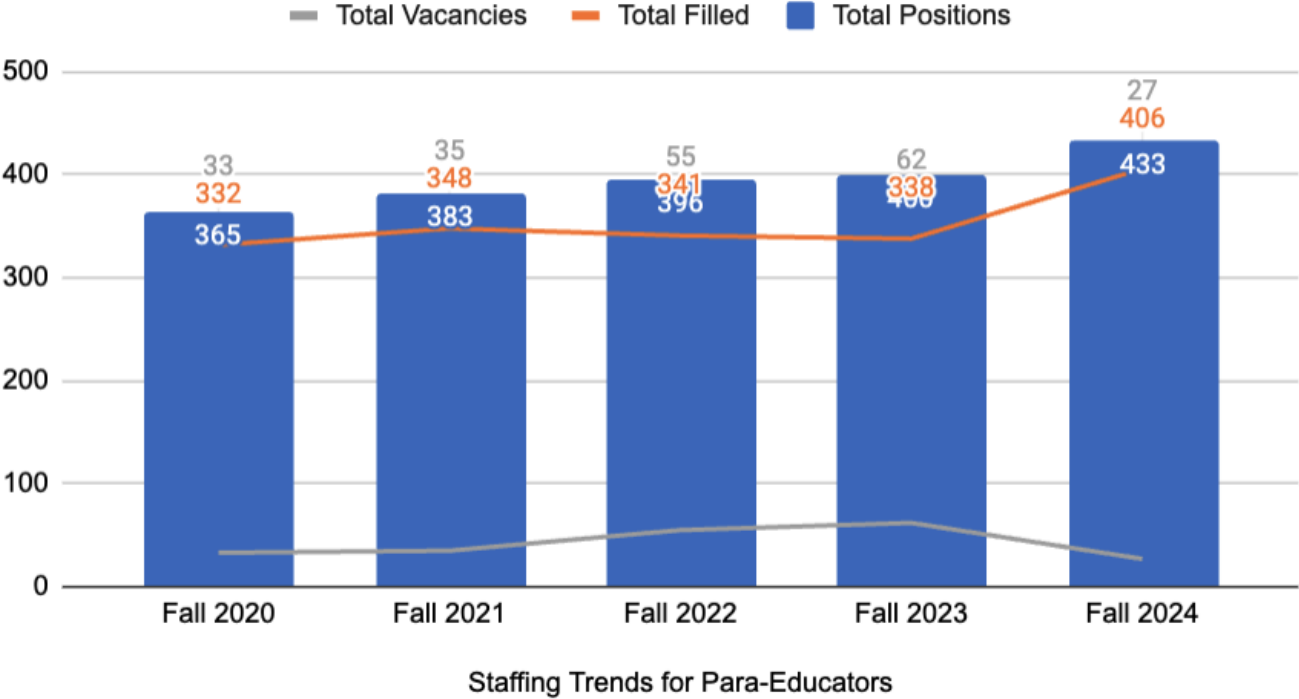

# 2020-2024 Staffing Trends for ParaEducators



**The hiring of paraeducators has improved this year as compared to the start of the 2023-24 school year, from 84.5% of paraeducator positions hired by Fall 2023 to 93.7% by Fall 2024.**

# Foster Youth Advisory Committee

**At our October 29 meeting we will** hear from staff about their response to our requests for:

- 1) an LCAP metric to show that OUSD is implementing the legal reporting requirements related to the suspension of foster youth**
- 2) Specific LCAP actions that would make sure foster students and their caregivers know about all diploma options (A-G diploma, reduced credit diploma, alternative diploma) and have access to those options**
- 3) A clear funding allocation for non-labor investments to support foster students.** FYAC has identified a list of small but essential expenses that have not been accounted for.



**We will also hear from Special Education staff who conducted an IEP review of all suspended 8th-12th grade foster youth with IEPs.**

**They will also share about their plans for ongoing IEP reviews for foster youth with IEPs.**

**Thanks the secondary Special Education team for collaborating with us to reduce the suspensions of disabled foster students!**
