What is the School Site Council (SSC)? | ¿Qué es el Concilio Escolar (SSC)?

A School Site Council (SSC) is the representative body tasked with developing, monitoring, and approving the school's strategic site plan (SPSA) and all related categorical expenditures. The SSC is the key deliberative body for the allocation of Title I funds and other resources to improve academic outcomes for all students and as such should be representative of the school community.

Un Concilio Escolar (SSC), es el cuerpo o equipo que se encarga de desarrollar, vigilar y aprobar el plan estratégico para el éxito de los estudiantes (*SPSA, por sus siglas en inglés*), y todos los gastos categóricos relacionados. El SSC es el equipo clave que va deliberar en la asignación de los fondos del Título I y otros recursos para mejorar los resultados académicos de todos los estudiantes y, como tal, debe ser representativo de la comunidad escolar.

- SSCs must have equal numbers of school staff and parent/community/student members.
- Principals are de facto members of the SSC.
- Classroom teachers (teacher of record in AERIES) must comprise a majority of school representatives, *except for small schools granted permission for a smaller SSC.*
- The minimum SSC size is 10 members, *except for small schools granted permission for a smaller SSC.*
- Student members are required for high schools and optional for middle schools.

- SSCs deben tener un número equitativo de personal escolar y padres/miembros de la comunidad/estudiantes.
- Es un hecho que los directores son miembros del SSC.
