**Background** 

In order to maintain a consistent compensation structure District-wide as well as acknowledge the work and commitment of all employees of the District, including employees who are confidential or confidential employees with employment contracts, the Superintendent recommends that the Board approve the same ongoing salary increase provided to represented employees and other compensation as described below.
