This Memorandum of Understanding ("MOU") between the Oakland Unified School District ("District" or "OUSD") and the Oakland Education Association ("Association" or "OEA"), collectively referred to as "the Parties," regarding the implementation and payment of the audiometrist stipend, pursuant to Collective Bargaining Agreements.

1. Background

Section 24.5.1.2 ("Stipends") of the Collective Bargaining Agreement states: Positions in this category are Teachers on Special Assignment, Senior High School Department Heads, including Librarians and Head Counselors, Head Teachers, Audiometrists, ROTC instructors, and yearbook supervision.
