The initial budget plan for the Irvine funds filed in spring 2015 was to fund a .6 FTE Linked Learning Coach at McClymonds High School for the 15-16 school year. In September 2015 the direction of McClymonds changed and a Linked Learning coach was not needed. During this time Preston Thomas became the leader of the newly created OUSD Linked Learning Office for High School Improvement. He contracted with Safir Consulting to assist with the facilitation of the systems change required as the Linked Learning Office grew substantially and merged with the OUSD High School Office. The now merged Linked Learning Office for High School Improvement was long wished for structural change in OUSD. Safir Consulting is a key player in co-planning and co-facilitation of transforming two bodies of work into one. The focus on supporting sites, pathways, and teachers to design linked learning, college, community, career success for all students is significant. The cost for the contract with Safir Consulting is \$30,000.

- 1. Access to Records. ConnectEd will have access to documents and other materials ("records") that may be defined as "pupil records" pursuant to the Family Educational Rights and Privacy Act of 1974 ("FERPA;" 20 U.S.C. §1232g, 34 CFR part 99) and the California Education Code provisions governing the privacy of pupil records (sections 49060 et seq.) ("applicable laws"). The applicable laws give parents/guardians certain rights with respect to their child(ren)'s educational records. These rights transfer to the student when s/he reaches the age of 18 or attends a school beyond the high school level.
- 2. Parent/Student Authorization. Oakland Unified School District hereby warrants that it will obtain necessary parent/guardian (and/or, as applicable, student) authorization, pursuant to applicable law, permitting ConnectEd to obtain, access, disseminate to necessary parties, store, and utilize for authorized purposes, the records of students participating in ConnectEd's on-line services pursuant to this Agreement. Oakland Unified School District shall obtain written authorization from the parent/guardian (and, as applicable, student) of each student participating in ConnectEd's on-line services for the purposes listed above. Oakland Unified School District shall maintain said authorizations in the cumulative records of each student participating in ConnectEd's on-line services and shall make such authorizations available to ConnectEd in a timely manner upon request by Connect-Ed. It shall be Oakland Unified School District's sole responsibility to comply with applicable legal requirements in regards to obtaining parent/guardian (and, if applicable, student) authorization for the possession, dissemination, storage and utilization of said records by ConnectEd pursuant to the terms of this Agreement. Within said authorization form it will be made clear that exemplary projects may be displayed on public-accessible pages to demonstrate certain student work, and in such cases, only first names and last

ConnectEd may disclose information from student records without limitation if the information or records are deidentified, which requires the removal of all personally identifiable information of the student(s) whose records are disclosed.

4. Hold Harmless. Oakland Unified School District shall fully defend, indemnify, and hold harmless ConnectEd from any and all claims, lawsuits, demands, causes of action, liability, loss, damage, and/or injury, of any kind whatsoever (including without limitation all claims for monetary loss, property damage, equitable relief, personal injury and/or wrongful death), whether brought by an individual or other entity, or imposed by a court of law or by administrative action of any federal, state or local governmental body or agency, arising out of, in any way whatsoever, any acts, omissions, negligence, or willful misconduct on the part of ConnectEd, its officers, owners, personnel, employees, agents, contractors, invitees, or volunteers, in connection with obtaining, accessing, disseminating, storing, and utilizing for authorized purposes the records of students participating in ConnectEd's on-line services pursuant to this Agreement. This indemnification applies to and includes, without limitation, the payment of all penalties, fines, judgments, awards, decrees, attorneys' fees, and related costs or expenses, and any reimbursements to Oakland Unified School District for all legal fees, expenses, and costs incurred by it.

In the event that ConnectEd is served with, or otherwise becomes aware of, a claim that, pursuant to the terms of this Agreement, Oakland Unified School District shall be responsible for defending and indemnifying ConnectEd against, ConnectEd shall provide Oakland Unified School District reasonably timely written notice of same, and thereafter Oakland Unified School District shall at its own expense defend, hold harmless and/or indemnify ConnectEd against said claim or any loss or liability thereunder as set forth herein. In the further event Oakland Unified School District shall fail to so defend and/or indemnify and hold harmless ConnectEd, then in such instance ConnectEd shall have full rights to defend, pay or settle said claim on its behalf without further notice to Oakland Unified School Dis-

trict, and with full rights to recourse against Oakland Unified School District for all fees, costs, expenses and payments made or agreed to be paid to discharge said claim.

Upon default, Oakland Unified School District agrees to pay all reasonable attorneys' fees necessary to enforce this Agreement. This Agreement shall be unlimited as to amount or duration.
