## **BACKGROUND**

The District Intern Certificate Program was enacted in 1983 under a major education reform law. This statute created an alternative route into teaching through District developed and administered teaching internships. The District, in collaboration with Fortune School of Education (Fortune), formerly know as Project Pipeline, allows individuals to provide instructional services while completing course work and the requirements towards the Clear teaching credential. District Internship program credentials must be approved by the school District's Governing Board in order to participate in this collaboration. Upon completion of all requirements under California Education Code 44328, the Commission awards the Preliminary Credentials to interns upon the recommendation from the school District's Governing Board.
